NARRATIVE

On the listed date and time Deputy John Tarpley conducted a traffic stop on a 2014 Chevrolet Impala white in color bearing Georgia tag of YAT-306. During the traffic stop it was found that Darius Rivera was driving. At the time of the stop, Harvey, Ladeeje, a passenger in the vehicle got out of the vehicle and fled. At that time Deputy Dontavius Jones chased Harvey and there was a struggle at which time Harvey broke away and pulled a firearm firing at least one shot that struck Deputy John Tarpley on the right side (Shoulder) under his arm.

After a short search the offender (Harvey) was located on Margaret Court and arrested. Deputy Tarpley was treated and released for a gunshot wound at Augusta University Medical Center.

This case was turned over to the Georgia Bureau of Investigation.
