Mr. Blume, Thank you for your request.

The estimated cost for the review and redaction of the records is 20 hours x \$32.63/hour (1st 15 min. free) for a total of \$652.60. In accordance with O.C.G.A. §50-18-71(d), we require pre-payment when the estimated costs for production of the records exceeds \$500.00 and will defer production until payment is received. Please keep in mind that I have 14 requests ahead of yours and estimate it will take me 60 days to review/redact the material.

Because a large portion of the estimate is attributed to audio/video redactions (<u>18</u> hours), I wanted to make you aware that we have audio/video files containing interviews with Acosta, Wilson, Cannon and Cratic as well as a few short interviews with EMTs. There appear to be triplicate files of each interview for Acosta, Wilson, Cannon and Cratic.

- One file contains audio and video.
- One file contains only audio from a separate recording device in the room.
- One file contains only video with no sound from what seems to be a camera located on the wall of the interrogation room.
