Good Morning,

Keep in mind this release is the records we have provided are only the ones I had readily available last week that required very little redaction, if any, that I could quickly download and release and would not generate a charge. That is the only IA I had at the time due to it being recent. I have an email into our Professional Standards unit, as I always do, to do a final check of their records to see if they have any additional ones as not all of their stuff is uploaded yet. The estimated response time on the rest of the records remains the same as the initial estimate you agreed to.

The exemption you reference is for the list of employees name, rank and pay. Those are the undercover officer names that are exempt from release under OCGA 50-18-72(a)(3). Those names will not be released as they are active undercover on active cases where their safety and security is at risk. I have highlighted the part of the statute that protects these undercovers. That part of your request below is denied. Feel free to file a formal complaint with my supervisor Capt. West at SWest@alpharetta.ga.us if you feel I have violated policy or the law.

I have been doing this a very long time. My response is not tailored to anything except your request. As I explained to you last week, the vast majority of your request is Furr's employee file. We will let you know when that is available and provide the final invoice at that time.
