In fulfilling record requests made by the public, the records unit must contact the appropriate unit(s) to obtain copies of the records.

Upon communication with the appropriate unit(s), it may be the case that the records are either more or less voluminous than initially anticipated. It may also be the case that, due to the complexity of the records requested, the cost of the time for the individual that is needed to compile the records is different than initially anticipated. Finally, it may be the case that, as required by the Georgia Open Records Act and other relevant state and federal law, the records may require more or less redaction than initially anticipated.

Any of these occurrences may result in either an upward or downward adjustment of the total cost of the records from the initial estimate provided above.

The cost of records are fixed by Georgia Open Records Act, and for that reason the records unit cannot deviate from that cost, even if any of the occurrences described above result in a final cost that is higher than the estimate provided above.
