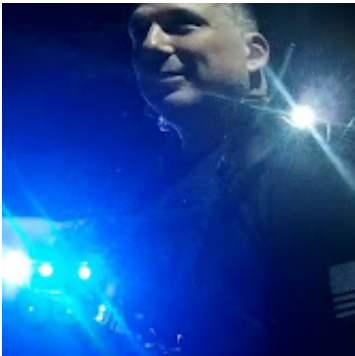
I need the identity of the officer in the attached image.
