The Richmond County Sheriff's Public Information Office has received your Open Records Request for the following information:

2. **List of all use of excessive force, by date and time, location and offense by Richard Russell during his entire employment with RCSO.**

For #1, our office is unable to release any body-worn video footage or dash camera video as

these items were turned over to the Georgia Bureau of Investigations (GBI) regarding a pending prosecution of a defendant {O.C.G.A. 50-18-72(a)(4)}. Our office does not generate case docket numbers, these are generated in the courts {O.C.G.A. 50-18-71(j)}.

For #2, we do not to generate lists that do not currently exist in our system {O.C.G.A. 50-18-71(j)}.
