Richmond County Sheriffs Office LT Kimberly Lee responded;

I have reviewed your request and this office is unable to provide the requested records regarding that case at this time because it is a part of the investigative file. This case is open/pending in Richmond County Superior Court {O.C.G.A. 50-18-72(a)(4)}."

Which Alphonso Forrest case are you referring to when you state you are unable to complete my request? And can you specify each exemption and why you feel these exemptions are lawful please
Alphonso Forrest has a lot of cases that either are open or closed depending on what agency you ask. The Richmond County Sheriffs Office is the onl agency that has issues with these requests, why is that? Nobody else has had a problem following the open records act, Snellville PD and the Georgia POST council.

You have a suspect in custody on the Felycya Harris case, Jerrome Miller, and you have excluded Alphonso Forrest, so how can you make exemptions when Snellville PD and Steve Goodyear of the Georgia P.O.S.T council stated in an interview video of Alphonso Forrest that he was not under investigation nor a person of interest in the HATE CRIME murder of Felycya Harris. Or is Alphonso actually being implicated? He worked the zone Felycya was murdered in, I am sure it is him in one of her twitter videos too. Was she extorting Forrest and did he kill her for it? Are you actively covering up a murder? Why did Snellville investigate Alphonso and you did not? He committed a sex crime and was found guilty as a juvenile and yet he did not disclose that on his application, I put it in the video. You did not verify. Did anyone ever tell anyone at the sheiffs department of this crime at any time during the employment of Alphonso Forrest? Did anyone send a Mandatory reporter letter earlier on? Was there ever any knowledge by anyone at the Richmond County sheriffs office that Alphonso Forrest had been convicted of a crime prior to employment at the Richmond County Sheriffs Office?

Felycya harris was murdered 18 months ago. What exactly are you investigating again??

Surely you are not making exemptions on the entire request? Even the child abuse case? There are 2 cases brought against Forrest, one was child molestation. I am getting open records from DFCS o that.

Even on the body cam of the days not related to the 3rd? You are making all of the dash cam and body cam exempt, for 2 days not related to any crime?

Even Alphonso Forrests schedule for that week? Is that is part of your investigation? Again, Steve said Alphonso was cleared by your agency.

Your agency is way more corrupt than I imagined. I didn't start out thinking that but now you have proved it. Many time, in many emails and the Attorney General is protecting your agency, how nice

I requested interviews of any investigation regarding Alphonso Forrest. NOT just the cases mentioned. How about the investigations Terry Gore completed? When he went to the home to do welfare checks, that is a part of a current investigation? The Child Molestation allegations for his daughter? How about the cousin, you know he lied in the interview? He told Snellville PD the cousin was 11, he then told Steve Goodyear she was 6.. are you guys really investigating anything at all?

You guys at the sheriff's office hate being exposed don't you? I have proven a lot of dishonesty on your agency's behalf in my videos and on my community tab of my YouTube channel.

And it seems from your emails you are not only proud and firm about your violations of the open records laws but you are very bold playing games with your career. I have no problem ending that career!
