I am requesting the data fields from all available non exempt body cam for Officer Christopher Brown, I am not asking the agency to create a list, I am requesting the data fields from the agencies listing of body cam and all data displayed for the officer for all body cam that is available and not exempt. I am not concerned with the type of system or compatibility your agency uses, a simple print out or screenshot of the screen that displays Officer Christopher Browns body cam listing of all body cam available for copying.

I am also requesting a simple print out of the first screen of Christopher Browns body cam. Just a simple print out.

§ 50-18-71 (b) (1) (f) Agencies shall produce electronic copies of or, if the requester prefers, printouts of electronic records or data from data base fields that the agency maintains using the computer programs that the agency has in its possession.

This subsection emphasizes that government agencies must ensure that their use of electronic record-keeping systems does not undermine the public's right to access records. When requested, agencies are obligated to provide electronic copies of records or, if preferred by the requester, printouts of electronic records or data from specific fields in their databases.

Can't wait to see how you defeat this request.
