Thank You for your email, the Public Information Office is in receipt of your request. Please consider this as an official (3) day response notification, I should be able to provide you with a response to your request before the end of business April 13, 2023. If it appears that it will take longer, I will notify you. If there is a cost associated with your request, I will notify you of that cost before I proceed. Pursuant to O.C.G.A. § 50-18-71(c) and (d), the Richmond County Sheriff's Office is authorized to charge for the costs of producing documents requested. The cost of producing the same is .10¢ per page and \$5 per disc, as well as a charge for the "direct administrative costs for complying with a request under this code section." This means you will be charged the hourly salary of the lowest paid full-time employee who has the necessary skill and training to perform the request, which is \$17.00 per hour. However, you will not be charged for the first fifteen (15) minutes spent on your request.
