All arrest the officer has made during his employment with Wrens PD. I know systems are different from agency to agency. I am attaching an example from the Richmond County Sheriffs office. Without knowing what your data fields look like I have no knowledge of how your agency creates such reports for internal use and therefore the record may be labeled or produced in a proprietary fashion but not proprietary for public release.

Please feel free to reach out if there are any additional questions, this is the most common question with the open records act I often get.

§ 50-18-71. Right of access; timing; fees; denial of requests; impact of electronic records

(f) As provided in this subsection, an agency's use of electronic record-keeping systems must not erode the public's right of access to records under this article. Agencies shall produce electronic copies of or, if the requester prefers, printouts of

"electronic records or data from data base fields that the agency maintains using the computer programs that the agency has in its possession."
