I hope this letter finds you well. I am writing to address the matter of my previous request made under the Open Records Act (ORA) and to bring to your attention the potential violation of the statutory provisions regarding the response timeframe as outlined in 50-18-71. Right of access; timing; fees; denial of requests; impact of electronic

records (a) (b) (1) (A) Agencies shall produce for inspection all records responsive to a request within a reasonable amount of time not to exceed three business days of receipt of a request

As of the date of this letter, it has been 5 weeks since I initially submitted my request for available records on May 11, 2023, at 11:08 am. According to the ORA, your agency is required to provide the requested records within a timeframe of 72 hours. Regrettably, this legal obligation has not been fulfilled, raising concerns regarding compliance with the statutory requirements.

I would like to draw your attention to Section 50-18-74 of the ORA, which explicitly stipulates the consequences for those who fail to comply with the law. Given the seriousness of this matter, I am compelled to report these violations to the appropriate authorities, namely the Attorney General's office. I believe it is in the best interest of all parties involved to rectify this situation promptly.

To facilitate the resolution of this matter, I kindly request that you expedite the processing of my request and provide the requested records as soon as possible. Furthermore, I am requesting the waiver of any associated fees due to the egregious violations of the ORA. It is my belief that these circumstances warrant the waiving of fees, given the undue delay and the importance of upholding the principles of transparency and accountability.

I would appreciate your prompt attention to this matter. Please confirm receipt of this letter within five business days and provide an estimated timeframe for the fulfillment of my request. Should you have any questions or require additional information, please do not hesitate to contact me via the information provided above.

Thank you for your cooperation and attention to this serious issue. I trust that you will take the necessary steps to rectify the situation promptly and ensure future compliance with the statutory provisions of the ORA.
