Subject: Formal Notice of Non-Compliance with State Open Records Act

Dear Sir/Madam,

I am writing to formally bring to your attention a series of instances where your esteemed agency, reputed as one of the leading law agencies in the state, appears to be in non-compliance with the state's Open Records Act.

The Open Records Act is not a set of optional guidelines, but rather, a collection of binding laws that mandate specific actions and timelines. For instance, Section 50-18-71 clearly stipulates a three-day period for fulfilling a request, which is not equivalent to a 72-hour window. This is a crucial distinction that seems to have been overlooked or ignored by your agency on multiple occasions.

Regrettably, I have identified seven instances where your agency has failed to adhere to these laws. This pattern of non-compliance is deeply concerning, particularly given your agency's role in upholding the law.

Below is a list of instances where your agency has failed to comply with the Open Records Act:

- 1. March 22, 2023 Request by Vernon Cratic IGNORED
- 2. May 3, 2023 Request by Alphonso Forrest (No responsive records)
- 3. May 18, 2023 Request by Brianna Grier Eventually filled 2 month delay
- 4. May 26, 2023 Request by Brianna Grier (Request fulfilled after nearly two months)
- 5. June 14, 2023 Request by Matthew Morin IGNIORED
- 6. June 15, 2023 Requests by Quincy Cannon, Andrew Acosta, and Robert Wilson IGNORED
- 7. June 20, 2023 Third request by Brianna Grier
- 8. July 07, 2023 Request by Keven Guerrier (No response) IGNORED
- 9. July 09, 2023 Request by Mercer (No response) IGNORED
- 10. July 12, 2023 Request by Jermaine Jones (No response) IGNORED

These are just a few instances. I will let you explain the rest to a judge.

I urge your agency to address these instances of non-compliance promptly and ensure adherence to the Open Records Act moving forward.
