On 04/24/2019, I was dispatched to 1406 Pine Tree Trl in reference to a fight call. Upon arrival Mr. Darren Ragland did attempt to elude Law enforcement Officers by running inside the residence upon seeing Police Officers. Mr. Ragland did intentionally ignore verbal commands to stop moving. Mr. Ragland did lock himself inside an upstairs bathroom and refuse to exit. It was explained to Mr. Ragland through the bathroom door that Officers were dispatched to the scene due the a fight call. Upon further investigation there was no evidence of any fight having taken place. After approximatley ten to fifteen mintutes Mr. Ragland exited the bathroom under his own free will and was detained without incident. After conducting a GCIC search it was later determined Mr. Ragland had an active probation warrant out of the Fulton County Sheriff's Office. Mr. Ragland was charged with Obstruction and transported East Point Jail without incident.
