#### Investigative Summary

On September 16, 2009, the Special Investigations Division was notified by Major Mark McDonough of a missing weapon reported by Trooper Chattam Smith #926, Post 48, Atlanta. Smith's supervisors, SFC Jerome Bowman and Sgt. Robert Moody, Post #48, Atlanta, were suspect of Smith's report and advised Major McDonough through the Troop C Chain of Command. SID Director Angie Holt advised Lt. Jenny Williams to investigate the matter. The case was assigned #IA-0094-2009.

On September 16, 2009, Lt. Williams contacted SFC Bowman. Bowman gave Williams a synopsis of the events that had taken place earlier that morning when Smith reported the loss of his weapon during a foot pursuit:

Bowman stated at 0616 hours, Smith notified Moody via telephone that when he got home from his 2200 – 0600 hours shift, he noticed his back up weapon, Glock 39, was missing from his ankle holster. Smith stated he had gotten into a foot chase and he was certain that was when he lost the weapon. Moody instructed Smith to return to the scene of the incident, I -20 EB ramp to MLK Drive, to search for the weapon. Smith met Moody and they searched for the weapon. When the weapon could not be found, Moody instructed Smith to return to Post

to Post 48 and write a letter of explanation to Major McDonough and to complete a Lost or Stolen Property Report. Smith's statement read he stopped a vehicle at I-20 for speeding and as he approached the vehicle, it sped away. Smith stated the vehicle traveled a short distance to the Eastbound Exit ramp at MLK Drive where the driver stopped in the middle of the ramp and the driver and the passenger fled in opposite directions on foot. Smith stated he gave chase to the passenger up a grassy embankment, and then he observed a female passenger in the vehicle. Smith stated he returned to the vehicle and spoke with the female and learned the male passenger that fled was wanted by Douglas County. Smith released the vehicle to the passenger after determining the vehicle belonged to her mother and that she possessed a valid driver's license. Smith stated when he got home his weapon was missing from his ankle holster.

When Bowman arrived at Post 48 at approximately 0815 hours, he questioned Smith and he accompanied Smith and Moody (now daylight) back to the scene to search a second time for the weapon. Bowman stated he was suspect of Smith's explanation because the event occurred at 1130 hours and Smith stated he didn't notice the weapon was missing until he got home at 0600 hours. Smith told Bowman he knew the weapon was on his ankle earlier in the evening because he recalled scratching his leg and feeling the gun. Bowman agreed to bring Smith's

in car video tape and a copy of Smith's explanation letter to the SID office the following day.

On September 17, 2009, SFC Bowman met with Lt. Williams at the SID Office. Bowman furnished Smith's original video tape and a copy of Smith's letter to Major McDonough. Bowman stated the visual portion of the tape was blank, but the audio had captured Smith's vehicle stops. Bowman stated he was even more suspect after listening to the tape because it did not support Smith's claim that he gave chase to the passenger. Bowman added that during a post inspection on August 10, 2009, Smith did not have his weapon and that was noted on the inspection report.

On September 23, 2009, Trooper Smith was interviewed at the SID office at Headquarters. Smith read and signed a Garrity Warning prior to the interview. Smith reiterated his story of losing his weapon during a foot chase on September 15, 2009. Smith stated he recalled having it on prior to the chase when he reached down and scratched his leg and felt the weapon. After approximately 45 minutes of questioning, Smith recanted and admitted that he discovered his weapon missing sometime around the first of September, after the Labor Day Holiday period (Exhibit #2a, p. 99). Smith stated the weapon was not lost during the post inspection on August 10<sup>th</sup>; rather, he had cleaned it for inspection and left it at his residence. (p.42 - 44) Smith stated he most likely lost it while on patrol and to that cause, he had been diligently searching for the

weapon at all the locations he operates Laser, at the jails, and at all locations he could recall visiting. Smith admitted he used the incident on September 15<sup>th</sup> to report the weapon missing. Smith stated he felt like he had "screwed up" for a second time and he did not want to disappoint SFC Bowman or Sgt. Moody. Smith rewrote his letter of explanation and his Lost or Stolen Property report before leaving the SID office.

Smith was interviewed for a second time on October 1, 2009. Smith gave a written statement and Smith narrowed down the date he lost the weapon to on or after September 8, 2009. (Exhibit #2b)

Allegation: Violation of DPS Code of Conduct Policy #3.01.A.9, which reads:

Members are required to be truthful to their supervisors and to all superior Officers.

**Sustained:** This investigation established Trooper Chattam Smith was untruthful to both Sergeant Moody and to Sergeant First Class Bowman when he advised them he lost his weapon during a foot chase on September 15, 2009.

Allegation: Violation of DPS Code of Conduct Policy #3.01.G.10 which reads:

Members will submit all necessary reports on time in accordance with established procedures. Reports submitted by members will be <u>truthful and</u>

complete, and no member will knowingly make false statements, charges or allegations in connection with any citations, warnings, assistance rendered, traffic crash reports, field reports, investigative reports, computer entries or by any other means which creates an official record of the Department.

Sustained: Trooper Smith submitted a DPS Form 494 (Lost, Destroyed, Damaged, or Stolen Property Report) and an Official Memorandum to Major McDonough, both of which contained false statements relating to the loss of his weapon.

#### **Additional Findings:**

It was of concern during the initial portion of this inquiry that Tpr. Smith had lost his weapon prior to the August 9, 2009, post inspection and had reported his weapon missing knowing he was due for inspection in October 2009. Nonetheless, it was established that on August 9, 2009, Smith was residing in Powder Springs, Georgia, and Smith moved to College Park, Georgia, on August 15, 2009, with girlfriend CSA Leona Frieson. In both interviews and in his written statement, Smith stated he'd cleaned his backup weapon for inspection and had left it beside his bed in Powder Springs when he went to work. Smith also stated that he recalled sitting in the parking lot of his apartment when he first noticed his weapon missing. Smith's belief that he lost the weapon while on duty seems to be validated by the list of locations he searched, and by the fact that an independent witness, Trooper Sellers, witnessed the fact that the weapon fell out of Smith's ankle holster on a prior occasion.

It should also be noted that Smith was not the only trooper that did not produce his backup

weapon during that August 9th inspection and neither were disciplined or required to retrieve the

weapon during the inspection. (See Exhibit #7)

Concerning the in car video tape, verification of repair was located, and the Garage

Communication staff reported it would be virtually impossible to erase only the visual portion of

the tape and leave the audio portion intact. Concluding, there is no evidence Smith tampered

with the visual portion of Video Tape #926-043-2009.

Lt. Williams:

Okay from your where you live now?

Okay. Ah, before we get started you know what I want to do is go over the whole patrol shift and everything with you. Is there anything that you have on your mind that you want to add to or say before we get started?

Tpr. Smith:

Hm — not really, ah, basically put, ah, just like I told Sergeant, Sgt. Bowman, a lot of people know where I patrol at as far as — especially in this particular situation. Ah, there is a bush that I sit behind on I-20 east. Ah, and that's where I was sitting at when I checked this vehicle speeding. Ah, usually I'm standing outside my patrol car because, ah, I don't know if it's the county or the city that is in charge of to make sure that bush stays cut or what not, but it has grown up to the point where I can't sit in my vehicle and just turn sideways and use my laser. So now I must I actually have to stand up. I may have my right foot in the car, left foot down and, ah, using my laser that way. And, ah, that's what I was doing that night. And, ah, checked the vehicle, I pursued the vehicle, got behind it, turned on my lights. Pulled over on the shoulder, ah, like I told Sgt.

Bowman 300 - 400 meters before the exit to Martin Luther King. So I get up, put my flashlight through the rear windshield and, ah, noticed the driver hand. I think he was looking at his rearview at me, and the next thing you know you just see his hand come down and throw it back in gear. So I run back to my patrol car and, ah, seemed like for some reason my car is real real slow on takeoff and I just saw them was just pulling away from me you know just trying to catch up and, ah, I saw them get off on Martin Luther King and that's when I got up to them and all I saw was this one go this way, one go that way. So I jump out and go after the guy that went that way. And as I get up the hill this young girl is saying oh my God. That's when I saw her, I went to her. Ah, that's when she gave me all their information. And, ah, I don't know if it was adrenaline or what, caught up in the moment, ah, I didn't think about my backup weapon at the time. Ah, I didn't think about it after the fact because I stayed in that area searching for the guys. I had APD searching. And, ah, one APD officer on that shift actually came to me and told me hey man I saw that guy, ah, riding a bicycle. You say he had on red and black shoes? I was like yeah. He was like yeah I just saw him riding a bicycle right down the street from where you said you, ah, he jumped out at. So I continued to search that area and look for the guy but I never came across him again. But, ah, then I went home. And, ah, I got in my car and well I was getting

out of my car rather and I I always undo the top part. When I took the top

part loose and it just felt kinda light. Then I looked down and I looked at

my ankle and I was like --- I just leaned back and said oh no. That's when

I called Sgt. Moody and told him about the situation. He just told me he

said look here brother I'm not gonna tell you what to do as far as, ah,

coming back out here to try to find your weapon, but it's gonna be up to

you I'm gonna go out there looking. But I said I got to find because as I

know I'm still on probation because of until I reach TFC status. And, ah,

I'm not trying to put anything on my record whatsoever against me. So

that was just the situation. I went out there looking and looking and

looking, pushed down bushes; I got out there pulling up weeds and still

came up with nothing. That's when I went back to the post and did all of

my reports.

Lt. Williams:

Okay what time did time did your shift start that night?

Tpr. Smith:

It started at 10 p.m.; it was 10 to 6 midnight shift.

Lt. Williams:

Okay and that stop was at 11:40 something, 11:30 something?

Tpr. Smith:

I think, ah, I'm not positive I think it was Sgt. William after reviewing it it told me 11:30 something, 11:33 -11:35 somewhere around there.

Lt. Williams:

Okay so what had you done before that?

Tpr. Smith:

Ah, actually I came out, ah, came up 285. I usually on my midnight shift when it starts it's a high crime area on that side so I usually look for stolen cars that's sitting on the side of the road. Because they usually just throw stolen cars out and just leave them abandoned and leave the tag on them, I run the tags So basically it turns in --- for the the first hour – hour and a half it's a 10-46 type thing. Look for broke down cars what not. So that's what I did, just did a loop from I come in on 285, went up to Bolton Road, went back down to Washington. And after I done that loop then I sit there, at 20 east Holmes or 20 east at MLK, 20 west at MLK or 20 west right before 285 that little loop right there I patrol that area for a while.

Lt. Williams:

Did you go by the patrol post when you first went 10-8?

Tpr. Smith:

No ma'am.

Lt. Williams:

Okay did you go by 48?

Tpr. Smith:

No ma'am.

Lt. Williams:

Did you get out and look at any cars or stop anybody before that 11:30 something?

Tpr. Smith:

I looked at cars but, ah, not to the point, because at night I just run the tag, ah, on my MTU unit in the car. And, ah, if nothing comes back on it I just leave it alone.

Lt. Williams:

How long have you had that unit in your car where you can do that yourself?

Tpr. Smith:

Ah, we got them back I think it was March 12<sup>th</sup>. If I'm not mistaking March 12<sup>th</sup> was the, ah, when we got that unit.

Lt. Williams:

So you're pretty efficient at it by now.

Tpr. Smith:

Yes ma'am I luckily I have a computer science degree also so that kinda goes goes in with it so that kinda helps me out a little bit.

Lt. Williams:

I imagine it does. Ah, do you remember stopping any cars before that?

Tpr. Smith:

I want to say I did stop maybe two cars prior, two to three cars I'm not positive. But I did stop a car prior to this situation, but I don't know exactly how many -- I can't positively about.

Lt. Williams:

When you were out there with Sgt. Bowman and Sgt. Moody you didn't, ya'll didn't discuss that about where all had you been before this or anything like that?

Tpr. Smith:

Ah, they didn't ask me where I had been. Ah, they asked me where was I sitting at as far as when I checked the subject. They asked me where did he stop at, I advised that. And they also asked me where did he get out at as far as where he stopped the car.

Lt. Williams:

I'm talking about the car stops before this, they didn't you didn't review all that with them?

Tpr. Smith:

The car stops before this was – all we were concerned with was basically this situation.

Lt. Williams:

Ah, after this situation did you stop any cars?

Tpr. Smith:

I think I stopped maybe I want to say about two or three cars after that.

Ah, because I was more focused on seeing if I could find, ah, the two suspects that fled on foot. I kept roaming around that area.

Lt. Williams:

About how long did you stay in the area and look for the suspects?

Tpr. Smith:

Ah, after the initial situation I stayed probably about an hour, because APD was doing a road check right down the street. Ah, I guess that would be west of if you get off on the ramp to the right, ah, west on MLK right there, ah, before Holmes Drive. Ah, they were sitting there in a slight curve, they were doing a road check so I stopped them and they were asking me questions. I said, ah, I gave them a description of the two males and I, ah, just stayed down there with them for a while. But they said they wanted my assistance as far as somebody turning around on them because of their no chase policy. Ah, after that I rode up towards RDA, Ralph David Abernathy, did a little turn around just kept circling the area. Then went back to patrolling a little while. I did, I continuously stayed in that area but I leave the area at one point like to like to say well I'm gonna give

them some time to think it over and come out wherever they're hiding at and then I'll go back and see if I can find them. Don't look for that.

Lt. Williams:

Okay. Ah, --- so you finished your patrol up about what time?

Tpr. Smith:

Ah, I finished up probably about, as far as patrolling due to the fact that Sgt. Bowman does give us 30 minutes early to go home, ah, I probably left the area of my last patrol about 5:45, which from that area which is right there around 285 to down back to Clayton county, Riverdale Road, that gives me about 15 minutes. When I get home it's right there at 6 o'clock. So I'm not trying to clock out early or being late due to the fact that we're under the furloughs and anytime over you got to, ah, take it out on your next shift, so I try to get home pretty much right there on time. It's it 5:59, 5:58 then whatever I must do I do my mode forms as far as my activity, put in my ending mileage. If I need any gas receipts I do that for those two minutes or what not then after that I go ahead ---

Lt. Williams:

So going by the patrol post is just a thing of the past, you just sit in your car and do everything?

Tpr. Smith:

Ah, pretty much. Ah, the blotter is no more so, ah, we don't have to do the blotter anymore. The main thing you do if you go by the patrol post is, ah, you turn in your tickets. And, ah, I've gotten into a habit, which is a bad thing, I always turn in my tickets, ah say on the midnight shift I may turn in my tickets, ah, the next work day. But on my regular shift, ah, I'm pretty good about working in the mornings so. If I work 6 to 2 I get off at 2 o'clock. And I know if I'm working like 7 to 3 the next day I can just go turn my tickets in because of the fact that the secretary is gonna be there maybe 7:30 – 8 o'clock.

Lt. Williams:

What did you do that night?

Tpr. Smith:

That night on that's in question, ah, basically I was hoping to get some speeders, ah, checking speeds.

Lt. Williams:

Well their tickets did you go by the post and turn in the tickets?

Tpr. Smith:

No ma'am I didn't turn my tickets in that day.

Lt. Williams:

Did you, ah, take out warrants on the guys that had ran from you?

Tpr. Smith:

No ma'am, no ma'am I did not. Ah, really to be honest I really don't know too much about the whole warrant process. Ah, and with, ah, the gentleman that she gave me a Willie Baker subject, ah, I couldn't get anything as far as name. I got the name but I couldn't get a date of birth, I couldn't get a location on him. Ah, as far as the the guy that, ah, came back with the warrant, ah, I know his first name starts with a "J" and I can't think of the rest. Ah, --- Mr. Holcombe, ah, yes he had – they gave me all this information but they're saying he's out of Stone Mountain. But, ah, the lady that I spoke with told me that, ah, he was riding with her because his parents just kicked him out of their house.

Lt. Williams:

He's the passenger?

Tpr. Smith:

He was the passenger yes. And, ah, he was staying with his parents, his parents just kicked him out and she was trying to help out. And that's that's what she's saying.

Lt. Williams:

So the driver you couldn't get any information on.

Tpr. Smith:

No ma'am.

Did she, ah, did you have any more contact with the passenger after she

left the scene?

Tpr. Smith:

She said that she was going to call me; I gave her my business card to call.

But nothing.

from the police.

Everything came back valid on her.

Lt. Williams:

Okay did you get a phone number for her?

Tpr. Smith:

No ma'am because she said – because how she sounded, ah, she pretty made it pretty confident that she was gonna – Sir I'll do whatever I need to do because I can't believe they did this, blah, blah, blah. And she was making a scene but said she was really wanting them to be taken into custody because of how they left her in the back seat asleep and just ran

When you said you heard her and you turned back to the car where was she sitting?

Tpr. Smith:

She was coming out of the rear right of the car.

Lt. Williams:

Four door car?

Tpr. Smith:

Yes ma'am. She was coming out of the rear right door. And that's when I saw her. When I got to her she was already out the door, and then I got to her and I said don't even think about it. That's when she said oh you don't have to worry I'm not gonna do anything. That's when she got all panicky about oh my God, oh my God; I don't even know why they ran.

Lt. Williams:

Did you search the car?

Tpr. Smith:

No ma'am I didn't I, ah, due to the fact that it was her her grandmother's car. I apologize her mother's car. But, ah, and, ah, she had a valid license and I didn't feel that there was anything in the vehicle that could incriminate any of those subjects that ran. Ah, more or less I felt that the reason they ran was because of Mr. Holcombe's warrant out of Douglasville. But as far as Mr. Baker is concerned I'm not positive on it till this day why he ran.

Lt. Williams:

Okay so you you, ah, -- when did you turn in your video tape?

Tpr. Smith:

I, ah, told him also my weapon is not in my holster, my backup weapon is

not in my holster. And that's when he went on into saying that, ah, sir, ah,

I don't know how you feel about this but you got to make a decision on

whether or not you're gonna come back out here and try to find your

weapon or or you're gonna go in there and go to sleep and then come back

out here and try to look for it because we got to find that weapon because



#### **Interview Summary**

On October 1, 2009, Trooper Chattam Smith was interviewed in the SID office at DPS Headquarters by Lt. Jenny WILLIAMS. The following is a synopsis of that interview:

Smith was requested to write a statement answering the following questions:

- 1) Where was your gun during inspection on August 10, 2009.
- 2) When and where you were the first moment you noticed the weapon missing.
- 3) All the locations you searched.

After Smith submitted his written statement, Williams reviewed the statement and reviewed the information included in Smith's first interview and in Smiths written statement. Smith was asked to be more specific about question #2, when and where he was when he first noticed his weapon was missing. Smith stated he first noticed the weapon missing after a patrol like he stating in the beginning, but it was after a first shift patrol. Smith recalled he was sitting in the parking lot of his apartment building, and he started to take off his backup gun and saw that the snap on the holster was open and the gun was gone. Smith searched his vehicle and his apartment, upstairs and downstairs. The following day, on a first shift patrol, Smith went back to all the locations listed in his written statement to look for the weapon. Smith stated he searched everywhere he'd pulled over a car and everywhere he operated Laser.

Smith stated he knows he had the weapon during the September Labor Day Holiday period because he recalled on Sunday, September 6<sup>th</sup>, he was working a motorcycle round up and he thought a motorcyclists was going to run from him. Smith stated he exited the vehicle in a rush and his pant leg got hung over the weapon. Smith stated he was off on Monday, September 7<sup>th</sup>, so Smith concluded the weapon had been missing sometime between September 8<sup>th</sup> and September 15<sup>th</sup> when he made the false report.

Smith stated on September 15<sup>th</sup>, he took his video tape out of the recorder shortly after the female left the scene and secured it to be turned in per policy. Later in the shift, Smith stated he put the video back into the recorded and viewed the tape. That is when Smith realized the visual portion of the tape was not operational. Smith stated he did not do anything to the camera to make it malfunction. Smith admitted that knowing the tape did not record his movements during that "pursuit" influenced his decision to use that opportunity to report the weapon missing.

Smith was questioned about the discrepancies in his statements that he did not return to Post #48 on the 15<sup>th</sup> after the reported chase, but that the tape was turned in sometime that night. Smith stated he normally pulls a tape after a chase and puts it in his mailbox for the NCO on call. Smith stated it is policy for the NCO on call to be notified of all chases and the NCO's know to look in trooper's mail boxes for the tapes. Smith knows he stated he did not go back to the patrol post that night, but he can't recall how the tape was turned in. Smith knows he did not have it on

him when he went back to the scene to meet with Moody. (note: Moody stated Smith had turned

in the tape sometime during that midnight shift).

Smith admitted he did not chase any violators up the grassy embankment on the 15th. Smith

stated he ran to the curb, and then saw the female passenger in the car.

Smith stated he discontinued carrying his weapon with him when off duty after he learned it

raised too much suspension and attention towards him. Smith stated he felt like leaving his

weapons in his locked patrol car was a safe measure, more safe than in his personal vehicle.

Smith wrote in his statement that he left his weapon on a hat box beside his bed, at his residence

in Hiram, Georgia on August 10<sup>th</sup> during inspection. (See attached statement)

On September 15, 2009, I performed a traffic stop at I-20 East, just west of the ramp to Martin Luther King Jr. Drive, on a vehicle for speeding. As I approached the vehicle, I noticed that the driver placed the vehicle back in gear and sped off. I ran back to my patrol vehicle and pursued the suspect's vehicle. The vehicle exited off of I-20 East onto the ramp to Martin Luther King Jr Drive. Approximately halfway down the ramp, the driver and the front seat passenger exited the vehicle. The driver ran in an eastwardly direction towards Martin Luther King Jr. Drive, while the front seat passenger ran in a westwardly direction up a grassy hill towards Martin Luther King Jr. Drive. I attempted to pursue the front seat passenger, but once I made it approximately ten to fifteen feet up the hill, I noticed a third subject that was still in the vehicle. I approached the subject and told her not to move. She advised me that she did not understand what was happening. She advised that she was asleep in the backseat of the car and was unfamiliar with the reason why the two men bailed from the car. I asked her for the names of the two men, and she advised that their names were Joseph Riley Holcomb and Willie Baker. She stated that Mr. Baker was the driver of the vehicle. I asked her if she knew if either subject had a warrant for their arrest. She stated that Mr. Holcomb had a warrant out of Douglasville Police Department. At this point, I asked for her driver's license. She displayed a Georgia driver's license, which identified her as Ms. Bridget Ann Sheehan. I checked her driver's license through GCIC/NCIC to make sure that they were valid. She had a valid license, and I released the vehicle to her. I completed the rest of my shift and went home. At my residence, I removed my ankle holster. I noticed that my back-up weapon (Glock Model 39 Serial GSP1036B) was not in my holster. I immediately called Sgt. Moody and advised him of the situation. Sgt. Moody and myself returned to the scene of where the subjects bailed to look for my weapon. We both were unsuccessful in finding my weapon after a thorough search of the area where I entered the grassy hill.

On my next patrol, I checked every area that I had patrolled the previous day. All my searching was to no avail. I continued to search for my weapon every day, but was unsuccessful in every attempt. I reported the weapon lost on September 16, 2009 to a Post 48 NCO. At the present time, I have no knowledge of the weapons current location.

#### Interview Summary

On September 16, 2009, this investigator contacted SFC Jerome BOWMAN at Post 48 in reference to Tpr. Chattam SMITH. SFC BOWMAN stated SMITH worked the midnight shift and at approximately 0606 hours this morning he reported to Sgt. Robert MOODY that he had lost his backup weapon apparently in a short foot chase at 1132 hours while on patrol. SMITH told MOODY that he stopped a vehicle at 20 West/MLK Blvd and the driver drove off as he approached the vehicle. SMITH ran back to his patrol vehicle and gave chase briefly to the next exit where the driver stopped the vehicle and fled on foot. SMITH began to give chase until he reached the car and discovered it was occupied by a passenger. He stopped and questioned the passenger and learned she was the owner of the vehicle. The owner was licensed and she told SMITH the driver had outstanding warrants. SMITH told MOODY he allowed the owner to leave the scene.

MOODY and SMITH returned to the scene where the driver fled on foot and searched the scene.

They did not discover the weapon. MOODY and SMITH returned to Post 48 and SMITH was instructed to begin writing his letter of explanation to Major MCDONOUGH.

SFC BOWMAN met with SMITH at Post 48 at approximately 0815 and he questioned SMITH about the incident. BOWMAN asked SMITH if he noticed his weapon in the ankle holster prior


to the incident. SMITH replied he recalled having the weapon prior to the chase. BOWMAN asked how it was possible SMITH worked for another six hours without noticing the weapon missing. SMITH stated he was accustomed to wearing it to the point that he didn't miss it until his shift was over and he was undressing. SMITH told MOODY and BOWMAN he was certain he had the weapon on at the beginning of his shift.

SMITH told BOWMAN he did not make any other traffic stops after that chase, but BOWMAN states the CADS system indicated SMITH made at least 3 more stops. BOWMAN and SMITH returned a second time to the scene, and this time included the location where SMITH states he made the initial stop, and they did not recover the weapon.

BOWMAN had not watched the video, but he stated he had it in hand and will view it and make this investigator a copy. BOWMAN stated he delivered SMITH's letter to Captain Fielding, but Fielding's secretary returned it indicating format errors that needed to be changed. BOWMAN made the changes and is waiting on SMITH to return to work tonight for his signature on the document.

#### Interview Summary

On September 21, 2009, this investigator contacted Sgt. Robert MOODY at Post 48 via telephone. The following is a synopsis of that interview.

Sgt. MOODY stated Tpr. SMITH notified him via telephone at 0606 hours stating he'd just discovered his weapon missing. MOODY told SMITH to meet him back at the scene and SMITH met MOODY in plain clothes. They looked for the weapon at the I-20 MLK exit ramp in a grassy area and on the shoulders of the roadway. They returned to Post 48 and SMITH was instructed to begin the lost property paperwork. When SFC BOWMAN came to work, they all three returned to the scene and this time SMITH told of his quick return back to his vehicle when the violator ran from the traffic stop. (Information SMITH had not told MOODY). They searched that area also and found nothing. SMITH told MOODY he knew he had the weapon on his ankle earlier that shift because he had scratched his ankle and felt the weapon.

MOODY stated as SMITH retraced his steps when looking for the weapon, he exited the patrol vehicle, ran slightly to the left, came back around the patrol vehicle and ran 10-18 feet up the grassy embankment before stating he saw a passenger and returned to the violator's vehicle.

MOODY found nothing unusual in that scenario until he and BOWMAN reviewed the tape and

noted the time between SMITH exiting the vehicle and his conversation with the passenger was approximately 4-5 seconds, and SMITH did not sound winded or excited.

MOODY stated it is policy to immediately turn in all video tapes when a chase occurs. SMITH had turned in the tape sometime during that shift. SMITH told MOODY that he had looked at the tape and the visual was not working. MOODY faxed WILLIAMS a copy of Post 48's August  $10^{th}$  Post Inspection form. (Exhibit #7)



On September 22, 2009, Lt. WILLIAMS contacted Captain Hank FIELDING via telephone. The following is a synopsis of that interview:

Captain FIELDING stated he had received Tpr. SMITH's reports and had forwarded them onto Major MCDONOUGH's office. FIELDING stated he recalled during his August 10<sup>th</sup> inspection that SMITH did not have his back up weapon. FIELDING could not recall SMITH's exact explanation, but FIELDING stated he found nothing unusual with the situation until the recent events surfaced. FIELDING had noted SMITH and another trooper did not have their back up weapons available for inspection on the report.

FIELDING faxed WILLIAMS a copy of SMITH's DPS Form-494: Lost, Stolen, Damaged or Destroyed Property form. (Exhibit #3)



#### **Interview Summary**

On September 30, 2009, CSA Leona FRIESON was interviewed in the SID office at DPS Headquarters by Lt. Jenny WILLIAMS. The following is a synopsis of that interview:

CSA FRIESON was questioned concerning her knowledge of Tpr. SMITH's missing weapon. FRIESON stated after they moved in together on August15<sup>th</sup>, SMITH came home after a midnight shift and told her he had lifted up his pant leg and noticed his backup weapon was missing. SMITH told her he'd been in a foot chase and must have lost it then. SMITH notified a supervisor and went back and looked for the gun, but had no luck. FRIESON stated SMITH is panicked over the loss of the weapon and feels his supervisors will think he acted irresponsibly, and he is afraid the gun will wind up in the hands of criminals and he will feel responsible.

FRIESON stated she has not seen the gun since they moved in together on August 15<sup>th</sup>. She stated he does not bring anything in the residence other than his gun belt. SMITH leaves all other equipment in his vehicle. FRIESON stated SMITH sometimes carried his gun when they went out to the movies, but she has not seen him carry the gun in several months. Likewise, she has not actually seen the gun in several months.

SMITH has not mentioned a previous, or an upcoming, post inspection to FRIESON.

Trooper SELLERS recalled an incident sometime in June just before he was transferred to Perry

on June 15, 2009, when SMITH chased a violator on foot in the MLK Drive area and lost his

backup weapon. SELLERS stated he helped SMITH look for the weapon in the immediate area,

but SELLERS remained with the patrol vehicles and the violators while SMITH retraced his

steps through several private yards until SMITH located his weapon. SELLERS stated SMITH

had run quite a distance and had crossed at least one fence during that foot chase.
