A search of our agency's records for the above information is estimated to take 10 hours to complete due to our office having to review the above information for redactions according to the GA Open Records Act. Using the O.C.G.A. 50-18-71 *et al* financial fee guidelines where the first 15 minutes are free, then \$17.00 / hour (based on hourly/salary amount of lowest paid person able to perform task), your estimated fee would cost **\$165.75**. 1. Arrest History by which you mean Adult Arrest Report has been included and redacted using {O.C.G.A 50-18-72(a)(25)(A)}.
2. The first page of the UOFs have been included and redacted using {O.C.G.A. 50-18-72(a)(20)}. There were no UOFs for Dep. Parks, Dep. Guay, or Dep. Donald {O.C.G.A. 50-18-71(j)}. The following UOFs for Cpl. Freeman were not included under {O.C.G.A. 50-18-72(a)(4)}: Case #'s 21-231700, 21-163414, 21-092738, 20-238119, 20-154733.
3. The images on file have all been included.
4. The IA Disciplinary Records are all included and any redaction made were under {O.C.G.A. 50-18-72(a)(20)}.
5. Complaints from Inmates/Jail/Public were all included and redacted using {O.C.G.A. 50-18-72(a)(20)}.

Additional redactions were made for the following Deputies: Dep. Pye: Pg 3: {O.C.G.A. 50-18-72(a)(21)}, and one complaint under IA Control #: 16-09-39 was ordered from Records Retention and has not been delivered to our office yet. For Dep. Donald, the IA Complaint #: 22-12-09 is exempt under {O.C.G.A. 50-18-72(a)(4)}. For Cpl. Freeman: Page 1 has redactions using {O.C.G.A. 50-18-72(a)(20)(A)} and IA Complaints 22-05-11 and 22-06-01 are exempt under {O.C.G.A. 50-18-72(a)(4)}.

The original estimate of 10 hours was incorrect. The actual amount of time it took to complete this request was 14 hours and 25 minutes. The correct financial fee owed our office is now **\$238.00** based on the O.C.G.A. 50-18-71 *et al* financial fee guidelines where the first 15 minutes are free, then \$17.00 / hour based on hourly/salary amount of lowest paid person able to perform task. Our office calculated this amount using 14 hrs and 15 minutes giving you an extra 10 minutes free. I want to draw your attention to a few things, 1. Not checking with me when the estimated fee went from \$165 to \$238. Violation 1, you assumed I was going to go for your use of prior restraint, it is clear you are trying to set me up and use

it to prevent future open records and jack the price up at the last minute, I sent this request on July 3rd, you had plenty of time to make sure your estimate was at least close., don't worry, I will be there to pay the \$238 and the \$12.75 for the 7 segments of Chris Brown body cam I requested and no itemized breakdown of what it is. I am expecting more :No body cam" which is why I requested his Axon audit trail in a previous email. You are getting desperate in the things you are willing to try to keep me from getting records from your agency.

How can you make this exemption? **This record has no bearing on any pending case**

Note: Any redactions made to the files and documents where the exemption guidelines were not cited are due to previous personnel who did the redactions; therefore, they could not be determined by our office. **You are charging me for redactions that were already completed prior to my request?**

You really make me work, I hate filing complaints!

I am forwarding this to Mrs. Settlemire for my records. It can and will be used against you in a court of law.
