OFFENSE NARRATIVE:

Two masked males entered the store through the main entry/exit doors. Suspect #1, who was armed with a handgun, chambered a round, and stated, "I'M NOT GONNA HURT YOU JUST GIVE ME EVERYTHING YOU GOT." The victim opened the register and both suspects removed the business cash from the till. They then ask her where the phones were, and she led them to the back of the store where they gathered several iPhones as well as business cash from the safe. They then returned to the front of the store where suspect #1 ask the victim where the other phones were, and she replied by pointing to the cabinet where additional phones are stored. Suspect #1 grabbed a garbage can and placed several Android phones in to the can. Both suspects then exited the store and ran southbound. A witness observed the suspects run from the store and around the south side of the building, and approximately 1 minute later, observed the above listed vehicle drive from behind the building at a high rate of speed and was last seen southbound on New Cut Rd.

The Air Unit responded but was unable to locate the suspects or any items of evidentiary value. K9 did not respond due to the suspects fleeing in a vehicle.

The victims two sons, ages 9 and 7, were present at the time of the robbery. They hid in the back of the store but were eventually seen by the suspects. One of the suspects stated to them, "EVERYTHING WILL BE ALRIGHT IT'S NOT YOUR FAULT."
