---

On 9-5-2019(Thursday) at 2241hrs you arrived to a motor vehicular collision at Campbellton Rd and Camp Creek pkwy. During the investigation you pulled accident case#2019-011621 and you pulled back into service at 2353hrs. Based on your Daily Activity sheet for that day you only had approximately 8 calls for service. You pulled back in from your last call at approximately 0347hrs. You failed to complete the accident report prior to your end of duty. You called out sick on Monday (9-9) and Tuesday (9-10). You subsequently had Military Leave from 9-13 thru 9-15(Friday-Sunday). Sgt. Wellington sent an email notification to you and CC'd supervision on 9-10-2019 for your outstanding reports (\*see attachment). In the email it stated, "If you are having issues please let me know".

On 9-18-2019 upon your return to work, I verbally advised you to complete all outstanding reports. You advised you had just returned, went through all of your emails and was clear on them. On 9-19-2019 a report audit was conducted and found that you still hadn't completed 4 outstanding reports (to include this accident). I then sent you an email stating to complete the reports immediately and reply to said email when they were completed. I then raised you over the radio to advise you to check the email I sent you and you replied that you were "clear". Prior to the end of duty around approximately 0655hrs, I called you to check to see if you had completed/submitted the reports and you verbally advised that you had. I then advised that I never received a response to my email stating that it was completed. You then advised that your laptop had died, and you would send the email upon your arrival to the precinct to charge your laptop (although most vehicles have invertors to power electronics and/or officers purchased their own invertors).

I checked later in the afternoon and still did not see any reports on the system nor a reply to said email. At 1534hrs, I received an email notification from Lt. White, stating that an involved party(Mr. Haney) in accident case#2019-011621, had come to the precinct again and was upset that his report was not ready, being that it has been over 2 weeks since the accident occurred.

I contacted the complainant who was undergoing physical therapy treatment from his accident with injuries. He needs a copy of the report to send to his insurance company so he wouldn't have to pay cost out of pocket. I was able to research the call and provide him with an insurance company name and the other involved parties policy number (from the vehicles tag) at the minimal since no report had been submitted.

I finally received an email from you on 9-20-2019 with three other reports, not including the accident case 2019-011621, which I advised you on. The complainant contacted me again on 9-24-2019 at approximately 1400hrs seeking the report. I again conducted a report audit and couldn't find the accident report in the system. I further researched reports with the date of the accident, just in case you unintentionally used the wrong case number and I still was unable to locate the accident report. Upon your arrival at work 9-24-2019, I advised you the report was still not show on the system. You then advised you checked your MFR and noticed the report had been rejected

by traffic supervision. You then fixed all errors and resubmitted the report and emailed me a copy. I then was able to send the Mr. Haney a copy of the accident report for his records

Cpl. R. Wyatt I find that you are in violation of the following SFPD General Orders/ Policy & Procedures, Rules & Regulations:

**Rules and Regulations:**

**1.29 DILIGENCE TO DUTY:**

All employees will diligently perform all duties and assignments of the South Fulton Police Department.

**1.31.A. INSUBORDINATION:**

Failure or deliberate refusal of any employee to obey a lawful order given by a superior officer shall be insubordination. Ridiculing a superior officer or his orders, whether in or out of his presence, is also insubordination.

**1.31.B. PERFORMANCE OF DUTY:**

All employees shall perform their duties as required or directed by law, Departmental rule, policy or order, or by order of a superior officer.

**1.32 TRUTHFULNESS:**

All members of the South Fulton Police Department must tell the truth whether under oath or otherwise. He/she will not willfully or recklessly depart from the truth:

**1.32.A.** In any official police investigation, inquiry, report or statement; or

**1.32.B.** In any statement he/she may make, cause to be made or distributed concerning the City government or South Fulton Police Department;

**Canon 3: INSUBORDINATION**

**General Order 34: Reports**

**Completing Field Reports/Review**

The incident report originates with the field officer. The officer must request the case number from the Emergency Services Department, collect, and enter the required information. Upon completion, the officer will forward the report electronically through R.M.S. to the shift supervisor for review of clarity, completeness, accuracy, and the signature of the reviewing supervisor. If the supervisor rejects, the report will be sent back to the officer for corrections. The process will continue until the supervisor approves.

**Accident Reports:** Accident reports are electronically submitted to the state through an automated system.

Based on this current complaint and previous issue with promptly completing report, truthfulness and insubordination, I recommend Cpl. Wyatt received a suspension from duty. I further recommend this complaint be forward to the Office of Professional Standards (Internal Affairs) for further review.

This memorandum is being drafted by the request of Lt. Green in reference to the completion of reports at the end of a shift. Toward the end of a shift I received a phone call from Lt. Green as a reminder to make sure reports are completed. At the time of the phone call, my laptop battery died and I was unable to submit the reports from the car due to a faulty inverter box. I informed Lt. Green I would stop by the precinct prior to leaving work to plug in my laptop and submit the reports. Prior to heading to the precinct, I was dispatched to a call that required me to pull a case number. Upon completion of that call I did go to the precinct where my car was parked and retrieve my portable inverter plug. I was able to plug in my laptop and power it enough to type my reports including the newest case number. A few hours later when I was off work, I received a phone call from Lt. Green but was unable to answer due to not having my phone on my person. Lt. Green texted me advising he did not see my reports on the system and wanted to know why after I advised him I would. Upon returning to my phone I did text Lt. Green advising I did submit the reports and would investigate the matter. Upon logging in to my computer, I noticed reports I submitted earlier were now showing in green on my MFR section. I attempted to resubmit the reports but was unsuccessful due to the program shutting down. the screen turned white giving an error message on two different attempts. I was successful on the third attempt and did email Lt. Green a copy of the PDF versions to ensure no further discrepancies.

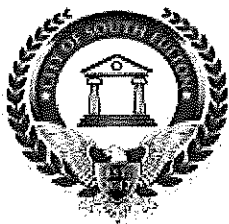
