SUBJECT: Cpl. Wyatt's Online Training 2019

During Rolls Calls for approximately the past 3 Months, Grey Morning Watch Supervision has instructed officers to complete the mandated 9hr online training courses. Supervision further instructed officers to print or email a copy of their completed training certificates to Supervision, so we know it has been completed and the certificates could be filed. During several rolls calls Cpl. Wyatt verbally advised that he already completed the online training, while he was assigned to the precinct (by Capt. E. Woods) after he was transferred from the background/recruitment unit to patrol (FOD). Cpl. Wyatt further advised that he submitted his certifications to Capt. Pritchett. Supervision furthermore verbally advised Cpl. Wyatt to submit his certificates to us. After failing to submit his certificates, Supervision was able to obtain Cpl. Wyatt's Post Training History and GPSTC Training History. The history shows that Cpl. Wyatt has never taken or completed the required training courses for 2019. Capt. Pritchett also never received any training certificates from Cpl. Wyatt (per her emails). Supervision then spoke with Cpl. Wyatt in the presence of Capt. Blackmon. We spoke on issues with getting his reports in timely (reference other write-ups) and this issue with Capt. Pritchett not having copies of his certifications.

Cpl. Wyatt continued with his statement that he had completed all online training class, while assigned to the precinct after leaving background/recruitment. Cpl. Wyatt again was advised to submit his completed certificates to Supervision. He was advised to log onto his GPSTC Account and print the certificates, since he was unable to locate his previous email (that he claimed he sent).

I further sent an email to Cpl. Wyatt advising him to submit Supervision his certificates on 9-30-2019. As of today's, date Cpl. Wyatt has failed to respond to the email and failed to submit his completed certificates.

I find Cpl. Wyatt has violated the following South Fulton PD's Rules and Regulations, General Orders and Policy/ Procedures:

Rules & Regulations:

1.31.A. INSUBORDINATION:

Failure or deliberate refusal of any employee to obey a lawful order given by a superior officer shall be insubordination. Ridiculing a superior officer or his orders, whether in or out of his presence, is also insubordination.

1.32 TRUTHFULNESS:

All members of the South Fulton Police Department must tell the truth whether under oath or otherwise. He/she will not willfully or recklessly depart from the truth:

1.32.A. In any official police investigation, inquiry, report or statement;

I recommend this be forward to the Office of Professional Standards (Internal Affairs) for review, due to past instances of untruthfulness.

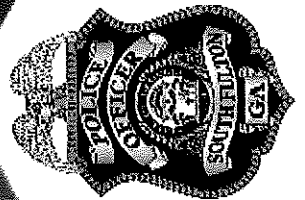

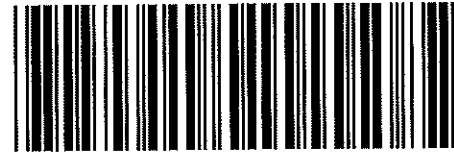
