Simmons) stated to 95 ██████████ that I didn't care about him doing a grievence on me for doing my job. While going through door between 5 and 6 I heard "somebody say "Racist Nigga" and when I walked back in Cell 6 95 ██████████ was still talking real loud, so I(ofc. Simmons) sprayed 95 ██████████ After spraying ██████████, 95 ██████████ started calling me Racist etc, So I advised that 95 he needed to stay out of it and Mind His own Business, or he could go directly to cell 2 for Getting in the way of me while I'm working. 95 ██████████ was escorted to the shower by myself and Cpl. Screen, cell 6 was placed on the Rec yard for the runaround to clean the cell.
