NARRATIVE/SUPPLEMENT

SUPPLEMENT #1

On 06/21/2021 at 4:26 PM I Deputy Bostick was dispatch to 316 MLK ST in Baconton in reference to window of a vehicle being shot. Upon arrival I made contact with [REDACTED] who stated that her back glass was shot out.

[REDACTED] stated that they were inside watching tv when they heard a loud bang come from outside. Mrs. Huntley stated that got up and look out the window and notice that there was glass behind there Vehicle that was park by the road. [REDACTED] stated that they got up and walk over to the Vehicle and notice that their back glass had been shot or busted out. Mrs. Huntley stated that they were unaware of which direction the sound could have come from. So they went back inside and call the 911.

I Deputy Bostick along with Investigator Brooks arrived on scene at the same time. Upon our arrival we notice couple of people out side watching us. We then made contact with [REDACTED] who advised us the same details that is listed above. we then check the area to see if there was a bullet fragment that could be laying next to the vehicle or inside of the vehicle. I then notice that there were two males sitting on the front prouch across from the incident. I then Identified one of males as Mr. Johntaven Simmons. I ask Mr. Simmons if he heard a gun shot which he advised he did. I then ask Mr. Simmons if he knew the direction it may have come from and he advised no. I then went back over to the scene where Investigator Brooks found where the vehicle was struck at. We then then took pictures of the dent and notice a sliver in color rust looking dust what appeared to be fresh in the dent where the object was struck.

While gathering all evidence we then notice that that there were cameras on side of the house that could have caught somone on there causing the damage. [REDACTED] took me inside and showed me the video. While watching the video you see a tan or brown vehicle pull into 321 MLK Dr and a black male wearing all black exit the vehicle. The male then walks over to the road. After you see the glass break from the vehicle the male subject then turns around and walks back to the his car. While turning around you could see a gun in the male's hand as he returns it back to his vehicle.

I then went back over to Mr. Simmons to follow up with Investigator Brooks. I then took a closer look at Mr. Simmons clothing and noticed they matched the ones that was in the video. Mr. Simmons then got frustrated with Investigator Brooks and myself and walk off and stated that he was not answering anymore of our questions. As I was walking away I then happen to come across a bullet casing that was in the same area that identified the male subject with the gun. I then notified Investigator Brooks who then took pictures and some measurments. The bullet was located 14ft or steps from the small sewer cap and 7ft or steps from the Big sewer cap.

[REDACTED] then showed Investigator Brooks a closer up video that help us identinfy the shooter even better. When Investigtor Brooks was done watching the video again he advised [REDACTED] to send that video to his phone as soon as she could and she advised that she would do so right away. Myself along with Investigator Brooks and Cpl Reddick and Deputy Carden went back to the 321 MLK and made contact with Mr. Simmons were we identified his clothing and placed Mr. Simmons under arrest. Mr. Simmons also gave over the 9MM that match the casing size and stored for evidence. As We walking off Mr. Simmons started cussing at Investigator Brooks. Deputy Wilson arrived on scene and transported Mr. Simmions to Mitchell County Jail where he was charge with Reckless Conduct, Obstruction Of Officers, Discharge of Gun or Pistol Near a Public Highway or street.
