Incident Summary

On 2/6/2019 at 1614hrs, Officer Wonka initiated a traffic stop for speeding on N I265 between Lagrange Rd and Old Henry Rd. The subject operating the vehicle put on her flashers and continued N/B until she came to a complete stop at the bottom of the ramp from I-265 to Westport Road. Officer Wonka approached the driver side of the vehicle and asked for the operators OL. The driver complied, and then Officer Wonka asked for the vehicles insurance information, the subject rolled up her window, locked the doors and told Officer Wonka to back away, that she was scared, wanted another officer and refused to comply with his orders. Officer Wonka knocked on the window and then tried to open the driver side door which caused the door handle to break off in his hand. Other officers arrived on scene within a few minutes, the subject was detained briefly during the investigation and then issued a traffic citation. Wonka's WVS was activated during the entire incident along with his in-car camera.
