	On the listed date and time, officers were dispatched to the listed location on a report of a black male, bald, with glasses, a gray hoodie and blue jeans walking around screaming and yelling. After arriving on scene officers observed the listed subject, who matched the description given in the run, standing in the middle of W Oak St, on the east side of the intersection with S 4th St. As officer drove by, the subject walked to the south side of the intersection, but as soon as the officer exited his marked LMPD patrol vehicle the subject began walking out in the middle of the street, yelling and screaming. The subject gave no regard for traffic, and was in danger of being struck by a passing vehicle. The subjects unreasonable noise and tumultuous behavior was causing alarm to those waiting for the TARC bus. As officer crossed the street in order to make sure that the subject was not struck by a car, the subject failed to heed officers verbal commands to stop and approached the officer in an aggressive manner, placing the officer in apprehension of imminent physical injury. Using soft empty hand control the officer removed the subject from the street, and asked the subject to place both hands behind his back. The subject refused to comply with officers commands in an attempt to prevent the officer from effecting his (the subjects) arrest. WVS activated.
