On 04/05/2019, I was dispatched to 3190 Smoke ridge Dr. in reference to a fight call. Prior to my arrival at the dispatch location, I made contact with a Ms. Angela Thomas( ) at the entrance of the subdivision. Ms. Thomas advised she was punched in the face by her boyfriend(Lawrence Mcmillian ) I was able to make contact with Mr. Mcmillian by knocking on the front door. Mr. Mcmillian did resist being palced in handcuffs with what appeared to be an attempt to flea. Mr. Mcmillian was detained without further incident and charged with battery and obstruction. the offender was transported to the East Point Jail. The victim did have a visible mark that appeared to be consistant with her on scene testimony. This case number was issued via victim rights pamphlet. The victim did deny on scene medical attention.
