On September 11, 2020 Deputy Parker Leathers was involved in a at-fault accident involving a county issued patrol vehicle while in the parking lot at 3425 Mike Padgett Hwy (South Sub Station). Deputy Leathers attempted to pullout of the parking lot while making a left turn and misjudged the clearance of the patrol vehicle parked directly to the left of his. The left side of Dep. Leathers' patrol vehicle struck the right front corner of the other patrol vehicle causing visible damage to both vehicles. Car 6211 (Asset #212034) had functional damage to the left side near the driver side door. Car 5003 (Asset #212069) had functional damage to the right side of the front bumper. I have counseled Deputy Leathers about the importance of attentive driving while operating a county vehicle.
