<p>On Saturday, July 10, 2021 at 0410 hours, I received a call from Hancock County E911 to give Brianna Grier a call in reference to a Financial Transaction Card Fraud and a Theft by Taking incident.</p> <p>Hancock County E911 connected me through to Ms. Grier (complainant/victim) who stated that between the above mentioned dates and times allegedly Christopher Lewis ([REDACTED]) of Sparta, GA took her 2014 gray in color Hyundai from his residence at [REDACTED] without permission for several hours and then brought it back.</p> <p>Ms. Grier further stated on Wednesday, July 7, 2021 at approximately 0915 hours, she received an email statement from Bank of Hancock showing that a charge of one hundred sixty one dollars and thirty eight cents (\$161.38) was paid to Georgia Power and charged to her Master Debit Card drawn on the Bank of Hancock in Sparta, GA.</p> <p>Ms. Grier further stated that her bank card was left in her above mentioned vehicle in a compartment at the time when it was allegedly taken by Mr. Lewis and that he must have taken the card at that time and used it on July 1, 2021 to pay his electric bill at Georgia Power.</p> <p>Ms. Grier advised that she contacted the Bank of Hancock on July 7, 2021 in the a.m. and disputed the charge and had them to flag the Master Debit Card payment to prevent further charges on it at which time the bank honored the request.</p> <p>Ms. Grier further advised that she was going to obtain a copy of her bank statement and a copy of the Master Debit Card payment from Georgia Power on Monday, July 12, 2021 and provide it to me to be attached to my incident report for further investigation.</p>

So I left Washington and went to Baldwin to get them when we got home, she begin shouting loud cussing, saying her father of wrong doing and stating my son Laquarius was molesting which was not true. Everytime she leave the house fooling with the wrong people and come back she start acting like a fool. I'm so tired of this I try to help her everyway I can but she is not pleased.</p> <p>I Sgt. "She (Brianna Grier) whip the kids for nothing and put her hand down the kids mouth. Smoking drugs around the children and accusing everybody of things that might hurt them."

Mary W. Grier then advised deputies that Brianna Grier would sit in the parking lot of a Gray 2003 Nissan Altima (VIN: 1N4AL11DX3C250647) throughout the day and smoke dope(Crack/Cocaine). Mary W. Grier then gave deputies a cigarette box with one of Brianna's dope pipe in it. Brianna Grier admits to deputies that she does smoke crack. Deputies then handcuffed Brianna Grier from the front and as she was being transported into a unit Brianna Grier fell out on the ground. Brianna Grier stated beforehand that while in the shower that she had took a bunch of pills at once. EMS was then called and EMS transported Brianna Grier to the Navicent Health Medical Center of Baldwin County.

Mary W. Grier then gave deputies consent to search the Gray 2003 Nissan Altima in her yard where Mary W. Grier stated that thats where Brianna Grier does drugs. When deputies search the vehicle deputies found the following; 2 yellow baggies with white residue, 2 clear baggies with white residue, a bud light beer can with a green baggie in it with white residue, 1 unknown pill tablet, and 1 more clear dope pipe with reskdue in it. All evidence was taken by deputies for evidence.

Later on deputies received information from Officer Willis (Cell Phone: [REDACTED]) from the Madison Police Department stating that Brianna Grier advised him that her 2 year old daughter has taken some "street drugs" and that she need to be evaluated as soon as possible. I, Deputy Ray made contact with Marvin Grier (Brianna Grier father) and informed him that he needs to take the child to the Navicent Health Medical Center of Baldwin County as soon as possible to be evaluated.

I, Deputy Ray then made contact with Dr. Sopenia Gay (Cell Phone: [REDACTED]) of the Navicent Health Medical Center whom stated that Brianna Grier 2 year old daughter (Maria Grier) has tested positive for Crack/Cocaine. Dr. Sopenia Gay further stated that Brianna Grier told her that the night before (April 30, 2021) that she and Bernard R. Reid (Father of the twin girls) had took their twin daughters (Maria and Mariah Grier) to a "Crack House" and Maria Grier may have pick some Crack/Cocaine up and swallowed it. Brianna Grier said she told her mother (Mary W. Grier) but she would not listen to her. Mary W. Grier told Dr. Sopenia Gay that she had no idea of the incident in question.

Brianna Grier was advised to come up to the residence. Brianna Grier did start to walk back to the residence and while walking with me (Lt. Primus) she asked me about my baby girl (Carmashia) which is her classmate but I did not reply.

I, Lt. Marlin Primus, and Deputy Legette made contact with both parents. Mary Grier, who was standing on the front porch and Mr. Marvin Grier who was sitting down on the porch. Mrs. Grier stated that you all need to take her back to the hospital where you have taken her before. While talking with the parents one of the twin girls came out on the front porch, crying. Mrs. Grier made the little girl go back into the house.

Brianna Grier was very aggressive toward parents and Deputies. I, Lt. Primus, asked Mr. Grier to say something. At that time, Brianna Grier stated to Mr. Grier that he smokes crack and he got the twin little girls sucking his dick. Mr. Grier stated that's lie.

I, Lt. Primus, could smell a strong odor of alcohol coming from Brianna Grier. Brianna Grier stated that she did drink some and that was in the refrigerator. Afterwards, I advised Deputy Legette to go to his unit and get his camera and three (3) masks, because I saw blood and we put on gloves. Deputy Legette did not have gloves, so I, Lt. Primus, got a pair from my unit and gave Deputy Legette a pair from my handcuff case (blue rubber pair). The blood was on her leg.

Brianna Grier stated that she was not going to jail and that she was going to kill herself when she gets to jail. I, Lt. Primus, asked Mrs. Grier to bring her some shoes and Mrs. Grier returned with some bedroom shoes. I, Lt. Primus, advised to get another kind of shoes. Mrs. Grier then returned back with a slip on pair of tennis shoes to wear. The mother returned with a black pair of tennis shoes and a black book bag. Both was placed in my unit on the rear passenger side.

We put gloves on and video was recording. Brianna Grier decided to go to the ground in a fetal position. Deputy Legette gave me his black handcuffs and she was cuffed to the front. We had to restrain her while taking her to the patrol unit. Deputy Legette had the arms and I, Lt. Primus, had her legs due to her kicking Lt. Primus. Blood did get on my uniform.

Brianna Grier refused to go to the unit. We did stop one time, because of her kicking, to get a better restraining grip. She was still kicking and refused to go. We placed her to the rear driver side door, but she refused to get into the unit. I, Lt. Primus, went around to the passenger rear side to attempt to get her into the unit but was unable to reach her. Then, I closed the rear passenger door and went back around to the driver side rear door and pulled out my taser and removed the cartridge and had it a low ready.

I, Lt. Primus, stated to Brianna Grier that I was going to tase her and she stated tase me out loud, but I, Lt. Primus, stated that I was not going to tase her but just get in the patrol unit Brianna. She got into a fetal position once again. Brianna Grier was picked up by Lt. Marlin Primus and was placed in the driver side rear seat and closed the door.

Both parents was advised early to come to the courthouse to do a 10-13 affidavit in the morning and that I will be at work at noon to talk with Mrs. Hudson chairperson and Judge Lamar to get her in a long term hospital. Deputy Legette stated that he had lost his bluetooth. Both Deputies was looking for his bluetooth and the bluetooth was located by his rear driver side tire on the ground.

Also, earlier Brianna Grier stated that some white man dropped her off.

I, Lt. Primus, advised Deputy Legette to turn on his dome red light until we return safely to the Detention Center with Brianna Grier. While travelling behind Deputy Legette's unit, on Hickory Grove Church Road, I noticed that the driver's door was opening and the rear passenger side door was opening and that Brianna Grier was laying in the grass on the ground. I asked Deputy Legette what happened. He stated that she jumped out. We quickly rendered aid by placing her in a sitting position and placed water on her face and for her to drink, trying to get her to respond, which she did. Deputy Legette called Hancock County E911 for EMS to be sent to this location.

Dispatch stated that a unit will be coming out of Baldwin. I, Lt. Primus, advised Deputy Legette to stay with her and keep rendering aid. I went to meet the EMS at 15 South. I also asked dispatchers to send out first responders. At that time, Med 1 came across the radio and stated that they are enroute coming from Mayfield and will be there shortly.

I, Lt. Primus, came back to the scene. Med 1 was on the scene. Contact was made to the Sheriff and Chief Deputy Ricky Brown. The scene was turned over to Med 1.

On July 15, 2022 at approximately 1224 am, Mary Grier contacted the Hancock County Sheriff's Office and stated her daughter, Brianna Grier had gotten dropped off at her home was beating on the door. Lt. Marlin Primus and I, Deputy Timothy Legette, arrived at the residence approx 1239 am and found Brianna Grier standing in the yard on the phone while Mrs. Grier stood on the porch. Both Lt. Primus and I, Deputy Legette, proceeded to the porch where Mary Grier stood. Lt. Primus spoke to Mary Grier who stated that Brianna Grier was acting out and could visit but not stay there. Around this time, Brianna Grier's father, Marvin Grier, came out of the house and stated that Brianna Grier had been drinking.

Lt. Primus then asked Brianna Grier if she had been drinking which Brianna Grier responded she got it out of there and pointed to the house. Lt. Primus then asked for my handcuffs and stated to Brianna Grier that he was charging her with public drunkenness. Brianna Grier then sat on the ground and refused to get up after being asked several times. Lt. Primus and I attempted to stand Brianna Grier up but she refused to stand. Both Lt. Primus and I, Deputy Legette, lifted Brianna Grier up and carried her to my unit. Lt. Primus and I, Deputy Legette, placed Brianna Grier back on the ground to open the driver side rear door of my unit. Brianna Grier refused to get up again after being asked several times by myself. Lt. Primus then went to the passenger side rear door of my unit and opened the door in an attempt to pull Brianna Grier into the unit, however, Brianna Grier was still on the ground near the driver side rear tire. Lt. Primus then closed the passenger side rear door and walked back over to me and Brianna Grier.

Lt. Primus picked Brianna Grier up and placed her in the back seat of my patrol unit. I, Deputy Legette, got into my unit and backed out of the yard. As I began to move forward, I, Deputy Legette, saw a reflection of Brianna Grier moving around in the back seat. As I turned around to see what Brianna Grier was doing, I hear the passenger side rear door open.

I saw what appeared to be her exiting the unit. I, Deputy Legette, stopped the unit, got out and saw Brianna Grier laying face down on the side of the road in the grass. I, Deputy Legette, went over to Brianna Grier and called her name and tapped her, however, she was unresponsive. Lt. Primus continued to attempt to wake her as I called for Grady EMS to assist.
