NARRATIVE

I responded to the listed location in reference to gunshots. Upon arrival, I spoke with Ms. Jones who reported that Mr. McBride-Owens followed her to Cracker Barrel, where her girlfriend, Jamella Cox, is employed at, and began a verbal altercation. Shortly thereafter, Mr. McBride-Owens drew a Smith and Wesson M&P Shield handgun, fired a round into the ground and then pointed the firearm at her chest while threatening to kill her. He then proceeded to choke her with his hands. Ms. Jones wrote a statement detailing such. No physical marks were visible on Ms. Jones.

Ms. Cox wrote a statement detailing that the subject, Maurice McBride-Owens, came to her place of employment to discuss information concerning her girlfriend, Tyasia Jones. Ms. Cox reported that they went outside to speak. Upon exiting Cracker Barrel, Mr. McBride-Owens drew his firearm and threatened to shoot Ms. Jones. Ms. Cox went back inside Cracker Barrel and heard a gunshot.

Ms. West wrote a statement detailing that the subject, Maurice McBride-Owens, shot a gun into the air, walked up towards Ms. Jones, and pointed the firearm at her chest. Mr. McBride-Owens then placed the firearm back inside his pants and continued a verbal altercation with Ms. Jones.

Mr. Vaccaro wrote a statement detailing that the subject, Maurice McBride-Owens, was arguing with Ms. Jones and demanding that his cell phone be returned to him. Mr. Vaccaro reported that Mr. McBride-Owens' cell phone was thrown into the street and at which time Mr. McBride-Owens discharged one round from his firearm into the road.

Mr. Bibb wrote a statement detailing that at approximately 11:00 a.m., the subject, Maurice McBride-Owens, grabbed Ms. Jones by the wrist forcing her toward the entrance of Cracker Barrel. Approximately 5 minutes later, Mr. McBride-Owens and Ms. Jones, while in a verbal altercation, walked outside the restaurant toward a vehicle in the parking lot when Mr. McBride-Owens drew a firearm from his waistband and pointed it toward her head and neck. Ms. Jones was able to walk away from Mr. McBride-Owens and he then fired a round into the air.

Mr. McBride-Owens stated that he went to Cracker Barrel to purchase food. While at Cracker Barrel, he saw the manager, Ms. Cox, and wanted to discuss with her information regarding Ms. Jones. Mr. McBride-Owens stated that as he and Ms. Cox exited Cracker Barrel, Ms. Jones arrived at the location and a verbal altercation ensued. Mr. McBride-Owens reported that Ms. Jones began hitting him in the face repeatedly. While Deputy Sheriff M. Sizemore was talking with Mr. McBride-Owens, Mr. McBride-Owens admitted that he fired one round from his firearm. No physical marks were observed on Mr. McBride-Owens.

While on scene, Sgt. Studer located a spent 380 Auto shell casing and also secured the firearm that Mr. McBride-Owens was in possession of. The firearm and shell casing were placed into evidence (BIN#12) under property receipt number P81258. Two photos of the shell casing were saved in the evidence drive under this report number. Mr. Bride-Owens was placed into custody and transported to the
