On 09/27/22 Dep. Parks attempted to stop a vehicle on the 1500 blk of Walton Way when the driver pulled into Krystal's parking lot and fled on foot. Deputy Parks chased the subject and discharged his county-issued taser. The subject was then taken into custody in the rear parking lot. Deputy Parks failed to activate his Body Worn Camera, which is required for all calls for service. The use of force was not captured on his body cam. This is Deputy Park's first violation of the policy regarding the body cam. Deputy Parks was warned that future violations would result in more severe punishment.
