On October 15, 2018 I spoke with Jailer Andrew Seymour about calling in sick. On October 13th, 2018 Jailer Seymour sent a text message to my phone stating due to a family emergency he would not be in to work. I was in an area with no service to my cellphone, so I did not receive the message until October 14th, 2018. Jailer Seymour did not contact his immediate supervisor Cpl Cathy Crumbley to advise her of his absence. Cpl Crumbley did not know Jailer Seymour was going to be out, so it appeared that Jailer Seymour did not notify anyone of his absence. I explained to Jailer Seymour the chain of command and how it works. I advised from this date forward if he is not going to be able to come to work on a scheduled day, he is to call his immediate supervisor. Jailer Seymour acknowledged that he understood.

On 02/12/2019 it was brought to my attention that some pepper spray had been sprayed in Q dorm. Sgt Patterson told me she was told Officer Andrew Seymour had sprayed it. When Sgt Patterson went to Q dorm, she could smell that pepper spray had in fact been sprayed. When she asked the inmates what had happened, they told her that Officer Seymour had sprayed it. Sgt Patterson asked Officer Seymour what had happened. Officer Seymour stated that he was attempting to remove a key ring from his belt and he accidently sprayed his pepper spray. I called Officer Seymour to my office and asked him what happened. He stated to me the same story about it being an accident while trying to remove the key ring from his belt. I advised Officer Seymour the next time he accidently sprayed pepper spray he is to notify his immediate supervisor.
