After speaking with Sgt Wyatt about this situation he advised the following:

Ms. Mumphrey is someone I have known for years through a mutual acquaintance from the Army. Ms. Mumphrey has called me several times advising of issues she has had with Mr. Baitey. Ms. Mumphrey advised because of the extensive call history at her home she is reluctant to call 911 for fear of being arrested. I have always instructed her if she feels there's an emergency or safety issue to call 911 and request Police to respond. Ms. Mumphrey has called me on various occasions to request information of possible steps that could be taken to rectify her issues with Mr. Baitey. I have always advised of citizen rights to seek evictions or TPO's.

I checked the history of this location (3470 Towanda Drive). We have responded to this location 9 times this year on fight calls. I have responded to this location with officers several times and remember dealing with Ms. Mumphrey. She has always called and would never want police help. Her children's father (Baitey) would always be gone upon police arrival. He has been on the phone with Mumphrey arguing while officers were on scene, so I am sure he heard not only Sgt. Wyatt giving advice but other officers as well. I believe Mr. Baitey is worried about information that Mumphrey has about his criminal activities.

I attempted to call Mr. Baitey at 2030hrs, 2100hrs and again at 2130hrs. No contact was made.

I find that there is no violation of Policy and this matter be handled on the watch level with no further action.
