I will also be using an open request on their personnel files as well. The video camera on that side of the building should show everything as well for exact time details. I also noticed he drove in reverse in the wrong direction in the window reflection, he pulled out of the back of the police station and looks like a jailor or the chief. Not sure but I would like to get all of these requests met at once if that is possible and if I need to fill out and open request the old way for each item that is fine too.

Personnel files on officer Rowe (badge 2504) and the unknown officer

copy of the video body cam footage from the incident officer Rowe was wearing and was blinking red, can be seen in video and Dash cam footage from officer Rowes police car

Body cam and dash cam footage from the unknown officer if exists, does not show a body cam in the video

If the man in the SUV is on duty and used any personal device I would like to open records that as well.

Good Morning Mr.Blume,

The employee involved in the incident on August 26 is identified as Lt. Lucas Grant who assigned to our Community Services Division. The complaint is being looked into.

Regarding your Open Records Requests:

1. Body worn camera footage of Deputy Sudarin Soosapillai's response to the incident that occurred on November

16, 2020: Three video files are available for release. Time to copy the videos is about 15 minutes. Cost of materials (Thumb drive) is **\$8.60**.

2. Personnel Files of Lt. Grant and Deputy Rowe: Estimated time to copy, review and redact any personal information (DOB, SSN, Personal Email, Personal Phone numbers and medical information, etc.) is 2 hours at \$20.00 per hour (First 15 minutes are free) and comes to **\$35.00**. Information can be placed on same thumb drive as above.

3. Body Worn Camera Footage from Deputy Rowe: One video is available for release. Time to copy the video is about 15 minutes which will be no charge. Information can be included on same thumb drive. There is no in-car camera in Rowe's vehicle, just the body worn camera.

Using the O.C.G.A. 50-18-70 *et al*/ financial fee guidelines where the first 15 minutes are free, then \$20.00 / hour, your estimated fee would cost **\$43.60**. Please let me know if you agree to pay the cost of this request. Once we receive your approval, we will begin assembling and producing the records. The accepted forms of payment are a Cashier's Check or Money Order paid to the Richmond County Sheriff's Office, [400 Walton Way Augusta, GA 30901](#).

Please advise how you wish to proceed.
