Narrative of the Circumstances Surrounding the Complaint

Cloud emailed the Internal Affairs office to file a complaint against Officer Alcaraz. Cloud stated Officer Alcaraz stopped them for a ficticious reason and was rude to her and her husband. The email is attached to this complaint.

Cloud's email:

To whom it may concern,

My husband and I were pulled over at about 2:04am 1/20/2019 by a Cobb County Police Officer on Powder Springs Road just before the East West Connector. We were instructed to pull off the road into an parking lot of Business. The officer never gave his name and badge number, he only stated that he was a Cobb county police officer, I then asked why we were pulled over. The officer claimed that it looked like we went slightly over our curb line. He asked where we were coming from. Once we both replied the movies he asked what movies as if we were lying. He also kept asking my husband did it feel like he drifted a little. After asking for my husband`s ID we sat and waiting in this desolate parking lot for another 5 minutes before he returned with a completely different tone and said " I was looking for drunk drivers your obviously not drunk have a nice night". The officer walks away quickly after returning my husband`s ID. We turned around to try to get the officers plate number but he pulled off very quickly.

This officer was parked on the side of the road in a turning Lane with his lights off before we passed him, he first got behind the car in the left lane and followed them before getting behind us and following my husband and I which resulted in us being pulled over. We were unfairly targeted for no reason. This officer didn't even have the decency to apologize after he was wrong. We were stalked from just after Powder Springs Road and Windy Hill/Macland until just before Powder Springs and East West Connector minus a small stretch of road where he was behind the other vehicle. This ruined our date night and was very uncomfortable to be falsley accused of something.

Complaint Investigation

On 01/22/19, I, Detective Bastis was assigned to investigate complaint #1586. I received a forwarded email from Sergeant Ramirez. The email contained a complaint on Cobb County Police. The complainant, Shantay Cloud advised in her email she and her husband had been pulled over on 01/20/19 around 2:04am by Cobb County Police. Mrs. Cloud stated the officer never introduced himself only as a Cobb County Police Officer. Mrs. Cloud stated they were unfairly targeted for no reason and stalked.

The officer was identified as Officer Alarcaz.

On 01/24/19 at 1015 hours, I contacted and accepted and advised her I was assigned to investigate her complaint. I told Mrs. Cloud I had reviewed her email and asked if there was anything additional she wanted to advise me. Mrs. Cloud said she was told by her husband, he didn't think the officer had his body camera on when he first approached their vehicle.

I explained to Mrs. Cloud I would be reviewing Officer's Alcaraz body camera and dash camera footage for her claim he didn't introduce himself and the traffic infraction. I advised Mrs. Cloud I would be calling her back for additional questions after everything is reviewed.

VuVault database was researched and Officer's Alcaraz's body camera footage was downloaded and attached to the complaint.

I then reviewed Officer Alcaraz's body camera footage. The date and time of the traffic stop was 01/20/19 at 0201 hours. The total time of the traffic stop was 5 minutes and 28 seconds. At 02:01:07, Officer Alcaraz approached the vehicle.

At 02:01:21, Officer Alcaraz stated "Good Morning". The passenger, Cloud immediately asked "Why did you pull us over". Officer Alcaraz stated he was about to explain. Officer Alcaraz then introduced himself as Cobb County Police Officer Alcaraz. Officer Alcaraz explained the reason he pulled them over was because the vehicle went over on the right side fog line. The driver made a statement but could not be understood because of the wind.

At 02:01:35, Officer Alcaraz asked where they were coming from. The driver stated the movies and Officer Alcaraz asked what movie. The driver responded with "Glass". Officer Alcaraz asked if the movie was good.

At 02:01:44, Officer Alcaraz asked the driver for his license. The driver handed Officer Alcaraz the driver's license. Officer Alcaraz asked if the information on the licenses was correct and the driver stated yes. Officer Alcaraz then asked if the driver realized he had went over the right side fog line, the driver said no.

From 02:02:15 to 02:05:57, Officer Alcaraz was in his vehicle checking the driver on his computer. During that time, Officer Alcaraz had connection issues with his MDC and requested the OLN be checked through Cobb County dispatch. Cobb County dispatch advised they also were having connection issues.

At 02:06:14, Officer Alcaraz returned to the complainant's vehicle and handed the driver his licenses back. Officer Alcaraz

told the complainant and the driver that he was looking for "drunks" and the driver obviously was not one. Officer Alcaraz thanked them and told them to be safe.

The body camera footage ended at 02:06:33.

On 01/25/19 at 0845 hours, I researched VuVault and downloaded Officer Alcaraz's dash camera footage. The dash camera footage was attached to the complaint.

I then reviewed the dash camera footage.

The footage started when Officer Alcaraz was travelling behind a vehicle. It appeared he was about car length to car and half length behind the vehicle.

At 00:13, the vehicle brakes.

At 00:15, it appeared the vehicle drove close to or on the white line next to the curb. It is difficult to see from the video footage.

At 00:56, Officer Alcaraz illuminated his emergency lights and conducted the traffic stop. The rest of the dash camera footage is consistent with the body camera footage.

On 02/01/19 at 0700 hours, I contacted Officer Alcaraz and stated I had reviewed the body camera footage and the dash camera footage. Officer Alcaraz confirmed he had been parked in a turning lane when the complainant passed him. Officer Alcaraz said the complainant's vehicle was in a group of vehicles when he got behind the complainant's vehicle, and witnessed the traffic violation. Officer Alcaraz said he regularly parks at that location to locate impaired drivers.

Mrs. Cloud's complaint was Officer Alcaraz never gave his name when he first approached the vehicle, and they were targeted for no reason and falsely accused of driving impaired.

After reviewing Officer Alcaraz's body camera and dash camera footage, Officer Alcaraz did state his name to Mr. Cloud and then explained to Mr. Cloud why the traffic stop occurred. The dash camera footage appeared to show the vehicle drive over or on the fog line. When Officer Alcaraz's told them he had been looking for drunk drivers and that the driver was not drunk, Officer Alcaraz was stating a fact and did not accuse them of being drunk.

Officer Alcaraz is accused of violating DPS Code of Conduct:

1.23 Courtesy

a.Employees shall at all times be courteous and respectful to the public and to one another. Employees shall be tactful in the performance of their duties, shall control their tempers, and shall exercise patience and discretion as appropriate under the circumstances.

b. In the performance of their duties, employees shall not use inappropriate gestures or express any prejudice concerning sex, gender, race, ethnic background, religion, age, politics, national origin, lifestyle, or similar personal characteristics.

On 02/13/2019 at 2150 hours I reviewed the original complaint, the investigation by Internal Affairs, and both the car and body worn camera's for Officer Alcaraz for this incident. The complaint was that Officer Alcaraz did not state his name, the reason for the stop was fictitious. Officer Alcaraz was rude, Officer Alcaraz treated them like they were lying by asking what movie that went to see, and Officer Alcaraz did not have his body worn camera activated at the beginning of the stop.

Officer Alcaraz does introduce himself, even after the complainant interrupts his first attempt at an introduction to ask why they were stopped. The complainant is the front seat passenger in the vehicle. The complainant stated that Officer Alcaraz's tone changed during the stop. I saw no change in tone and he was exceptionally polite and professional during the entirety of the stop, despite both occupants appearing to be upset from the beginning that they were stopped.

As for unfairly targeting this vehicle or the lack of a reason to stop the vehicle, I found the video evidence contradicted both claims. Officer Alcaraz states he began following a group of vehicles, looking for a violation. This is further supported by the complainant's own statement that Officer Alcaraz followed behind another vehicle at some point and there is at least one other vehicle present on the video, beside the complainant's vehicle. Officer Alcaraz is not following too close and is not driving in a manner to incite a violation. As officer's only need reasonable articulable suspicion to stop a vehicle, I believe that video clearly shows that Officer Alcaraz at the very least met this standard and it appears he has actually established probable cause. The complainant's vehicle does appear to strike the clearly marked right fog line, also braking at the same time for no apparent reason, then drifts back and comes very near to striking the same line again, and then drifts back completely across the lane and does or nearly does strike the hashed lane dividers. Striking the right fog light would be a violation of OCGA 40-6-48: Failure to Maintain Lane and Officer Alcaraz could have issued the driver a citation for this violation, but instead used his officer discretion and decided to issue only a verbal warning. Further, a vehicle being driven at 0200 hours that is weaving in its lane and braking unnecessarily, is a clear NHTSA indicator of an impaired driver, and a reasonable officer could ascertain that the driver is likely to be impaired.

As for the final claim that Officer Alcaraz treated the complainant and her husband as if they were lying by simply asking what movie they went to see, I find no cause for this either. Officer Alcaraz is clearly trying to determine if the driver is impaired upon contact. Officers are trained to get the driver to talk to them, so that they can ascertain: if there is an odor of an alcoholic beverage on their breath, they have slurred or other speech impairments, all while the officer is also observing the driver's eyes and overall condition as it relates to impairment.

Once Officer Alcaraz determines that the driver is not impaired, he returns to his vehicle to quickly check to be sure the driver has a valid license and no outstanding warrants. This is standard operating procedure for this department and law enforcement as a whole. The entire stop is under six minutes and there is no undue delay to the complainant and her husband.

I find this complaint to be Unfounded in its entirety. Sgt PM Cronin (badge 1609) [02/13/2019 22:43, CRONIP, 2571, DPS]

After reviewing the complaint and the investigation already completed by Internal Affairs Detective Bastis and Precinct V Sergeant Cronin, I find none of the complaints filed against Officer Alcaraz to be valid. I recommend this complaint to be UNFOUNDED. [02/14/2019 03:58, NICHOE, 1762, DPS]

I have reviewed the Officer Alcaraz's video and read the investigation completed by Detective Bastis. I concur with the findings that Officer Alcaraz had a valid reason for the stop, introducted himself, acted in a professional manner, and never accused anyone of being drunk. I recommend this complaint be UNFOUNDED.
