**FINAL DISPOSITION**

On Monday, October 21, 2019, GBI Region 14 SPECIAL AGENT WILL IVEY was in Charlton County, Georgia. While at this location, AGENT IVEY reviewed GBI Case File 14-0215-34-18, which corresponds to the shooting death of TONY GREEN by former Kingsland Police Officer ZECHARIAH PRESLEY.

AGENT IVEY notes the following:

On Saturday, October 5, 2019, PRESLEY was found not guilty on the felony charges of Voluntary Manslaughter and Involuntary Manslaughter. PRESLEY was found guilty of the felony charge Violation of Oath of Public Office. On Friday, October 18, 2019, PRESLEY received a five-year sentence of which one year is to be served under incarceration, with four years to be served on probation. PRESLEY was additionally sentenced to a 1500.00 dollar fine. PRESLEY was sentenced under the provisions of the First Offender Act.

AGENT IVEY respectfully request that this case be closed.

On Wednesday, June 20, 2018, the Georgia Bureau of Investigation was requested by the Kingsland Police Department to investigate an Officer Involved Shooting. On the above mentioned date Officer ZECHARIAH MARK PRESLEY had shot and killed ANTHONY MARCELL GREEN. The following is a synopsis of what occurred during the incident:

GREEN was located at a convenience store purchasing cigarettes when Officer PRESLEY pulled into the parking lot of the store. After making the purchase GREEN exits the store and gets into a vehicle as the driver. GREEN exits the store parking lot onto Hwy. 40 West and Officer PRESLEY follows GREEN. GREEN turns onto N East Street as does Officer PRESLEY. GREEN comes to a stop at the end of N East Street where GREEN and the passenger runs from the vehicle. The vehicle GREEN is driving does have damage to the front passenger side due to the manner and location GREEN stops the vehicle. Officer PRESLEY turns on his blue lights once GREEN has stopped the vehicle and Officer GREEN radios to dispatch, "10-50".

Once GREEN runs from the vehicle he quickly comes back to the vehicle and it appears he retrieves a cell phone from the vehicle. GREEN takes off running again and Officer PRESLEY pursues him. Once Officer PRESLEY gets close to GREEN he attempts to tase GREEN but is unsuccessful due to the taser's cartridge having fell off during Officer PRESLEY's pursuit of GREEN. In reviewing the body camera footage it appears Officer PRESLEY approaches GREEN and contact is made between the two. The contact looks to be brief and there is no indications of anyone

being hit although it appears that GREEN pushes Officer PRESLEY which allows GREEN to be able to run away. This is when Officer PRESLEY transitions from his taser to his handgun and fires 8 rounds in the direction of GREEN, per the medical examiner hitting him no less than 5 times and no more than 8 times.

Upon reviewing the body camera footage Officer PRESLEY makes several comments after the shooting reference GREEN running away and this is when he shot GREEN. Officer PRESLEY at first states that GREEN possibly hit him in the head but later is uncertain as to whether or not he was hit. Officer PRESLEY states that he tased himself in the arm and at one time he thought GREEN was going to kill him. Officer PRESLEY comments that he believed GREEN to be driving with suspended license.

The autopsy revealed that GREEN was shot once in the chest and the remaining shots were in the back or side areas. After consultation with the District Attorney's Office Officer PRESLEY was charged with Voluntary Manslaughter and Violation of Oath of Office.

The investigation is still ongoing.

While at this location, AGENT IVEY was telephonically contacted by GBI Region 14 ASAC RICHARD DIAL. ASAC DIAL contacted AGENT IVEY for the purpose of informing him of a request for GBI assistance.

ASAC DIAL relayed the following information:

Kingsland Police Department's ASSISTANT CHIEF WAYNE PEEPLES had contacted ASAC DIAL and requested investigative assistance from the Georgia Bureau of Investigation in reference to an Officer Involved Use of Force incident. ASAC DIAL informed AGENT IVEY that he had received information from ASSISTANT CHIEF PEEPLES that a Kingsland Police Officer had shot and killed a subject near the area of the Pineland Bank in Kingsland, Georgia.

On Thursday, June 21, 2018, Special Agent in Charge S. B. Carson was located in Camden County, Georgia in reference to an ongoing officer involved shooting where Kingsland Police Officer ZECHARIAH PRESLEY shot TONY GREEN resulting in GREEN'S death. AGENT CARSON requested Georgia Bureau of Investigation Intelligence Analyst JENNIFER WOODWARD to provide any information concerning a white Chrysler Pacifica displaying Georgia tag RLH6181, including an offline search of the tag. AGENT CARSON requested this in an effort to determine if and when the tag or vehicle had been ran through GCIC prior to the incident resulting in the death of GREEN. GREEN is believed to have been driving the Pacifica immediately prior to his death.

Analyst WOODWARD advised the vehicle was registered to [REDACTED] ROCHE, 3066 Colerain Road, Kingsland. Attached is a copy of the vehicle registration. Analyst WOODWARD provided AGENT CARSON with the attached printout which showed the above mentioned tag number being ran on four occasions: three times on April 17, 2018 by the Jacksonville Sheriff's Office and once on April 19, 2018 by the Camden County Sheriff's Office.

AGENT CARSON also requested WOODWARD to provide any information concerning GREEN, in particular whether or not his driver's license was suspended. ANALYST WOODWARD provided the attached copy of GREEN'S driver's license which showed that GREEN'S license had been suspended since 2014. ANALYST WOODWARD also ran GREEN'S criminal history which shows numerous arrest for possession of illegal narcotics, obstruction, and driving with suspended licenses.

On Thursday, June 21, 2018, at approximately 12:05 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY made contact with Kingsland Police Department LIEUTENANT BILL LEE, for the purpose of obtaining a briefing pertaining to an Officer Involved Use of Force incident.

Lt. LEE essentially related the following:

A Kingsland Police Officer, ZECHARIAH PRESLEY, had been involved in a vehicle pursuit that subsequently turned into a foot pursuit. The vehicle being pursued came to a stop at the intersection of N. East Street and Lillian Street, at such time PRESLEY pursued one of the occupants on foot. PRESLEY caught the subject on N. Satilla Street. At that time, a physical altercation occurred, and subsequently PRESLEY shot and killed the subject. Lt. LEE stated that he believed the decedent to be TONY GREEN; however, it was unconfirmed due to the decedent not having any identification upon his body. Lt. LEE further advised that the body of the decedent had been transported to the Camden Medical Center via ambulance prior to Agent IVEY'S arrival, and that Deputy Coroner JAMES GALLOWAY was responding to that location. Lt. LEE also advised Agent IVEY that PRESLEY had been taken to the Kingsland Police Department.

On Thursday, June 21, 2018, at approximately 12:17 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia, on North Satilla Street. While at this location, AGENT IVEY was approached by MARCEA ROACH.

ROACH essentially related the following information:

Upon AGENT IVEY'S initial contact with ROACH, he observed that she was visibly distraught. She informed him that she had heard that her brother, TONY GREEN, was in an accident and had gotten shot. She received this information via phone call from a subject named, LATOSHA WHITE. According to ROACH, TONY was driving her white in color Chrysler Pacifica earlier in the evening. She did not know who he may have possibly been with at the time he was shot. The last time she had spoken with him was Tuesday, June 20, 2018. She stated she had been unable to reach him via telephone.

For the purpose of trying to make a positive identification of the person shot by Kingsland Police Department OFFICER ZECHARIAH PRESLEY, AGENT IVEY asked ROACH if TONY had any tattoos or visible scars. She stated that he did not have any tattoos; however, he has a scar over his left eye.

This investigative activity was concluded on the same date at approximately 12:25 a.m.

On Thursday, June 21, 2018, at approximately 12:30 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY spoke with Kingsland Police Department OFFICER ZECHARIAH PRESLEY, for the purpose of obtaining information relevant to PRESLEY being involved in a use of force incident, in which TONY GREEN was shot and killed.

Agent IVEY notes the following:

PRESLEY declined to be interviewed without first consulting with an attorney. Agent IVEY then asked if PRESLEY had any visible injuries that needed to be photo documented, to which PRESLEY replied that he did not. Agent IVEY did not observe any visible injuries upon PRESLEY. At this time, PRESLEY was dressed wearing a black short-sleeved t-shirt and black uniform dress slacks. Agent IVEY notes that PRESLEY'S uniform shirt had previously been removed and collected as evidence.

On Thursday, June 21, 2018, at approximately 12:51 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Kingsland Police Department OFFICER BRYAN GREEN, for the purpose of obtaining information relevant to Kingsland Police Department OFFICER ZECHARIAH PRESLEY, being involved in a Use of Force incident in which TONY GREEN was shot and killed. Prior to beginning the interview with GREEN, AGENT IVEY advised BRYAN GREEN that the investigation was to determine whether any criminal laws had been violated during the Use of Force incident, and that it was not an administrative or disciplinary inquiry. GREEN was advised that he was not being compelled to give any statement or answer any questions and that his cooperation in this investigation was strictly voluntary. After advising BRYAN GREEN of such, GREEN agreed to be interviewed by AGENT IVEY.

GREEN essentially related the following information:

He was sitting stationary in his patrol vehicle near Christ Church Camden when he heard OFFICER PRESLEY call out that there had been a traffic crash, and that subjects were running from him. He thought that PRESLEY stated over the radio that he was located at U.S. Highway 17 and Lawnwood. He then thought that he heard PRESLEY state that he was at the Pilot Truck Stop. Later, he was able to discern PRESLEY'S radio traffic and determine he was located at Pineland Bank.

GREEN was the first officer to arrive on scene on North Satilla Street to assist

PRESLEY. Upon his arrival, he smelled gun powder. He observed a black male subject laying on the ground. PRESLEY stated to him that his head was hurting, and he noticed that PRESLEY had dirt on his back. PRESLEY told him that the black male subject was on top of him. GREEN then tried to get PRESLEY to sit in his car. PRESLEY told him that he needed to lay down, so PRESLEY laid down on the ground. At this time, he advised LIEUTENANT JASON SEAWARD and LIEUTENANT BILL LEE of PRESLEY'S location.

He described the black male subject laying on the ground as lying on his back in a driveway on North Satilla Street. The subject, who would later be identified as TONY GREEN, appeared unresponsive with his eyes rolled back into his head. Kingsland Police Department OFFICER ANDREW REED arrived on scene and began doing chest compressions on TONY GREEN. ASSISTANT CHIEF WAYNE PEEPLES also arrived on scene and observed GREEN. ASSISTANT CHIEF PEEPLES stated that GREEN was deceased. It should be noted that ASSISTANT CHIEF PEEPLES is also a DEPUTY CORONER for Camden County.

Shortly afterwards, Kingsland Police Department OFFICER FREDDIE KEMP and LIEUTENANTS JASON SEAWARD and BILL LEE arrived on scene. At this time, OFFICER PRESLEY was standing on his feet. Upon GREEN'S arrival, he did not observe OFFICER PRESLEY identifying himself as law enforcement, nor did he observe OFFICER PRESLEY rendering aid to GREEN. GREEN did not discharge his weapon during this incident. He stated that he did not discharge his weapon because the subject was already incapacitated on the ground and; therefore, there was not a threat present upon his arrival. GREEN did not take custody of OFFICER PRESLEY'S weapon. He informed AGENT IVEY that LIEUTENANT JASON SEAWARD took custody of OFFICER PRESLEY'S weapon. AGENT IVEY asked

OFFICER GREEN if TONY GREEN was armed at the time. He replied, that he did not think that he was.

When asked by AGENT IVEY if OFFICER PRESLEY had been involved with any other Use of Force incidents, he stated that he had been involved in several. He stated that one was for tasing a substitute teacher at the Camden County Board of Education Office. He does not know what the other Use of Force Incidents that PRESLEY has been involved pertain to; however, PRESLEY has not been involved in any Use of Force Shooting incidents that he knows of. OFFICER GREEN stated that he himself, had not been involved in any Use of Force incidents. At the time of this incident, OFFICER GREEN was armed with a Glock, model 22 hand-gun, which is a .40-caliber semiautomatic weapon. At the time of this incident, OFFICER GREEN was equipped with a functioning body camera and his patrol car was equipped with a functioning in-car camera system.

This interview was concluded on the same date at approximately 1:08 a.m.

On Thursday, June 21, 2018, at approximately 12:45 a.m., SPECIAL AGENT JAMIE KARNES was located at the Pineland Bank in Kingsland, Camden County, Georgia. The GBI Region 14 Field Office had been requested by the Kingsland Police Department to investigate an Officer Involved Shooting that occurred during the late evening hours of Wednesday, June 20, 2018. SA KARNES was contacted in order to complete a crime scene examination relating to this incident.

SA KARNES notes upon his arrival the Agent initially met with Region 14 SPECIAL AGENT IN CHARGE (SAC) STACY CARSON and ASSISTANT SPECIAL AGENT IN CHARGE (ASAC) RICHARD DIAL. They advised that Kingsland Police OFFICER ZECHARIAH PRESLEY attempted to stop the vehicle occupied by ANTHONY MARCELL GREEN and a second unknown occupant. The vehicle stop was located at the corner of Lilly and N. East Street a couple of blocks away from this location in Kingsland, Georgia. GREEN and the unknown passenger fled the vehicle on foot. OFFICER PRESLEY pursued GREEN on foot down Lilly Street. The Officer and GREEN continued down North Satilla Street. OFFICER PRESLEY reportedly shot GREEN while on North Satilla Street. SA KARNES was advised that this incident contained two locations, the first was the vehicle stop location and the second on North Satilla Street.

SA KARNES traveled to the corner of Lilly and N. East Street arriving at approximately 1:00 a.m. and observed that yellow crime scene tape had been put in place by Officers of the Kingsland Police Department. The weather was mostly clear with an outside temperature of approximately 75 degrees Fahrenheit. SA KARNES

obtained GPS coordinates of this location by using an iPhone GPS location application. The coordinates are 31 degrees 30' 51" N and 81 degrees 25' 60" W. SA KARNES utilized a Nikon D800 digital camera to photograph this area. All photographs taken are electronically attached to this summary.

SA KARNES observed a Kingsland Police Department, Ford Crown Victoria, 4-door patrol vehicle within this scene. SA KARNES noted the vehicle was prominently marked with Kingsland Police Department decals. The emergency lights on the vehicle were activated and operational. The vehicle displayed Georgia Government Tag # [REDACTED] and vehicle # 2091. The afore described vehicle was reportedly driven by OFFICER PRESLEY. A white in color, 4-door, Chrysler Pacifica vehicle was also observed within this scene. The vehicle engine was not running. The vehicle displayed Georgia Tag # [REDACTED]. SA KARNES notes the vehicle driver's side front door was open as was the front passenger door. The Chrysler vehicle was reportedly driven by GREEN. Both the Chrysler and patrol vehicles faced in a north, northwest direction.

SA KARNES observed an apparent broken, blue in color, knife handle outside of the vehicle on the passenger side where the front door was open. The handle was marked with Placard 1. SA KARNES observed what appeared to be the other half of the knife in the front passenger floorboard. SA KARNES was directed to a pair of Nike Brand flip-flop style footwear in a ditch adjacent to the front passenger corner of the Chrysler vehicle. SA KARNES notes the ditch contained water. The footwear was marked with Placard 2. SA KARNES located a Taser cartridge on the south side of Lilly Street and within this scene. The cartridge was marked with Placard 3. SA KARNES located a hat laying on Lilly Street that was inscribed with "CAVS." The hat was marked by yellow tape. SA KARNES placed Placard 4 next to the hat. SA

KARNES observed an apparent charging cord and box of Arm and Hammer Brand, Extra Strength, Carpet Odor Eliminator powder on the ground next to the open driver's side door. The cord and box were marked with Placard 5.

SA KARNES obtained measurements to each of the items utilizing the triangulation and baseline methods of measurement where appropriate. SA KARNES was assisted by Kingsland Police Department LIEUTENANT BILL LEE and Camden County Sheriff's Office DEPUTY ROBERT HOYT when obtaining the measurements. The triangulated measurements were obtained using a "Stalker" XS LIDAR Speed and Distance laser measuring device. LIEUTENANT LEE assisted with the operation of this measuring device which is also the property and equipment of the City of Kingsland, Kingsland Police Department. SA KARNES completed a sketch of this area. See attached sketch and measurement legend.

SA KARNES collected the knife handle on the ground at Placard 1 and labeled it with GBI Evidence Property Tag # AA60113. SA KARNES collected the footwear from the ditch at Placard 2 and labeled them with GBI Evidence Property Tag # AA60114. SA KARNES collected the Taser cartridge at Placard 3 and labeled it with GBI Evidence Property Tag # AA60115. SA KARNES collected the hat at Placard 4 and labeled it with GBI Evidence Property Tag # AA60116. SA KARNES collected the charging cord and Arm and Hammer box at Placard 5 and labeled them with GBI Evidence Property Tag # AA60117.

The Chrysler vehicle was turn over to A&A Towing for transport to the GBI Region 14 crime scene bay for additional processing. SA KARNES notes SAC CARSON followed the tow vehicle with the Chrysler to the Region 14 Office. SA KARNES sealed the front and rear passenger doors, trunk lift door, and driver's side rear

passenger door with red evidence tape. SA KARNES initialed and dated the red tape. SA KARNES notes the driver's side front door was not sealed at the scene due to the need to access the Chrysler at the office in order to maneuver the vehicle into the bay. SAC CARSON sealed the driver's door upon placement of the vehicle in the bay. SAC CARSON initialed and dated the red tape. The processing of the Chrysler vehicle is documented in a separate investigative summary contained in this case file.

SA KARNES noted the following with regard to the Kingsland Police Department vehicle (#2091) located at this scene. The patrol vehicle doors were closed. The back seat was empty and a "Thank You" card and white envelope were present in the rear floorboard behind the driver's seat. A plastic crate was present in the front passenger seat containing a "Popeye's" chicken box, reflective vest, clip board, folder, and a latex glove box. A pouch was affixed to the upright portion of the front passenger seat which contained assorted papers. A State of Georgia vehicle tag was located in the front passenger floor board bearing the number BTC 7584 with a section of newspaper. The vehicle center console contained a water bottle, drink cup, phone, and Huggies Brand wipes.

SA KARNES concluded the examination of the portion of the crime scene located at Lilly and N. East Street at approximately 3:08 a.m. SA KARNES next traveled to North Satilla Street in Kingsland, Camden County, Georgia, arriving at approximately 3:12 a.m. for the purpose of continuing the scene examination at the second location.

SA KARNES observed that yellow crime scene tape had been put in place around this scene by Officers of the Kingsland Police Department. SA KARNES observed a

SA KARNES noted the vehicle was prominently marked with Kingsland Police Department decals. The front of the patrol vehicle faced north on North Satilla Street. The scene was photographed with a Nikon D800 digital camera. The photographs are attached with all of the photographs taken at scene location 1 and 2.

SA KARNES observed a cell phone hands free headset on the west side of North Satilla Street just off of the roadway and slightly behind the patrol vehicle. SA KARNES marked the headset with Placard 1. A Taser (x26 model S/N X12006Y1P) was also located on the west side of North Satilla Street just off of the roadway and slightly behind the patrol vehicle. SA KARNES marked the Taser with Placard 2. SA KARNES observed (8) spent shell casings near the front driver's side corner of the patrol vehicle, underneath the patrol vehicle, and on the west edge of North Satilla Street. SA KARNES marked the spent shell casings with Placards 3 through 10 respectively. SA KARNES notes the spent shell casings were "WIN" .40 caliber S&W casings. SA KARNES observed several coins on the west edge of North Satilla Street. SA KARNES marked the coins with Placard 11. SA KARNES observed (3) one dollar bills (\$1.00) on the west edge of North Satilla Street and marked the bills with Placard 12. SA KARNES observed an area of suspected blood on the west edge of North Satilla Street and slightly off of the roadway. SA KARNES marked the suspected blood with Placard 13. SA KARNES observed a bullet resistant vest, blue in color, Kingsland Police Department patrol shirt, bottle of water, and belt keepers laying on the passenger right rear corner of the patrol vehicles trunk. SA KARNES marked the items with Placard 14.

SA KARNES collected the cell phone hands free headset at Placard 1 and labeled it with GBI Evidence Property Tag # AA60118. SA KARNES collected the Taser at Placard 2 and labeled it with GBI Evidence Property Tag # AA60119. SA KARNES collected the spent shell casings at Placards 3 through 10 and labeled them with GBI Evidence Property Tags # AA60120, AA60121, AA60122, AA60123, AA60124, AA60125, AA60126, and AA60127 respectively. SA KARNES collected the assorted coins at Placard 11 and labeled them with GBI Evidence Property Tag # AA60128. The coins were placed in GBI Evidence Block Bag # 925020 by this Agent. The coins consisted of (3) quarters and (4) pennies totaling seventy-nine cents (.79c). SA KARNES collected the (3) one dollar bills (\$1.00 x3) at Placard 12 and labeled them with GBI Evidence Property Tag # AA60129. The bills were placed in GBI Evidence Block Bag # 925029 by this Agent. SA KARNES collected a sample of the suspected blood at Placard 13 using cotton swabs. The swabs were labeled with GBI Evidence Property Tag # AA60130. SA KARNES collected the blue in color, Kingsland Police Department patrol shirt at Placard 14 and labeled the shirt and its' attached items with GBI Evidence Property Tag # AA94436. The shirt contained a name tag inscribed with "Z. PRESLEY", collar emblems, sleeve patches, a "Watch Guard" device, pen, and Kingsland Police Department badge "547". A suspected soil stain was present on the rear of the patrol shirt in the area of the right shoulder.

A Leica BLK 360 scanner was used to further document this scene. A copy of the scan data and "True View" image is maintained in this case file in a separate investigative summary. SA KARNES utilized the baseline method of measuring the items within this second scene area. SA KARNES completed a sketch of the scene. See attached sketch and measurement legend. SA KARNES established a fixed point for the baseline measurements by driving a steel spike into the ground on the

west side of North Satilla Street. SA KARNES obtained the GPS coordinates of the fixed point by using an iPhone GPS location application. The coordinates are 30 degrees 48' 3" N and 81 degrees 41' 21" W.

SA KARNES was provided with a copy of the Crime Scene Entry Log for the second scene location. The entry log is attached to this summary. This secondary scene was released to the Kingsland Police Department at approximately 6:40 a.m. On Monday, July 23, 2018, SPECIAL AGENT JOSH ELLIS, who is a GBI Crime Scene Program Technical Leader (TL) performed a peer review of this crime scene summary.

AGENT DIAL and AGENT CARSON made contact with JUANETTA [REDACTED], who was ANTHONY MARCEL GREEN'S maternal aunt. Also present during this interview was NATHANIEL [REDACTED], JUANETTA [REDACTED] husband.

ASAC DIAL and SAC CARSON provided information to JUANETTA [REDACTED] concerning the GBI'S involvement in the ongoing investigation into ANTHONY MARCELL GREEN'S death. AGENT DIAL provided [REDACTED] contact information for the GBI Region 14 Field Office.

AGENT DIAL notes that contact initially had been made with ANTHONY MARCELL GREEN'S sister, but due to her emotional state, information could not be communicated. AGENT DIAL advised JUANETTA [REDACTED] of this attempt and requested that if ANTHONY MARCELL GREEN'S sister wished to confer with the Georgia Bureau of Investigation, to contact the provided number.

On Thursday, June 21, 2018, at approximately 2:46 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Kingsland Fire Department LIEUTENANT CHARLES RONEY for the purpose of obtaining information relevant to an Officer Involved Use of Force incident in which Kingsland Police Department's OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN.

RONEY essentially related the following information:

When asked by AGENT IVEY for the date and time of being dispatched to the incident location and the time of his arrival, he stated that he was unaware of the exact times; however, that information would be provided on the Dispatch CAD Report. He stated that he left the Fire Department located on Highway 40, Kingsland, Georgia, near the Five-Points area. When he arrived on scene on North Satilla Street, he noticed several patrol vehicles from the Kingsland Police Department and the Camden County Sheriff's Office. He was met by a Kingsland Police Officer who escorted him to OFFICER PRESLEY. There were other emergency medical personnel already present, who were attending to TONY GREEN. Upon his initial contact with OFFICER PRESLEY, PRESLEY was laying on the ground. OFFICER PRESLEY was then put inside the back of an ambulance by RONEY.

He observed RACHEL BENOIT, MARK SMITH, JAMES BROWN, and CARL HORN, EMT'S with the Camden County Fire-Rescue performing chest

compressions on TONY GREEN. He observed that while they were doing compressions on GREEN, that blood was squirting out of the left side of GREEN'S body, under his armpit. RONEY stated that OFFICER PRESLEY had made verbal complaints of his head hurting, and that he seemed disoriented and shook up. He also stated that it seemed as if OFFICER PRESLEY was trying to get his thoughts together.

When asked by AGENT IVEY if GREEN was restrained, he stated that he did not notice whether or not he was restrained initially; however, GREEN was not restrained once he was in the back of the ambulance. When asked by AGENT IVEY if GREEN made any statements to him, he stated that he did not because he was unconscious. OFFICER PRESLEY stated to RONEY that GREEN had been involved in a traffic accident in which he fled on foot. OFFICER PRESLEY stated that he was in a physical altercation with GREEN, and that he thought that he had tased himself while he was in the altercation with GREEN. RONEY also informed AGENT IVEY that OFFICER PRESLEY stated to him that he and GREEN were fighting on the ground before shots were fired. RONEY stated that he did not collect anything from PRESLEY nor GREEN.

RONEY stated that OFFICER PRESLEY was not transported via ambulance from North Satilla Street; however, GREEN was transported via ambulance to the Camden Medical Center in St. Marys, Georgia. RONEY stated that Kingsland Fire Department, CHIEF TERRY SMITH, took a mobile phone from the person of TONY GREEN, and placed it inside of a latex glove, and turned it over to Camden County Deputy Coroner, JAMES GALLOWAY.

LIEUTENANT RONEY stated that he would send AGENT IVEY a copy of the EMS

and Fire-Rescue Reports via email.

RONEY did not observe any sign of pepper spray on or about GREEN.

This interview was concluded on the same date at approximately 2:58 a.m.

On Thursday, June 21, 2018, at approximately 3:18 a.m., ASAC RICHARD DIAL was located at the Kingsland Police Department in Kingsland, Camden County, Georgia, for the purpose of interviewing Kingsland Police Department, LIEUTENANT WILLIAM LEE, in reference to the ongoing investigation into the death of ANTHONY MARCELL GREEN as a result of an officer involved shooting earlier this same evening. AGENT DIAL notes that LIEUTENANT WILLIAM LEE was a responding Kingsland Police Department Supervisor to the scene of the shooting directly after the incident.

AGENT DIAL notes the following interview was audio recorded on a Sony Digital Audio Recorder. AGENT DIAL notes that a copy of this recording is attached and made part of this case file.

During this interview AGENT DIAL advised LEE that this investigation was criminal in nature and that it was not an administrative or disciplinary inquiry. AGENT DIAL also advised LEE that his cooperation was voluntary and he was not being compelled in any way to make a statement.

LIEUTENANT LEE stated that on the evening of June 20, 2018, he and LIEUTENANT SEAWARD were ending their assigned shifts. LIEUTENANT LEE stated that he had placed his issued body camera in the charger at his assigned office and had entered back into his assigned patrol vehicle. LIEUTENANT LEE stated that he was traveling on Highway 40 headed west when he heard OFFICER PRESLEY call out a "10-50" and two subjects were running. LIEUTENANT LEE

stated that OFFICER PRESLEY provided no location at that time. LIEUTENANT LEE stated that there was confusion concerning OFFICER PRESLEY'S exact location. LEE stated that it was initially thought that he may have just been near the Five Points location in Kingsland, Georgia. LIEUTENANT LEE stated that based upon information they heard over the radio, specifically a reference to "Pilot", he started heading to the Scrubby Bluff area of Kingsland, Georgia. LIEUTENANT LEE stated it was obvious to him there was poor communication by OFFICER PRESLEY due to a foot pursuit.

LIEUTENANT LEE stated that one of the Kingsland Police Department officers figured out what OFFICER PRESLEY was attempting to communicate, that the location was behind Russell's Collision Center. LIEUTENANT LEE stated that he traveled to Lily Street where he initially made contact with the vehicle allegedly operated by ANTHONY MARCELL GREEN. LIEUTENANT LEE stated that he observed OFFICER PRESLEY'S vehicle present at that location. LIEUTENANT LEE stated that he then traveled to where OFFICER PRESLEY was located. LIEUTENANT LEE stated that Kingsland Police Department OFFICER GREEN had already made contact with OFFICER PRESLEY before LIEUTENANT LEE'S arrival.

LIEUTENANT LEE stated that OFFICER GREEN had requested an ambulance and indicated that shots had been fired. LIEUTENANT LEE stated that a supervisor's presence was also requested. LIEUTENANT LEE stated that when he arrived on scene, he observed OFFICER PRESLEY laying on his back with his hands above his head. LIEUTENANT LEE stated that OFFICER PRESLEY was on the east side of the roadway with OFFICER GREEN'S car in the middle of the road. LIEUTENANT LEE stated he asked OFFICER PRESLEY if he was, "okay." LIEUTENANT LEE stated that OFFICER PRESLEY advised him that his head hurt.

LIEUTENANT LEE stated that he immediately began notifying his Chain-Of-Command about the Officer Involved Shooting Incident.

LIEUTENANT LEE stated that he did visually inspect OFFICER PRESLEY to determine if he was injured. LIEUTENANT LEE stated that he saw no injuries on OFFICER PRESLEY.

LIEUTENANT LEE stated that at one point, OFFICER PRESLEY got to his feet and began taking his shirt off. LIEUTENANT LEE stated that he knew that LIEUTENANT SEAWARD had taken possession of OFFICER PRESLEY'S weapon. LIEUTENANT LEE stated that when he first arrived on scene, he observed that OFFICER PRESLEY was wearing his body camera and it was activated.

LIEUTENANT LEE stated that he observed the body of ANTHONY MARCELL GREEN on the ground. LIEUTENANT LEE stated that he saw no weapons on or around ANTHONY MARCELL GREEN.

LIEUTENANT LEE stated that he did observe that OFFICER PRESLEY was wearing his issued Kingsland Police Department uniform identifying him as an officer.

LIEUTENANT LEE stated that he never observed any previous altercation between OFFICER PRESLEY and GREEN.

LIEUTENANT LEE stated that he only knew OFFICER PRESLEY from his employment at the Kingsland Police Department. LIEUTENANT LEE stated that OFFICER PRESLEY was "filling in" for this shift and that this shift of officers was not

his regularly assigned duty shift.

LIEUTENANT LEE stated that he was familiar with TONY MARCELL GREEN. LIEUTENANT LEE stated he had contact with TONY MARCELL GREEN when LEE previously worked for the Camden County Sheriff's Office Drug Unit. LIEUTENANT LEE stated that he had no previous violent interaction with GREEN. LIEUTENANT LEE stated that GREEN had never personally fled from him. LIEUTENANT LEE stated that he had received information from other officers that GREEN would flee from law enforcement. LIEUTENANT LEE stated that he could not recall any information he had ever received concerning GREEN being violent towards any officers in the past.

During this interview LIEUTENANT LEE hand drew a sketch illustrating the scene. A copy of this sketch is attached and made a part of this case file. The original hand drawn sketch is maintained in the case file.

LIEUTENANT LEE provided no further pertinent information, thus contact was concluded at approximately 3:50 a.m.

On Thursday, June 21, 2018, at approximately 3:18 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Kingsland Police Department LIEUTENANT JASON SEAWARD, for the purpose of obtaining information related to the shooting death of TONY GREEN. Prior to beginning the interview, AGENT IVEY advised LIEUTENANT SEAWARD that the investigation is to determine whether any criminal laws have been violated during the Use of Force incident, and that the investigation was not an administrative or disciplinary inquiry. AGENT IVEY further advised LIEUTENANT SEAWARD that he was not being compelled to give any statements nor answer any questions, and that his cooperation in this investigation would be voluntary. After being advised as such, LIEUTENANT SEAWARD agreed to be interviewed by AGENT IVEY.

SEAWARD essentially related the following information:

He was traveling west bound on Highway 40 at the end of his shift, traveling towards his residence. As he passed by the Flash Foods store on the corner of Williams Street and Highway 40, he observed OFFICER ZECHARIAH PRESLEY backing out of the Flash Foods parking lot. SEAWARD continued west bound down on Highway 40 when he heard over the police radio that OFFICER PRESLEY was out with a traffic crash. At the time he heard PRESLEY call this information out over the radio, he was located near the entrance of The Meadows Subdivision on Highway 40. He then heard OFFICER PRESLEY state over the radio that he was in a foot pursuit. SEAWARD then turned around and traveled east bound on Highway 40 in order to

render assistance to OFFICER PRESLEY. According to SEAWARD, PRESLEY did not give an accurate location, and it sounded as if he was running while talking on the radio. SEAWARD then turned onto U.S. Highway 17 headed south towards Williams Street. He then traveled down Williams Street and got to the intersection at Highway 40, when he heard OFFICER PRESLEY say that shots had been fired over the police radio. SEAWARD then observed another police unit west bound on Highway 40, and he followed him. Another police unit went down East Street by Russell's Collision. SEAWARD then turned right on East Street and Lily Street and observed Kingsland Police Department OFFICER COREY HOSTER standing by a vehicle that had crashed in the wood line. SEAWARD then left from that location and went to the area of Pineland Bank.

Upon initial contact with PRESLEY, SEAWARD observed that PRESLEY was laying in the road next to the second entrance of Pineland Bank. He also observed that another officer was standing with him. He initially thought that PRESLEY may have been shot, due to him laying on the ground.

SEAWARD then observed TONY GREEN laying on the ground. He stated that GREEN was unresponsive and had no pulse. He did not perform a weapon's check on GREEN; and therefore, was unaware if GREEN was armed or not. SEAWARD then went back to his patrol vehicle and retrieved a medical bag in order to render aid to GREEN. Before he could return to GREEN'S body, EMS had arrived on scene and was administering medical aid. He then went to check on OFFICER PRESLEY while EMS attended to GREEN.

SEAWARD observed what appeared to be a bullet hole near the left armpit area of GREEN, and also observed that GREEN had blood upon his shirt, and on his hip

area. SEAWARD found OFFICER PRESLEY'S Taser on the west side of North Satilla Street. PRESLEY'S Taser did not have a Taser cartridge loaded into it. According to SEAWARD, he did not touch PRESLEY'S Taser.

He then went back to OFFICER PRESLEY and got him to sit up. At this time, he took possession of OFFICER PRESLEY'S gun and gun belt, and also took possession of OFFICER PRESLEY'S body camera. He then secured those items inside his patrol vehicle.

SEAWARD then helped secure the scene by taping it off with Kingsland Police Department, OFFICER ANDREW REED and OFFICER FREDDIE KEMP. He stated that while taping off the scene, he observed shell casings that were near Kingsland Police Department OFFICER BRYAN GREEN'S patrol vehicle. He left OFFICER GREEN'S patrol vehicle, as it sat, inside the crime scene. He further stated that TONY GREEN'S body was half in the roadway. He also stated that he found shell casings on the west side of North Satilla Street.

When asked by AGENT IVEY as to what movements were made by TONY GREEN, SEAWARD stated that he did not make any movements due to him being unresponsive. He stated that movements made by OFFICER PRESLEY, was that PRESLEY was laying on his back. SEAWARD is unaware if PRESLEY rendered aid to GREEN prior to his arrival. SEAWARD did not discharge his weapon, nor did he draw his weapon from his holster, due to there not being any active threats upon his arrival.

When asked by AGENT IVEY if he was aware of any previous Use of Force incidents involving OFFICER PRESLEY, he stated that PRESLEY has not been

involved in any prior shooting cases; however, he has had incidents where he has used his Taser. He stated that he tased a subject at the Camden County Schoolboard Office, and that he tased a subject at the IGA Grocery Store on south Highway 17.

During this incident, SEAWARD was armed with a Glock model 22 semiautomatic .40-caliber pistol. Both his vehicle and body cameras were both functioning during this incident.

This interview was concluded on the same date at approximately 3:40 a.m.

On Thursday, June 21, 2018, at approximately 3:52 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Kingsland Police Department OFFICER COREY HOSTER for the purpose of obtaining information relevant to a Use of Force incident in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN. Prior to beginning the interview, AGENT IVEY advised HOSTER that the investigation is to determine whether any criminal laws have been violated during the Use of Force Incident, and that it is not an administrative or disciplinary inquiry. HOSTER was further advised that he was not being compelled to give any statement or answer any questions, and that his cooperation in the investigation was voluntary. After being advised as such, HOSTER agreed to be interviewed by AGENT IVEY.

HOSTER essentially related the following information:

He was traveling east bound on Highway 40 near the Interstate 95 interchange around 10:00 p.m. on June 20, 2018. He heard another officer call over the police radio that there had been a traffic crash and a subsequent foot pursuit. He then traveled on Highway 40 west bound towards the direction of the Five Points area. He thought he heard OFFICER PRESLEY state that he was at the Pilot, so he drove down South Grove Street. AGENT IVEY notes that the Pilot Truck Stop is located near Exit 1 off of I-95 in Kingsland. After realizing that OFFICER PRESLEY was not in the area of the Pilot, he traveled down East Street, where he discovered a vehicle that had crashed in the wood line near the intersection of East Street and Lily Street.

HOSTER then exited his patrol vehicle and cleared the subject's vehicle for any threats. He then stayed on scene with the vehicle in the wood line due to other patrol units that were assisting OFFICER PRESLEY. He observed the subject's vehicle with the engine still running and the front doors opened.

When asked by AGENT IVEY what movements were made by OFFICER PRESLEY and TONY GREEN, he stated that he did not see them due to him staying on scene with the crashed vehicle. When asked by AGENT IVEY if he discharged his weapon, HOSTER stated that he drew his weapon out of its holster upon approaching the subject's vehicle, but he did not discharge his weapon. He did not discharge his weapon due to their not being an active threat. HOSTER did not take possession of OFFICER PRESLEY'S firearm, and unaware as to who took possession of it. HOSTER was unaware if TONY GREEN was armed or not armed during this incident. He also did not have knowledge as to whether or not anyone came in contact with any weapons during this incident.

When asked by AGENT IVEY if OFFICER PRESLEY had been involved in any prior Use of Force incidents, HOSTER stated that he has not been involved in any shootings; however, he has been involved in non-lethal Use of Force incidents. He stated that internal investigations were done on these incidents, and that all were deemed as being justifiable.

HOSTER was armed during this incident with a Glock model 22 .40-caliber pistol. His pistol was loaded with Winchester Ranger 2 Ammunition. During this incident, HOSTER'S in-car camera system, and body-cam system were both operational and functioning.

On Thursday, June 21, 2018, at approximately 4:06 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Kingsland Police Department, OFFICER ANDREW REED, for the purpose of obtaining information relevant to the Use of Force incident in which Kingsland Police Department OFFICE ZECHARIAH PRESLEY shot and killed TONY GREEN. Prior to beginning the interview, AGENT IVEY advised OFFICER REED that the investigation is to determine whether any criminal laws had been violated during the Use of Force incident, and that it is not an administrative or disciplinary inquiry. REED was further advised that he was not being compelled to give any statements or answer any questions, and that his cooperation in the investigation was strictly voluntary. After being advised of such, REED agreed to be interviewed by AGENT IVEY.

REED essentially related the following information:

He was traveling in his patrol vehicle on Lakes Boulevard in Kingsland, Georgia. He then heard OFFICER PRESLEY state over the police radio that there had been a traffic crash. He also heard him state that two subjects had exited the vehicle, and it sounded as if PRESLEY was running while he was talking over the police radio. He heard PRESLEY state that he was traveling down Williams Street towards U. S. Highway 17, and then heard him say that he was traveling down Highway 40 and South Grove. He also heard PRESLEY state that he was at the Pilot Truck Stop. Another officer came over the radio and said that he was at the Pineland Bank. He stated that he could hear over the radio what sounded like a portable microphone

that was keyed-up, and it sounded as if there was a physical struggle. He then heard PRESLEY state over the radio, "GSW."

REED then turned on North Satilla Street in Kingsland, Georgia. Upon his arrival, OFFICER BRYAN GREEN was on scene. REED observed OFFICER PRESLEY laying on the ground next to GREEN'S vehicle. He observed TONY GREEN laying halfway in the road on North Satilla Street and the other half of his body lying in a driveway. GREEN was lying on his back with his arms and legs spread. REED checked on PRESLEY, and then got a medical bag to render treatment to TONY GREEN. Before rendering aid to GREEN, he was informed by Kingsland Police Department's Lieutenant that TONY GREEN was deceased. REED remained on scene until the Georgia Bureau of Investigation arrived. The injuries he observed on TONY GREEN were a blood mark on his left arm, blood on his chest area; however, he could not discern where any gunshot wounds were. When asked by AGENT IVEY about any injuries to OFFICER PRESLEY, he stated that PRESLEY complained of his head hurting. Upon his arrival, GREEN was not responsive, and not moving. OFFICER PRESLEY was laying down on the ground, and asking about the condition of TONY GREEN. He stated that OFFICER PRESLEY seemed very shaken up.

When asked by AGENT IVEY if OFFICER PRESLEY had identified himself as law enforcement, he stated that he did not know because he arrived on scene after the incident had occurred. He is unaware if OFFICER PRESLEY rendered aid to TONY GREEN. REED stated that he did not discharge his weapon. He stated that the reason he did not discharge his weapon, was because there was no active threat upon his arrival. REED did not take custody of PRESLEY'S weapon after the incident. When asked if TONY GREEN was armed during this incident, he stated

that Kingsland Police Department OFFICER FREDDIE KEMP patted TONY GREEN down, and no weapons were on GREEN'S body upon his arrival.

When asked if OFFICER PRESLEY had been involved in any prior Use of Force incidents, REED stated that he has not been involved in any shooting incidents; however, PRESLEY has been involved in at least two Use of Force incidents. REED believes that it is related to two taser incidents; however, he is unsure because he normally works on a different shift than PRESLEY.

During this incident, REED was armed with a Glock model .22 40-caliber pistol. He stated that he did not un-holster his weapon during this incident, and that his weapon was loaded with Winchester Ranger Ammunition. During this incident, REED'S in-car camera system and body camera system were both operational and functioning. When asked by AGENT IVEY if he had any other information that would be pertinent to this investigation, REED stated that TONY GREEN had a cell phone in his right hand upon his arrival.

While at this location, AGENT IVEY interviewed Kingsland Police Department OFFICER FREDDIE KEMP for the purpose of obtaining information related to a Use of Force incident in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN. Prior to beginning the interview, AGENT IVEY advised OFFICER KEMP that the investigation was to determine whether any criminal laws had been violated during the Use of Force incident, and that it is not administrative or disciplinary inquiry. AGENT IVEY further advised KEMP that he was not being compelled to give any statements nor answer any questions, and that his cooperation in this investigation would be voluntary. After being advised as such, KEMP agreed to be interviewed by AGENT IVEY.

KEMP essentially related the following information:

While on patrol, he heard OFFICER PRESLEY call out a traffic stop and then immediately call out that there had been a traffic crash. He then heard over the police radio, OFFICER PRESLEY stating that he was in a foot pursuit and that two subjects were running from him. KEMP was near the Chick-fi-la restaurant on Highway 40 when this occurred. KEMP was riding with his Field Training Officer, ANDREW REED during this time. He and REED then started driving west on Highway 40 to render assistance to OFFICER PRESLEY. He stated that most of PRESLEY'S radio transmissions were not understandable, and that PRESLEY sounded stressed. He stated that he thought he heard PRESLEY state that he was

at the Pilot, and then he heard PRESLEY state over the radio, "Shots fired." KEMP later determined what he thought was being described as "the Pilot", was actually, Pineland Bank. While enroute to give assistance to OFFICER PRESLEY, there were five patrol vehicles ahead of him. He then turned onto North Satilla Street in Kingsland, Georgia. Upon his arrival, Kingsland Police Department, OFFICER BRIAN GREEN was comforting PRESLEY.

KEMP then searched the body of TONY GREEN for weapons and found none. He stated that it appeared that TONY GREEN had lost a bowel. He also observed a gunshot wound to the chest of TONY GREEN on his left side. TONY GREEN still had a mobile phone in his left hand when he observed him. TONY GREEN also had, what appeared to be, fresh abrasions on the inside of his arm. He described TONY GREEN as being unresponsive, with having slight involuntary movements.

He did not ask OFFICER PRESLEY any questions, other than asking him if he was okay. PRESLEY stated in his presence, that he had a headache. When asked about any injuries to OFFICER PRESLEY, he stated that PRESLEY had dirt on his right arm and complained of a headache, and that he was sweaty. KEMP arrived on the scene at 10:57 p.m. He remained on the scene until the Georgia Bureau of Investigation arrived.

He observed Emergency Medical personnel doing chest compressions on TONY GREEN. These chest compressions caused blood to squirt out of a gunshot wound on GREEN'S body.

When asked by AGENT IVEY if OFFICER PRESLEY identified himself as law enforcement during this incident, he stated that he was unfamiliar due to him arriving

after the incident had occurred. He was unfamiliar whether or not OFFICER PRESLEY rendered aid to TONY GREEN; however, OFFICER ANDREW REED retrieved his medical bag to help GREEN, but EMS arrived before REED could assist. AGENT KELLY was at the above location as part of a neighborhood canvass related to the ongoing investigation of an officer-involved shooting involving Kingsland Police Department (KPD) OFFICER ZECHARIAH MARK PRESLEY and ANTHONY MARCELL GREEN on June 20, 2018.

AGENT KELLY spoke with the homeowner, [REDACTED] [REDACTED]. [REDACTED] [REDACTED] advised she was home with her husband, [REDACTED] and her children, [REDACTED] [REDACTED] [REDACTED]. [REDACTED] [REDACTED] noted she heard six to seven gunshots, but she initially thought that the sounds were fireworks. The children came running into her room frightened by the fireworks and the group went to her daughter, [REDACTED], bedroom where they saw the blue lights from several police cars pulling into the area. After the police arrived, [REDACTED] went outside and spoke with her neighbor about what had happened. While outside, [REDACTED] saw a police officer giving cardio pulmonary resuscitation (CPR) to someone laying on the ground. Prior to hearing the gunshots, [REDACTED] had been in bed and heard nothing before the shots nor had she seen anything. After hearing the shots, [REDACTED] had seen police officers with flashlights in her backyard, and her husband, [REDACTED], had turned on the floodlights in their backyard to assist the officers and to ensure that no-one was there.

AGENT KELLY next spoke to [REDACTED], who stated he had heard approximately six gunshots in the direction of the bank. After hearing the gunshots, [REDACTED] ran to tell his mother and they returned to his sister's room and looked out the window. After looking out the window, [REDACTED] saw police officers putting up yellow cordon tape.

AGENT KELLY also spoke with [REDACTED], who stated she had been in her bedroom on the front, south west corner of the house, when she heard several gunshots that sounded like they were right outside of her window. [REDACTED] peeked out the window, but did not see anyone running at that time. [REDACTED] then went to get her mother and returned and looked out the window again and saw several vehicles operating blue police lights.

AGENT KELLY noted that he and GBI SPECIAL AGENT WILL IVEY had previously spoken to RANDY KIMBREL, the Vice-President, and Chief Security Officer for the bank. KIMBREL had shown AGENTS KELLY and IVEY video from the night deposit window located on the north side of the bank. The camera showed the area near where the shooting occurred, but North Satilla Street was in the extreme top edge of the frame. AGENTS KELLY and IVEY noted a white female in a red tee shirt using the night deposit window in the bank's drive-through lane around the time of the shooting. The lights from several emergency vehicles were visible, and several officers could be seen walking in and out the camera frame. The shooting was not visible from that location. AGENT IVEY previously requested that KIMBREL provide a copy of that video from the aforementioned camera from approximately 10:30 p.m. to 11:15 p.m. on June 20, 2018.

AGENT KELLY met with Senior Vice-President WILLIS KEENE. AGENT KELLY gave KEENE the original of the attached bank records request letter. KEENE

provided AGENT KELLY with a San Disk Cruzer Glide 16GB flash media storage drive which he stated contained the video that AGENT IVEY previously requested. Additionally, the letter contained a request for information about any account for which night deposits were made on the evening of June 20, 2018 and the early morning of June 21, 2018, and contact information for those account holders. AGENT KELLY hoped to use that information to identify the white female depicted in the aforementioned video. AGENT KELLY explained his further request for records to KEENE, who advised that he would forward it to the appropriate parties at the bank to be fulfilled.

AGENT KELLY subsequently reviewed the video, and he noted that it began at 10:46:31 p.m. on June 20, 2018. AGENT KELLY noted that the vehicle driven by the white female could be seen in the upper corner of the frame leaving the area and there were already blue lights from police cars visible on the top of the frame. AGENT KELLY noted that this was after the video previously reviewed by AGENTS KELLY and IVEY. AGENT KELLY subsequently left a message for KEENE and KIMBREL requesting the additional video footage. The remainder of the video showed various emergency vehicle responses. SA KARNES made the following observations and notations.

The vehicle is a white in color, 4-door, Chrysler Pacifica, displaying Georgia Tag # RLH 6181. SA KARNES photographed the exterior and interior of the vehicle using a Nikon D800 digital camera. The photographs are attached to this summary. SA KARNES notes the presence of red evidence tape over each of the doors and trunk lid. The tape had been put in place by SA KARNES on the driver's side rear door, trunk, passenger side rear door, and passenger front door when the vehicle was located at the corner of Lilly and N. East Streets in Kingsland, Camden County, Georgia, on Thursday, June 21, 2018. The tape was placed by this Agent prior to the vehicle being removed from the area. Tape was placed on the driver's side door by Region 14 SPECIAL AGENT IN CHARGE STACY CARSON after the vehicle arrived at the Region 14 crime scene bay for secure storage on June 21. The

purpose of the tape being placed on the driver's door at the time and not earlier, was to allow access to the steering wheel to maneuver the vehicle into the bay.

SA KARNES placed GBI Evidence Property Tag # AA94600 on the driver's side exterior window. SA KARNES observed that the driver's side rear passenger window was down, as well as the front passenger door window. SA KARNES observed damage to the front passenger corner of the vehicle at the bumper and also in the area of the front grille.

A fifty dollar bill (\$50.00) and a one hundred dollar bill (\$100.00) were each located in the driver's side door pocket. SA KARNES collected the bills and labeled them with GBI Evidence Property Tag # AA94583. The bills were placed in GBI Evidence Block Bag # BBB025381. The driver's side door pocket additionally contained a folding knife, Winterfresh gum pack, brush, wrenches, and a fragrance bottle. A charging cord, comb, and hair pick were each located in the driver's floorboard.

The dash console area contained a "CT Tek" device, apparent plug in radio, sunglasses, a Flash Foods Reward Card, and a charging cord. The center console contained assorted CD'S and CD cases. A bottle of "Wig Shine" spray was located in the driver's side rear passenger seat. The driver's side rear floorboard contained (2) red cups, a charging cord, and an empty water bottle.

The trunk contained a black bag with assorted clothing inside, a box with assorted papers and pencils, a second black bag with clothing inside, shoes, a gray in color art box, and jumper cables. The passenger side rear seat floorboard contained a black bag with (3) packs of Maruchan noodles, a charging cord, drinking glass, and a lighter was located under the rear passenger seat. The passenger rear door

pocket contained a small child's toy, bottle cap, and an Advance Auto receipt dated 6/5/2018. The passenger seat rear pocket contained a small roll of tape, OFF Brand bug spray, an empty identification holder, fragrance spray, a spoon, pen, and assorted papers.

The front passenger door pocket contained a black marker, fork and spoon, a charging cord, and a funeral notice for [REDACTED]. The front passenger seat floorboard contained a small bottle of fingernail polish, half of a blue knife handle, cell phone, and a Newport Brand cigarette box containing cigarettes. SA KARNES collected the knife handle and labeled it with GBI Evidence Property Tag # AA94527. SA KARNES collected the cell phone and labeled it with GBI Evidence Property Tag # AA94586. SA KARNES collected the Newport cigarette box and cigarettes and labeled them with GBI Evidence Property Tag # AA94526.

SA KARNES swabbed the front passenger window sill. The swabs were labeled with GBI Evidence Property Tag # AA94524. SA KARNES swabbed the external front passenger door handle. The swabs were labeled with GBI Evidence Property Tag # AA94522. SA KARNES swabbed the front passenger interior window button. The swabs were labeled with GBI Evidence Property Tag # AA94520. SA KARNES swabbed the front passenger interior door handle. The swabs were labeled with GBI Evidence Property Tag # AA94492. SA KARNES swabbed the front passenger seat arm rest. The swabs were labeled with GBI Evidence Property Tag # AA94579. SA KARNES notes the afore mentioned swabs were collected for the possible submission for DNA analysis.

SA KARNES visually inspected the exterior passenger side doors for the presence of fingerprints. SA KARNES utilized oblique lighting during this effort. No fingerprints

appeared visible. SA KARNES applied black fingerprint powder to the front and rear exterior passenger doors on the white vehicle surfaces, as well as the passenger side mirror. The results were negative for the presence of identifiable fingerprints. SA KARNES applied silver fingerprint powder in the area of both passenger side doors on the black in color door surfaces. The results were negative for the presence of identifiable fingerprints.

A copy of the consent to search form was left on the driver's seat. SA KARNES replaced red evidence tape over each of the vehicle doors and trunk. SA KARNES initialed the tape and placed the date of the tape on each tape strip. The examination of this vehicle and contents was completed at approximately 3:20 p.m. On Monday, July 23, 2018, SPECIAL AGENT JOSH ELLIS, who is a GBI Crime Scene Program Technical Leader (TL) performed a peer review of this crime scene summary.

On Monday, June 25, 2018, at approximately 11:21 a.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed Camden County Fire Department LIEUTENANT JAMES BROWN. AGENT IVEY initiated this interview with BROWN for the purpose of obtaining information relevant to an Officer Involved Use of Force incident in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN.

BROWN essentially related the following information:

He responded to the scene in which GREEN was shot on the evening of June 20, 2018; however, he does not recall the exact time. Upon his arrival, North Satilla Street was blocked off by law enforcement vehicles. He observed an officer laying on the ground on North Satilla Street. He went to check on the officer, but was redirected to go attend to TONY GREEN. Upon his first observation of GREEN, GREEN was laying on his back. He observed a gunshot wound to the left pectoral area of GREEN. He checked GREEN'S pulse and respirations. At this time, GREEN had no pulse and was not breathing. He then applied an EKG monitor to the body of TONY GREEN. He stated that GREEN had pulseless electrical activity according to the EKG monitor. Treatment provided to GREEN was in the form of CPR, intubation, and administration of Epinephrine.

No evidence was taken by BROWN or any other emergency medical personnel. He did not observe any signs of pepper spray on or about the body of TONY GREEN.

During his observation and treatment of GREEN, GREEN was not restrained.

This interview was concluded on the same date at approximately 11:30 a.m.

On Monday, June 25, 2018, at approximately 12:00 p.m., ASAC RICHARD DIAL was located at the GBI Region 14 Field Office in Kingsland, Camden County, Georgia, for the purpose of reviewing body camera footage from a body camera that was worn by ZECHARIAH MARK PRESLEY on the evening of June 20, 2018 at the time of the officer involved fatal shooting of ANTHONY MARCELL GREEN.

AGENT DIAL conducted a review of the body camera footage designated with the name ZECHARIAH PRESLEY. AGENT DIAL notes that the video was 15 minutes and 29 seconds in length. AGENT DIAL notes that a copy of this video is attached and made a part of this case file.

AGENT DIAL notes that the video begins with an apparent foot pursuit conducted by ZECHARIAH PRESLEY involving the chase of a black male subject wearing a light-colored tee shirt. AGENT DIAL notes that during the foot pursuit, a red dot laser is observed swinging in and out of the camera view. AGENT DIAL notes that this red dot laser mark is consistent with the laser on a taser device. AGENT DIAL notes that during the foot pursuit, OFFICER PRESLEY makes a verbal statement, presumably over the radio, that he was "on Williams coming to 17." AGENT DIAL notes that this statement was made at approximately six seconds into the video.

AGENT DIAL notes that approximately ten seconds into the video, OFFICER PRESLEY is heard making the statement, "You're gonna get tased."

AGENT DIAL notes that approximately eleven seconds into the video, OFFICER

PRESLEY makes a statement, "Here it comes."

AGENT DIAL notes that the video shows a foot pursuit continuing until approximately 38 seconds into the video. AGENT DIAL notes that at that point in the video, the back of a black male subject is briefly illuminated and the sound of an activated taser is heard. AGENT DIAL notes that the black male subject appears to stop and his right hand is visible, held up in the air. AGENT DIAL notes that the taser cycle continues, and the black male subject is observed crouching on the ground with his face briefly illuminated by a light source. AGENT DIAL notes that as the black male subject is crouched down, his right arm is, again, visible to the camera. AGENT DIAL notes that a frame-by-frame analysis of this section of the video reveals that a light source, consistent with the illuminated screen of a cellular phone, is observed in the subject's hand. AGENT DIAL notes that due to the movement of the video, it could not be determined if the cellular phone was in the subject's right or left hand.

AGENT DIAL notes that as the subject is crouched down on the ground, there appears to be significant movement with the video camera. AGENT DIAL notes that at one point, a dark-colored cloth appears to cover the camera lens.

AGENT DIAL notes that approximately 42 seconds into the video, a clear picture of the illuminated cellular phone held by the subject's left hand is depicted in the camera lens. AGENT DIAL notes that the camera lens is extremely close to this cellular phone and visible in this frame is a taser with the amber-colored rear read-out of the taser clearly illuminated. AGENT DIAL notes that both the left hand holding the cellular phone and the illuminated Taser were in close proximity into the camera. AGENT DIAL notes that the Taser appears to be in a white male's right

hand, which appears to be in close proximity to a light-colored cloth shirt from which a dark-colored arm is visible emerging. AGENT DIAL notes this dark-colored arm is the appendage that is holding the illuminated cellular phone. AGENT DIAL notes that the cellular phone remains visible, but there is a large amount of movement on the camera. AGENT DIAL notes that at this point, the orientation of the camera to the visible light source changes dramatically. AGENT DIAL notes that at approximately 46 seconds into the video, the upper section of a cellular phone is extremely close to the camera lens. AGENT DIAL notes that this cellular phone depicts a string of Emoji's along the top line as well as the numbers,"9700", clearly visible.

AGENT DIAL notes that approximately 48 seconds into the video, a light-shirted individual appears to be running from the bottom right corner of the camera to the upper left corner of the camera. AGENT DIAL notes this light-shirted individual is illuminated by a cellular phone. AGENT DIAL notes this subject appears to be moving away. AGENT DIAL notes that once the subject goes off-screen, a hand holding a cellular phone is held down towards the camera.

AGENT DIAL notes that at this point in the video, the motion of the camera appears to settle. AGENT DIAL notes that the camera then rocks at approximately 49 seconds from the left to the right.

AGENT DIAL notes that clearly visible in the camera is the bank and buildings located directly behind the bank. AGENT DIAL notes that approximately 51 seconds into the video, the camera turns back north and a light, consistent with the illuminated screen of a cellular phone, is seen a distance from the camera. AGENT DIAL notes that approximately 53 seconds into the video, there is a gunshot.

AGENT DIAL notes that several more gunshots are observed in the camera at this time. AGENT DIAL notes the last of the visible indication that the suspect was in close proximity to the officer was at approximately 48 seconds into the video. AGENT DIAL notes that at this point, the cellular phone is pointing towards the officer and the video captures the cellular phone retreating.

AGENT DIAL notes that there were no verbal commands during the apparent physical encounter between ZECHARIAH PRESLEY and GREEN. AGENT DIAL notes that there were no verbal commands, other than the tasing commands previously detailed, prior to OFFICER PRESLEY firing his weapon.

AGENT DIAL notes that the audio of the camera captured the sound of numerous discharges which appeared to come from OFFICER PRESLEY'S weapon. AGENT DIAL notes that the video only captures a few of the muzzle flashes, but their location was consistent with coming from PRESLEY'S weapon.

AGENT DIAL notes that approximately one minute and two seconds into the video, OFFICER PRESLEY is heard yelling, "I need help." AGENT DIAL notes that approximately one minute and 17 seconds into the video, OFFICER PRESLEY radios in that shots had been fired.

AGENT DIAL notes that approximately one minute and 24 seconds into the video, OFFICER PRESLEY radios out that he has "One subject down." AGENT DIAL notes that approximately one minute and 30 seconds into the video, OFFICER PRESLEY vocalized the instruction to, "Put your hands out."

AGENT DIAL notes that approximately one minute and 48 seconds into the video,

OFFICER PRESLEY issues the command, "Stay still man." AGENT DIAL notes that at this time, OFFICER PRESLEY made the statement, "I've got help coming."

AGENT DIAL notes that after the shooting, there were numerous requests for OFFICER PRESLEY to provide his location. AGENT DIAL notes that OFFICER PRESLEY continued to provide more information concerning his location. AGENT DIAL notes that approximately two minutes and 36 seconds into the video, OFFICER PRESLEY is heard giving the instruction to, "Keep your hands out."

AGENT DIAL notes that approximately two minutes and 46 seconds into the video, blue emergency lights are observed on the camera.

AGENT DIAL notes that approximately two minutes 52 seconds into the video, it is observed that OFFICER PRESLEY'S left hand appears to be held up in an upward gesture near his forehead and in his right hand, there appears to be an un-holstered pistol.

AGENT DIAL notes that the video depicts the first officer arriving as Kingsland Police Department OFFICER GREEN. AGENT DIAL notes that OFFICER PRESLEY immediately requests to sit in OFFICER GREEN'S car. AGENT DIAL notes that OFFICER PRESLEY then informs OFFICER GREEN that there is another subject in the area. AGENT DIAL notes that at approximately three minutes and four seconds into the video, the body of a black male laying on the ground is briefly illuminated by OFFICER GREEN'S flashlight.

AGENT DIAL notes that approximately three minutes and 22 seconds into the video, OFFICER PRESLEY is overheard telling OFFICER GREEN that he lost his taser

and “he got on top of me and started hitting me.”

AGENT DIAL notes that approximately three minutes and 34 seconds into the video, OFFICER GREEN is overheard asking OFFICER PRESLEY if he [OFFICER PRESLEY] was okay. OFFICER PRESLEY stated that his “head hurts so bad.”

AGENT DIAL notes that approximately three minutes and 50 seconds into the video, OFFICER PRESLEY informed OFFICER GREEN that he has to lay down. OFFICER PRESLEY then lays down on the roadway.

AGENT DIAL notes that approximately four minutes and 53 seconds into the video, OFFICER PRESLEY makes the statement that he was “so dizzy.”

AGENT DIAL notes that approximately four minutes 57 seconds into the video, OFFICER PRESLEY makes the statement that “I don’t know if he hit me or what, but I tased myself.” OFFICER PRESLEY then states, “He was on top of me, I tried to tase him, and my radio, I lost it and couldn’t find it.”

AGENT DIAL notes that approximately five minutes and 30 seconds into the video, OFFICER PRESLEY asks OFFICER GREEN if his head was okay. OFFICER PRESLEY states that he has the worst headache of his life.

AGENT DIAL notes that approximately five minutes and 59 seconds into the video, a Kingsland Police Department Officer asks OFFICER PRESLEY if he was injured. OFFICER PRESLEY responds that “I don’t know, my head hurts so bad.”

AGENT DIAL notes that approximately six minutes and 27 seconds into the video,

LIEUTENANT LEE comes over and asks OFFICER PRESLEY if he was injured. AGENT DIAL notes that OFFICER PRESLEY states, "It's my head, it's excruciating. I don't know what happened." OFFICER PRESLEY then states, "I got on him, and then he kind of got on me." OFFICER PRESLEY then states, "He was grabbing at my taser and I kind of tased myself in my arm I think." OFFICER PRESLEY then states, "I was going for my gun, he started taking off, and I fired."

AGENT DIAL notes that approximately seven minutes and 52 seconds into the video, a Kingsland Police Department Officer asks OFFICER PRESLEY if he was okay. AGENT DIAL notes that OFFICER PRESLEY emotionally responds, "It happened so fast."

AGENT DIAL notes that approximately eight minutes and 45 seconds into the video, OFFICER PRESLEY asks if GREEN (the shot subject) was, "okay." OFFICER PRESLEY then states that he thought GREEN was going to kill him. OFFICER PRESLEY again states that GREEN was on top of him.

AGENT DIAL notes that approximately nine minutes and 32 seconds into the video, OFFICER PRESLEY asks if his camera was on.

AGENT DIAL notes that approximately nine minutes and 36 seconds into the video, OFFICER PRESLEY is answering questions concerning his physical condition. OFFICER PRESLEY states that his head hurt. OFFICER PRESLEY then states he doesn't know if GREEN hit him or if he hit his head while he was running. OFFICER PRESLEY was then asked where he got hit at. OFFICER PRESLEY stated that he did not know, "He was kind of on top of me." OFFICER PRESLEY was then asked if he got hit in the "face or anything". OFFICER PRESLEY states that he did not

know, that it “happened so fast.”

AGENT DIAL notes that approximately nine minutes and 58 seconds into the video, OFFICER PRESLEY makes the statement that he thought GREEN was driving on a suspended license, and that he went to get in behind him and GREEN took off at about 55 miles per hour. OFFICER PRESLEY then states that “they hopped out.” OFFICER PRESLEY then states that he started chasing them.

AGENT DIAL notes that approximately 11 minutes and nine seconds into the video, LIEUTENANT BILL LEE asks OFFICER PRESLEY if he ever saw a gun on GREEN. OFFICER PRESLEY then stated that he had GREEN by the neck and then GREEN “rolled me over.” PRESLEY states that GREEN was then on top of him. PRESLEY states, “That’s when I started reaching for my gun and he took off.” OFFICER PRESLEY then stated, “That’s when I fired.”

AGENT DIAL notes that approximately 14 minutes and 30 seconds into the video, OFFICER PRESLEY indicates he wants to take his “stuff” off because he feels constricted.

AGENT DIAL notes that approximately 15 minutes and 7 seconds into the video, a voice is heard telling OFFICER PRESLEY that he was going to go ahead and take his weapon.

AGENT DIAL notes that LIEUTENANT SEAWARD was then observed taking OFFICER PRESLEY’S duty belt along with his body-worn camera. LIEUTENANT SEAWARD then informs LIEUTENANT LEE that he was turning off the body worn camera.

AGENT DIAL notes this review of the video included a frame-by-frame analysis of the events directly leading up to the shooting. AGENT DIAL notes that several still captures were taken of parts of this video. AGENT DIAL notes that the screen captures are attached and made part of this case file.

She did not note specifically the entrance and exit wounds of the projectiles that entered TONY'S body. She did not prescribe any medication to TONY.

She did not receive any statements made by TONY, nor did she have any contact with OFFICER PRESLEY. TONY'S body had no signs of pepper spray on or about him. She stated that she did not seize any evidence from the person of TONY GREEN. She stated that upon TONY'S arrival, he had no vital signs, a very weak pulse, and was intubated.

This interview was concluded on the same date at approximately 12:40 p.m.

On Monday, June 25, 2018, at approximately 1:54 p.m., GBI Region 14 Special Agent WILL IVEY was located in Camden County, Kingsland, Georgia, at the Kingsland Police Department. While at this location, Agent IVEY and Agent JAMES FELLER reviewed the personnel file for Kingsland Police Officer ZECHARIAH PRESLEY. This investigative activity was conducted pursuant to an officer involved use of force investigation, in which PRESLEY shot and killed TONY GREEN.

Agent IVEY notes the following information pertaining to PRESLEY'S personnel file:

PRESLEY was hired by the Kingsland Police Department on June 1, 2017. He completed his field training program during December of 2017. His assigned Field Training Officer, VICTOR REED, noted that PRESLEY had performance issues related to properly communicating over the radio. During his field training, PRESLEY failed a written exam which mostly pertained to radio codes and the geographic layout of the city of Kingsland.

On April 12, 2018, TORONCE JONES filed a written complaint against PRESLEY and Officer BRANDON TODD, alleging that the two were harassing him. Contained within his personnel file was written documentation that PRESLEY had transported a suicidal subject from a Doctor's Office to the Hospital. PRESLEY did not check the female subject for weapons, and a handgun was found in her purse by hospital staff. On January 29, 2018, Lt. RICHARD SAPP with the Kingsland Police Department met with PRESLEY to discuss policy violations related to PRESLEY pursuing a reckless driver while PRESLEY was off duty, according to the documentation,

PRESLEY followed a car at a speed in excess of 100 miles per hour, while PRESLEY was off duty, and in his personally owned vehicle.

Kingsland Police Department SGT. SEAN RAFFERTY noted in an Employee Performance Review (EPR) that PRESLEY needed improvement in his decision making and judgment abilities. RAFFERTY noted that PRESLEY needed to exercise better judgment on and off duty, and that he had made some poor choices in the past year. This EPR was for the time frame of June 1, 2017 to March 1, 2018. There was also a letter noting that PRESLEY was suspended without pay for one day from City Manager LEE SPELL. This suspension was for the above-mentioned incident in which PRESLEY did not properly search a female that he transported to the hospital.

On Monday, June 25, 2018, at approximately 2:00 p.m., ASAC RICHARD DIAL was located at the GBI Region 14 Field Office in Kingsland, Camden County, Georgia, for the purpose of reviewing body camera footage from Kingsland Police Department OFFICE BRYAN "BYRON" GREEN'S body camera in reference to the ongoing investigation into the death of ANTHONY MARCELL GREEN during an Officer Use of Force Incident.

AGENT DIAL notes that the video viewed was labeled, "BryanGreen", and is attached and made part of this case file. AGENT DIAL notes this video depicts OFFICER GREEN'S arrival at a darkened scene. AGENT DIAL notes that this video initially depicts OFFICER GREEN getting out of his patrol vehicle and observing a white male dressed in a Kingsland Police Department uniform, identified as OFFICER ZECHARIAH PRESLEY. AGENT DIAL notes this officer appeared to be holstering a pistol with his right hand. AGENT DIAL notes that to the right of OFFICER PRESLEY is the body of a black male subject, identified as ANTHONY MARCELL GREEN. AGENT DIAL notes that the video depicts GREEN as laying on his back with both arms raised to head level. AGENT DIAL notes that in GREEN'S right hand is a non-illuminated cellular phone. AGENT DIAL notes that GREEN is seen wearing a light-colored shirt, and black and red shorts. AGENT DIAL notes this video contains video of other officers arriving on scene and the initial law enforcement response.

AGENT DIAL notes this video also depicts ZECHARIAH PRESLEY taking a seat in OFFICER GREEN'S patrol vehicle, and visual indicators indicated that ZECHARIAH

PRESLEY'S body camera was recording. AGENT DIAL notes that after sitting in OFFICER GREEN'S vehicle for a short time, OFFICER PRESLEY gets out of the vehicle and lays down in the roadway. AGENT DIAL notes that this video provides a view of OFFICER PRESLEY'S back, which depicts dirt along PRESLEY'S right shoulder blade. AGENT DIAL notes that the uniform did not appear beaten, torn, or in disarray.

AGENT DIAL notes that throughout the video, the depiction of ZECHARIAH PRESLEY fails to show any injury or marks, other than the dirt on the rear right shoulder blade, on PRESLEY.

AGENT DIAL notes this video also captures various statements made by OFFICER PRESLEY concerning the incident. AGENT DIAL notes these statements are consistent with the previous heard statements documented on ZECHARIAH PRESLEY'S body camera video. AGENT DIAL notes this video was viewed in a previous investigative summary.

AGENT DIAL notes that the still-frame captures of this video were taken by AGENT DIAL. AGENT DIAL notes that these video captures are attached and made part of this case file.

On Monday, June 25, 2018, at approximately 2:02 p.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY conducted an interview with Kingsland Fire Department Emergency Medical Technician (EMT) RACHEL BENOIT. AGENT IVEY initiated this interview with BENOIT for the purpose of obtaining information relevant to an Officer Involved Use of Force incident, in which Kingsland Police Department Officer, ZECHARIAH PRESLEY, shot and killed TONY GREEN.

BENOIT essentially related the following information:

She arrived on the scene of the above-mentioned incident at approximately 10:45 p.m., on June 20, 2018. She specifically arrived on North Satilla Street between the TDS building and the Pineland Bank building. She retrieved a stretcher from the back of the ambulance and initially went to go attend to OFFICER PRESLEY; however, she was re-directed to attend to TONY GREEN. She assisted with GREEN by loading him onto a stretcher and placing him in the back of the ambulance. She observed that GREEN had what appeared to be gunshot entrance wounds to his hip and chest. During this time, she had no contact with OFFICER PRESLEY.

TONY GREEN was not restrained in any manner, and he did not make any statements to her due to him being unresponsive. OFFICER PRESLEY also did not make any statements to her.

She stated that a mobile phone was in GREEN'S hand. Kingsland Fire Department, CHIEF TERRY SMITH, took the phone from GREEN'S hand and put it into a latex glove, and turned it over to Camden County Coroner, JAMES GALLOWAY. Treatment provided to GREEN was in the form of CPR and intravenous fluids. She did not witness all of the treatment that was provided to GREEN due to her driving the ambulance to the hospital. TONY GREEN was transported to Camden Medical Center in St. Mary's, Georgia. She did not seize any evidence from this incident. She was not aware of any pepper spray on or about the body of TONY GREEN.

On Tuesday, June 26, 2018 at approximately 09:30 a.m., Georgia Bureau of Investigation (GBI) SPECIAL AGENT LAWRENCE KELLY was at the GBI Region 14 Field Office, located at 111 North Gross Road, Kingsland, Camden County, Georgia. AGENT KELLY met with GBI ASSISTANT SPECIAL AGENT IN CHARGE (ASAC) RICHARD DIAL. ASAC DIAL requested that AGENT KELLY perform a mobile device data extraction on a cellular telephone pursuant to the ongoing investigation of the officer-involved shooting of ANTHONY MARCELL GREEN by Kingsland Police Department (KPD) OFFICER ZECHARIAH MARK PRESLEY, on June 20, 2018.

AGENT KELLY performed the extraction pursuant to a search warrant issued in the Magistrate Court of Camden County. GBI SPECIAL AGENT WILL IVEY advised AGENT KELLY and ASAC DIAL that the search warrant was signed by the Honorable JENNIFER LEWIS, Chief Judge of the Magistrate Court of Camden County, at approximately 9:30 a.m., AGENT IVEY will document and attach that search warrant separately.

ASAC DIAL gave AGENT KELLY a sealed package containing the aforementioned cellular telephone. ASAC DIAL had previously marked the package containing the cellular telephone by affixing GBI Evidence/Property Tag AA94401 thereto. AGENT KELLY linked the records associated with GBI Evidence/Property Tag AA94401 to this summary.

AGENT KELLY removed the cellular telephone from the sealed package, and he

noted that the battery was dead. AGENT KELLY charged the cellular telephone's battery, and he restarted the device once it was sufficiently charged.

AGENT KELLY photographed the packaging and the cellular telephone, and he attached those photographs hereto. AGENT KELLY noted that the cellular telephone was a Google Pixel, model G-2PW2100-021-A, encased in a black and gold colored metal protective case bearing the words "KATE SPADE." AGENT KELLY removed the case, and he noted that the cellular telephone bore a sticker with the model number, international mobile equipment identifier (IMEI) [REDACTED] and serial number (S/N) [REDACTED]. Graphic and alphanumeric indicators on the cellular telephone's home screen showed that it had cellular service from "Verizon Wireless."

AGENT KELLY used a Cellebrite UFED Touch II device to attempt mobile device data extractions from the cellular telephone pursuant to a search warrant issued in the Magistrate Court of Camden County. AGENT KELLY was unable to perform any data extractions from the cellular telephone because it was encrypted and locked with a passcode, which AGENT KELLY did not know. The passcode used an alpha numeric keypad for entry. There were two user profiles stored on the cellular telephone. One of the profiles was labeled "BILLY" and the other was labeled "TONY." AGENT KELLY attempted two possible passcodes based on information known to him about the case, but neither unlocked the cellular telephone.

GBI Region 14 Assistant Special Agent-in-Charge (ASAC) RICHARD DIAL spoke with GREEN'S family to attempt to determine the passcode, but no one in GREEN'S family knew the passcode.

AGENT KELLY and GBI SPECIAL AGENT NIKLAUS ANTCZAK went to the Sunset Funeral Home, located at 401 North Lee Street, Kingsland, Georgia in Camden County where GREEN'S body was being prepared for burial. With permission from GREEN'S next of kin, AGENTS KELLY and ANTCZAK attempted to use GREEN'S fingerprints to unlock the cellular telephone. Each time the agents placed one of GREEN'S fingertips on the fingerprint reader on the rear of the cellular telephone the device vibrated and displayed the message, "Passcode Required on Restart."

AGENT KELLY determined that there was a subscriber identity module (SIM) installed in the cellular telephone but no external media storage device. AGENT KELLY removed the SIM, photographed it, and used a Cellebrite UFED Touch II device to perform SIM data and file system extractions from it. The SIM was white with the Verizon Wireless 4G LTE logotype printed on it. The SIM bore integrated circuit card identifier (ICCID) 89148000003346753069. AGENT KELLY was familiar with the arrangement of the ICCID and he noted that 89 signified that the SIM was used for telecommunication services, and the 1 indicated that it was issued to a provider in the United States. AGENT KELLY knew from experience that 4800 identified the service provider as Cellco Partnership, LLP d/b/a Verizon Wireless. The remaining numbers were a sequential number by which Cellco Partnership; LLP d/b/a Verizon Wireless could identify the account to which the SIM was allocated and a check digit, respectively.

The Cellebrite extractions revealed that the international mobile subscriber identifier (IMSI) associated with the SIM was 311480343072902, and it confirmed the ICCID as 89148000003346753069. The SIM data also defined the SIM's mobile station international subscriber directory number (MSISDN) as +17313779498. The MSISDN is a number used to identify a mobile telephone internationally. The

MSISDN includes a country code and a National Destination Code, which in this case was 1 for a number issued in the United States and area code 731. Area code 731 covers West Tennessee, excluding the greater Memphis area. The remaining seven digits identify the particular number used for routing calls to the subscriber. AGENT KELLY noted that the MSISDN is sometimes synonymous with the cellular telephone number assigned to the SIM, but that is not always true because service providers can assign new cellular telephone numbers to SIMs used by existing subscribers.

AGENT KELLY subsequently used Cellebrite Physical Analyzer software to combine the SIM Data and SIM File System Extractions into a single project. AGENT KELLY produced a reports package containing reports of all data extracted from the SIM in both portable document format (PDF) and Cellebrite's proprietary format. AGENT KELLY produced an executable copy of Cellebrite's UFED Reader software at the same to time. AGENT KELLY noted that one could use Cellebrite's UFED Reader software to view the reports in Cellebrite's proprietary format.

AGENT KELLY compressed the folders containing the SIM data extractions and the reports into separate .zip files using 7-Zip version 7.65, and he attached those .zip files hereto.

On Tuesday, June 26, 2018, at approximately 1:10 p.m., GBI Region 14 SPECIAL AGENT WILL IVEY was located in Camden County, Kingsland, Georgia. While at this location, AGENT IVEY interviewed [REDACTED] JONES for the purpose of obtaining information relevant to an Officer Involved Use of Force incident, in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN.

JONES essentially related the following information:

Approximately two and a half months ago, TONY came to his house and was visibly upset. TONY informed him that OFFICER PRESLEY was threatening him when they had contact at the Springfield Hotel in Kingsland, Georgia. According to JONES, TONY was involved in an altercation with another subject at the Springfield Hotel, and OFFICER PRESLEY responded to the scene. JONES stated that he has called the Kingsland Police Department CHIEF DARYL GRIFFIS to make complaints about Kingsland Police Officers, BRANDON TODD and ZECHARIAH PRESLEY. He has also spoken with the City of Kingsland's MAYOR KENNETH SMITH.

JONES and TONY both obtained Complaint Forms from the Kingsland Police Department. JONES' brother, told Kingsland Police Department LIEUTENANT BILL LEE about the complaints that he and TONY were going to file. LIEUTENANT LEE then approached TONY and offered to handle the situation with OFFICERS TODD and PRESLEY. LIEUTENANT LEE told him that it would be best if he handled it,

because CHIEF GRIFFIS would not do anything to handle the situation. At this point, he and TONY decided to let LIEUTENANT LEE handle their complaints.

JONES also informed AGENT IVEY, several months before the incident in which TONY was shot by OFFICER PRESLEY, that OFFICER PRESLEY and OFFICER TODD were riding together in a patrol car and stopped his girlfriend, ANGELICA [REDACTED]. Afterwards, JONES flagged OFFICER TODD and OFFICER PRESLEY down. They then performed a U-Turn in the road and got behind his vehicle and stopped him by the Tire Mart in Kingsland, Georgia. JONES accused them both of stalking him. PRESLEY became very irate towards him, so he then requested that PRESLEY'S Sergeant respond to the traffic stop. SERGEANT SHAUN RAFFORDY then responded and JONES spoke with him about his issues with OFFICERS TODD and PRESLEY. After this incident, he filed a Complaint Report with the Kingsland Police Department. He stated that he has been pulled over by OFFICER TODD multiple times, and that OFFICERS TODD and PRESLEY both constantly ride past his residence. JONES also informed AGENT IVEY that a friend of his, KAITLYN KIMBALL, was asked by OFFICER TODD if he was a "shit-head." He stated that OFFICER TODD also told TONY that he was going to come after JONES.

The day after he filed his complaint against OFFICER PRESLEY with the Kingsland Police Department, PRESLEY was parked out in front of his residence. He then approached PRESLEY and confronted him about him being parked out in front of his house. According to JONES, he told PRESLEY that he would "whip his ass before he violated his Constitutional Rights." He informed AGENT IVEY that he has also put out signs warning people about the Kingsland Police Department having "dirty cops" and has also told people that OFFICERS TODD and PRESLEY harass black people.

On the night that TONY was shot by OFFICER PRESLEY, JONES was at his brother's house located on West Lily Street. He heard the shots from the residence. The passenger who was with TONY the night he was shot, who JONES refused to identify, came to his brother's house and told him that he thought TONY was shot. He stated at the time that he arrived at the scene of the shooting, that TONY'S body had been moved.

He informed AGENT IVEY that his interactions with OFFICERS TODD and PRESLEY occurred from them constantly patrolling the area of North Orange Edwards, and hanging out at the IGA Grocery Store, which is located on South U.S. Highway 17. He stated that both of the officers would see him at the IGA Grocery Store, and then wait until he drove off before they would pull him over. According to JONES, he used to have negative interactions with OFFICER BRANDON TODD'S father, St. Mary's Police Department OFFICER BRAD TODD. He told BRANDON TODD, "Go ask your daddy about me." He believes that BRANDON TODD gave PRESLEY a bad impression about him. He stated that OFFICERS BRANDON TODD and PRESLEY were either always riding together or parked next to one another.

AGENTS ANTCZAK and KELLY were at the above location to locate and interview ERIC DEVON HINES. Multiple sources had identified HINES as the passenger who fled ANTHONY MARCELL GREEN'S car when Kingsland Police Department (KPD) OFFICER ZECHARIAH MARK PRESLEY encountered the vehicle on June 20, 2018. AGENTS ANTCZAK and KELLY sought to interview HINES pursuant to the ongoing investigation of the officer-involved shooting of GREEN by PRESLEY that night.

Upon arrival AGENTS ANTCZAK and KELLY saw HINES at the front door to the residence. As AGENTS ANTCZAK and KELLY approached the mobile home, they were met in the yard by an unidentified black female, who advised that HINES had retained JOHN OSSICK, a local attorney, to represent him. The female added that she and HINES were leaving to go to OSSICK'S office and asked AGENTS ANTCZAK and KELLY to follow.

Upon arrival at OSSICK'S office, located at 230A South Lee Street, Kingsland, Camden County, Georgia. HINES and the female were escorted into the rear of the office. OSSICK soon emerged and he advised AGENTS ANTCZAK and KELLY that he wanted to confer with HINES to determine if HINES would speak to the agents. OSSICK dismissed AGENT KELLY'S suggestion that he and AGENT ANTCZAK could wait until it was determined if HINES would speak to the agents. OSSICK

took the agents contact information, and he advised that he would contact them if HINES wanted to make a statement.

AGENTS ANTCZAK and KELLY concluded the above-described investigative activity at approximately 10:54 a.m.

MILLER responded to a questionnaire sent to him by Agent IVEY, which was in reference to a criminal investigation into an officer involved use of force incident, in which Kingsland Police Officer ZECHARIAH PRESLEY shot and killed TONY GREEN.

Agent IVEY notes the following:

To the question of does PRESLEY possess a P.O.S.T. certification, and what is the status of the certification, MILLER informed Agent IVEY that PRESLEY holds a Basic Law Enforcement certification and a Basic Jailer certification, both in good standing. To the question of has PRESLEY completed the required training for each calendar year since completing the basic course, MILLER responded that PRESLEY had completed such. When asked by Agent IVEY if PRESLEY has power of arrest, MILLER responded that PRESLEY did have power of arrest on the night of the above mentioned incident. MILLER informed Agent IVEY that PRESLEY'S P.O.S.T. record showed either the required training or a waiver issued for each required calendar year. To the question of if PRESLEY'S P.O.S.T. record does not show either the required training, or a waiver issued for each required calendar year, has PRESLEY submitted all required training to P.O.S.T. to be documented on their record, MILLER stated that the question was not applicable in this case. MILLER informed Agent IVEY that there has not been any prior, pending, or active P.O.S.T.

STRAUB initially noticed GREEN having a gunshot wound through his left hand and his left pinky finger missing. GREEN also noticed that GREEN had two gunshot wounds on his left hip, a gunshot wound to his right hip, a gunshot wound to his right buttock, and a gunshot wound to his left chest. STRAUB can not verify entrance or exit wounds. STRAUB noticed what appeared to be stippling or a burnt hole on GREEN's shorts.

On Friday, June 29, 2018, at approximately 5:36 p.m., Georgia Bureau of Investigation (GBI) SPECIAL AGENT LAWRENCE KELLY was at Angelo's Italian Restaurant, located at 1371 Georgia Highway 40 East, Kingsland, Camden County, Georgia. AGENT KELLY was at the above location to interview LISA ██████ pursuant to the ongoing investigation of an officer-involved shooting involving Kingsland Police Department (KPD) OFFICER ZECHARIAH MARK PRESLEY and ANTHONY MARCELL GREEN on June 20, 2018. During the interview, ██████ stated essentially the following:

██████ had made the restaurant's night deposit at the Pineland Bank Branch in Kingsland after Angelo's closed on Wednesday, June 20, 2018. AGENT KELLY noted that the closing time was listed on a sign as 10:00 p.m. ██████ advised that she did not hear or see anything related to the officer involved shooting other than its aftermath. While driving from the restaurant to the bank, ██████ saw two marked KPD patrol cars driving with the emergency blue and red lights activated. Neither patrol car operated an audible siren. One of the patrol cars passed ██████ as she drove westbound on Georgia Highway 40 and the other came toward her from the opposite direction.

When ██████ arrived at the Pineland Bank to make the night deposit, she saw several police cars arrive. ██████ saw a white officer lying on the ground to her right. The officer had his arm up around his head. ██████ mimed holding her arm up so that the top of her forearm was pressed against her forehead. ██████ also saw a black male lying on the ground to her left. ██████ noted that the black male

was not moving. No one was providing aid to the officer or the black male, and no ambulance was present. [REDACTED] could hear the officers talking, but she could not make out what they said.

[REDACTED] had not seen any of the chase, nor had she heard any sirens or gunshots.

[REDACTED] asked if AGENT KELLY had spoken to the heavysset white male who lived on the corner near the shooting. [REDACTED] described the man as a good customer. The man told [REDACTED] that he had seen everything, and there was no altercation between the officer and the subject that was shot.

[REDACTED] was unable to provide any additional pertinent information, so AGENT KELLY concluded the interview at approximately 5:41 p.m.

AGENT KELLY recorded the above-described interview, and he attached that recording hereto. The foregoing text is a summation of information garnered during the interview. For exact phrasing and context, one should consult the recording.

Specifically, AGENT KELLY requested that Cellco Partnership, LLP d/b/a Verizon Wireless preserve records associated with the account to which the device bearing international mobile equipment identifier (IMEI) [REDACTED] and subscriber identity module (SIM) to which the assigned integrated circuit card identifier (ICCID) [REDACTED] and international mobile subscriber identifier (IMSI) [REDACTED]. That account was associated with a Google Pixel, model G-2PW2100-021-A, encased in a black and gold colored metal protective case bearing the words "KATE SPADE," which was recovered from GREEN'S hand. AGENT KELLY requested that records from June 1, 2018 through the date of the request be preserved.

AGENT KELLY concluded the above-described investigative activity at approximately 8:09 p.m.

AGENT KELLY attached the letter, facsimile cover sheet, and transmission report hereto.

AGENT KELLY subsequently received the attached confirmation message and invoice from Cellco Partnership, LLP d/b/a Verizon Wireless. Information on the invoice confirmed that Cellco Partnership, LLP d/b/a Verizon Wireless preserved the requested records. Additionally, information on the invoice confirmed that current telephone number assigned to the account [REDACTED], was the same as the mobile station international subscriber directory number (MSISDN), [REDACTED], that AGENT KELLY recovered from the SIM in GREEN'S cellular telephone. The MSISDN is a number used to identify a mobile telephone internationally. The MSISDN includes a country code and a National Destination Code, which in this case was 1 for a number issued in the United States and area code 731. Area code 731 covers West Tennessee, excluding the greater Memphis area. The remaining seven digits identify the particular number used for routing calls to the subscriber.

AGENT KELLY noted that Cellco Partnership, LLP d/b/a Verizon Wireless assigned Law Enforcement Resource Team (LERT) case number 180157672 to his request.

On Tuesday, July 3, 2018, at approximately 1:38 p.m., Georgia Bureau of Investigation (GBI) SPECIAL AGENT LAWRENCE KELLY and GBI Region 14 Assistant Special Agent in Charge (ASAC) RICHARD DIAL were at 110 East Lilly Street, Kingsland, Camden County, Georgia. AGENT KELLY and ASAC DIAL were at the above location as part of a neighborhood canvass related to the ongoing investigation of an officer-involved shooting involving Kingsland Police Department (KPD) OFFICER ZECHARIAH MARK PRESLEY and ANTHONY MARCELL GREEN on June 20, 2018.

AGENT KELLY and ASAC DIAL spoke with [REDACTED] MARTIN. MARTIN lived in a tent set up on the North Satilla Street side of the property. MARTIN was in his tent when he heard someone yell “get your hands up!” The statement was followed by a single gunshot, a short pause, and then several subsequent quick gunshots. MARTIN estimated that there were approximately three seconds between the statement and the first gunshot. The sound of the gunshots came from the opposite side of a privacy fence on the northeast corner of the property.

Upon hearing the statement, MARTIN began to exit his tent. MARTIN saw a black male, whom he subsequently learned was GREEN, fall and hit the ground. MARTIN saw a white uniformed police officer roll GREEN over and into the road shortly after the gunshots. MARTIN knew the white male was a police officer because he saw the reflection of the officer’s badge on his chest and his holstered gun. It was “obvious” to MARTIN that the white male was a police officer.

MARTIN advised that he never saw a gun in either person's hand. MARTIN noted he believed that if there had been a gun on the ground then the officer would have picked the gun up and made it safe. The officer's gun was holstered when MARTIN first saw him, and it remained so.

GREEN was initially lying face down "all twisted up" with his head near a reflector on the south side of a driveway to the property on which MARTIN lived. MARTIN noted that GREEN'S left shoulder and hip were on the ground as if he fell in midstride. MARTIN did not see if GREEN was standing still or running when he was shot. GREEN'S head faced south, and his feet faced north.

The officer walked up quickly, rolled GREEN onto his back, crouched down, and patted GREEN for weapons, then got up and yelled, "what the Fuck," repeatedly with his arms raised to his head. MARTIN asked the officer if he needed help, and the officer yelled at him to get back into his residence. The officer did not seem injured or hurt.

MARTIN noted that the officer had to be close when he fired the gunshots because it took him very little time to reach GREEN. MARTIN estimated that the officer was near a large tree on the northeast corner of the property. MARTIN noted that the officer came into his view from the North. MARTIN heard sirens approaching immediately after the officer walked away from GREEN.

There was "some stuff" on the ground near GREEN, but MARTIN did not pay that much attention to what it was. MARTIN was certain that there was no weapon. MARTIN saw officers throw items in a dumpster across the street from his residence. MARTIN also saw trash laying on ground after everyone left the area.

MARTIN noted that the officers provided cardio pulmonary resuscitation (CPR) to GREEN. MARTIN agreed that the things the officers threw away could have been medical supplies used to treat GREEN. MARTIN admitted that he did know what it was the officers threw in the dumpster. MARTIN supposed that one of the items near GREEN was a "bottle" or that it could have been dope or crack. MARTIN heard one of the backup officers say, "search the ditch for crack." Officers then walked up and down the ditch with flash lights.

MARTIN heard "hey" just before he heard "get your hands up!" MARTIN did not hear anything else such as sirens or yelling before the shots. MARTIN knew what a taser sounded like from his time as a prisoner at Georgia State Prison, but he did not hear the distinctive sound associated with the device. MARTIN did not see any blue lights before the shooting.

MARTIN knew who GREEN was and the "things he would do" in the neighborhood. MARTIN knew GREEN'S family. MARTIN did not know or recognize the officer, because he had just returned from being gone for four years.

MARTIN noted when asked that a light mounted on the corner of the house at 115 North Satilla Street and a light from the bank across the street lit the area well, so MARTIN could see easily.

MARTIN'S friend, FYRTH "MO" MORRIS, lived in the home on the property, and he was home at the time of the shooting. MORRIS was not outside during the shooting.

On Thursday, July 5, 2018, at approximately 2:24 p.m., GBI Region 14 SPECIAL AGENTS WILL IVEY and RICHARD DIAL were located in Nassau County, Yulee, Florida. While at this location, AGENT IVEY and AGENT DIAL interviewed [REDACTED] LEWIS for the purpose of obtaining information relevant to an Officer Involved Use of Force Incident, in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN. In accordance with Florida Law, prior to beginning the interview, AGENT IVEY informed LEWIS that the interview would be audio recorded.

LEWIS essentially related the following information:

He lived together with TONY at the Springfield Hotel for approximately one year. When asked for clarification on what time frame they lived together, he stated that they lived together from approximately January 2018 to June 2018. TONY had issues with Kingsland Police Department OFFICER ZECHARIAH PRESLEY in the past. PRESLEY had performed a traffic stop on TONY, and TONY had gotten caught with illegal drugs. According to LEWIS, TONY informed him that, OFFICER PRESLEY gave him money to do a controlled purchase of illegal drugs. TONY never performed the controlled purchase for PRESLEY, and kept the money. Later, OFFICER PRESLEY drove by the room in which they lived in the Springfield Hotel, and pointed at TONY and then drove off. Shortly afterwards, PRESLEY pulled TONY over and arrested him for Driving with a Suspended Driver's License.

TONY informed him that he had written a complaint on PRESLEY. On March 12,

2018, three Kingsland Police Department officers were present in his hotel room. The officers searched the room, and told him that the hotel's manager informed them that there were illegal drugs in the room. They then took TONY outside and said that he was not allowed to leave the property because he did not have a driver's license. Afterwards, TONY wrote another complaint because the Kingsland Police Department Officers told him that he was trespassing at the hotel. TONY informed him that he had written three complaints on OFFICER PRESLEY.

TONY also told him that he had previously had negative encounters with an Officer TODD. When questioned by ASAC DIAL as to whether it was BRANDON TODD (Kingsland Police Dept.) , or BRAD TODD (former St. Marys Police Dept.), He stated that he was unsure which one TONY had previous dealings with. However, he stated that TONY informed him that he had negative dealings with Officer TODD in the city limits of St. Marys.

According to LEWIS, a subject by the nickname, "JR" was driving TONY'S white Chrysler Pacifica sporadically. On the night that TONY was shot, LEWIS heard gunshots. At the time he was residing at a residence on Georgia Highway 40, which was located between Russell's Collision Center and the Kingsland Fire Department.

LEWIS informed AGENT IVEY that TRICE MITCHELL, TONY'S ex-girlfriend, may possibly have the access code to TONY'S phone. He also informed AGENT IVEY that TRICE'S sister, SYBIL MITCHELL, works at the Traveler's Inn in Kingsland.

This interview was concluded on the same date at approximately 3:05 p.m.

While at this location, AGENT IVEY interviewed ██████████ BAKER for the purpose of obtaining information relevant to an Officer Involved Use of Force incident, in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN.

BAKER essentially related the following information:

She is involved with a group which is called, Concerned Citizens of Camden County. This group is focused on issues related to the shooting death of TONY GREEN. She stated that she has passed out flyers which pertain to this issue. The flyers that have been passed out have her cell phone listed on them. She received a video text message from an unknown source. The number that sent her the message was (912) ██████████

BAKER displayed the video to AGENT IVEY. AGENT IVEY observed on the video that a Kingsland Police Officer was parked outside the residence of TORONCE JONES. A black male subject, who BAKER identified as JONES' brother who has the alias of "CHOP", was the black male subject in the video. CHOP then approaches the patrol car then parked outside the residence, and a verbal altercation ensues. According to BAKER, this video was taken in March 2018, one day after ██████████ JONES filed a complaint against Kingsland Police Department OFFICERS BRANDON TODD and ZECHARIAH PRESLEY.

BAKER also informed AGENT IVEY that on June 20, 2018, PRESLEY was in a verbal altercation with a black male subject, [REDACTED] LNU. This happened at the Petro Gas Station located off of Highway 40 in Kingsland, Georgia. On Saturday, July 14, 2018, at approximately 10:30 a.m., Georgia Bureau of Investigation (GBI) SPECIAL AGENT LAWRENCE KELLY received the attached responses from Cellco Partnership, LLP d/b/a Verizon Wireless. The responses were sent to AGENT KELLY via electronic mail using Cellco Partnership, LLP d/b/a Verizon Wireless's secure file transfer system. The response packets contained records for two cases including the ongoing investigation of the shooting of ANTHONY MARCELL GREEN by Kingsland Police Department (KPD) OFFICER ZACHARIAH PRESLEY.

AGENT KELLY downloaded the records pertaining to GREEN'S cellular telephone number, [REDACTED], and he attached the compressed files containing those records hereto. The records included communication data and transactional records that listed subscriber information, device information, telephone calls, text messages, , picture message information, and real-time tool ranging data using Cellco Partnership, LLP d/b/a Verizon Wireless's various network types.

AGENT KELLY noted that the subscriber information indicated that Cellco Partnership, LLP d/b/a Verizon Wireless had allocated [REDACTED] to BILLY [REDACTED] since July 18, 2017. AGENT KELLY noted when he attempted a review of the Google Pixel 2 Cellular telephone recovered from near GREEN'S body, he noted two user profiles, GREENS' and a second marked "BILLY." BILLY STEPHENS address of record was [REDACTED]. AGENT KELLY provided the subscriber information to GBI SPECIAL AGENT WILL IVEY, who attempted to contact STEPHENS. AGENT IVEY

AGENT KELLY reviewed the communications records and he noted that there were no voice calls or picture messages between the cellular telephone to which [REDACTED] was allocated and any other party around the time that GREEN was shot. The date and time stamps for the text messages were displayed in "Zulu Time," which corresponded to coordinated universal time (UTC). There was also documentation of PRESLEY leaving an inmate unattended in order to answer a call for assistance from another jailer. This was documented as having occurred on November 28, 2016.

AGENT IVEY notes that he had made previous attempts to contact MITCHELL for the purpose of obtaining information pertinent to the Officer Involved Use of Force incident in which Kingsland Police Department OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN.

MITCHELL essentially related the following information:

When AGENT IVEY asked her if she knew the code to access the phone which was found in TONY GREEN'S possession the night that he was killed, she stated that she did know the phone code. She stated that the phone belonged to her prior to her giving it to GREEN. She informed AGENT IVEY that the swipe code was essentially a backwards "7".

She informed AGENT IVEY that GREEN had talked with her previously about PRESLEY harassing him. She also informed AGENT IVEY that ERIC HINES was a passenger in GREEN'S vehicle the night he was shot. On July 20, 2018, at approximately 6:00 p.m. she received a phone call from GREEN. He told her that he was riding with HINES.

She further informed AGENT IVEY that in March 2018, PRESLEY came to the Travel Lodge Hotel because of a dispute between GREEN and another woman. She

stated that PRESLEY came and was “trying to kick down the door.” When PRESLEY arrived at the Travel Lodge, he stated that he was there because he received a call that she and GREEN were trespassing. However, no one was arrested for Criminal Trespass, and PRESLEY let GREEN go back to his room. During this incident, she was arrested and taken to jail for an outstanding arrest warrant. She also stated that there were occasions where PRESLEY would follow GREEN around the parking lot of the Travel Lodge, and wait until he pulled out, and then follow him. She stated this occurred around the middle of March 2018. She also informed AGENT IVEY that PRESLEY had followed GREEN to a location named, The Oasis, in Yulee, Florida. PRESLEY was off duty when this occurred. She stated this occurred near the end of May 2018. She further stated that a subject, JASON [REDACTED], quit going to The Oasis because of PRESLEY also following him.

GREEN had told her that he had filed complaints with the Kingsland Police Department in reference to PRESLEY. He told her that he filed a complaint against PRESLEY on the Monday before GREEN was shot. She stated that a subject named, [REDACTED] BRYANT, drove him to Woodbine to file the complaints against PRESLEY.

MITCHELL stated that she does have the alpha numeric code which is necessary to access GREEN’S phone. She stated that she would have to obtain that information from her iPad, and that she would contact AGENT IVEY once that information was obtained.

On Thursday, July 26, 2018, at approximately 11:20 A.M., ASSISTANT SPECIAL AGENT IN CHARGE (ASAC) TANYA CALES met with SPECIAL AGENT (SA) WILLIAM IVEY at the Drug Enforcement Administration Office in Savannah, Georgia, for the purpose of conducting a Taser data download related to this investigation. At that time, SA IVEY provided ASAC CALES access to a Taser that previously collected.

ASAC CALES retrieved a Taser X2 bearing serial number X12006Y1P, listed on GBI Evidence Property Tag # AA60119. ASAC CALES conducted a 5 second spark test and the device appeared to be in proper functioning order. After the device was spark tested, the device was connected to a computer with Evidence Sync software installed, and the resulting download report has been attached with this summary (see attached). At the time of download the internal clock of the device was synced from 07-26-2018, 11:24:57 hours to the current time of 07-26-2018, 11:21:10 hours; indicating the clock of the Taser was 3 minutes 47 seconds ahead of the actual time. The time difference should be accounted for when reviewing individual entries on the log. Lines 927 through 932 on the log are from 07-20-2018 (Date in Question) indicated a total of 2 trigger activations (see report for exact detail). ASAC CALES disconnected the device from the computer. After the device was disconnected, it was returned to SA IVEY's custody at approximately 11:30 A. M. The following is a list explaining the terms seen on the attached report.

- Event Column:
  - Armed – means the Taser was turned on;

While at this location, Agent IVEY interviewed [REDACTED] [REDACTED] for the purpose of obtaining information pertinent to an officer involved use of force incident, in which Kingsland Police Officer ZECHARIAH PRESLEY shot and killed TONY GREEN. Prior to beginning the interview, Agent IVEY advised [REDACTED] of his constitutional rights pursuant to the Miranda v. Arizona Supreme Court Decision. After being advised of such, [REDACTED] agreed orally and in writing to being interviewed by Agent IVEY.

[REDACTED] essentially related the following:

He knows that ERIC HINES was present in the vehicle with TONY GREEN the night that GREEN was killed. On the night that GREEN was killed, GREEN had .380 caliber pistol in his possession. He was on the phone with GREEN as GREEN was driving prior to fleeing on foot from PRESLEY. GREEN told him over the phone, that he was being pulled over, and that he was near Russell's Collision Center. GREEN stated to him that, "he had to get the hell outta here." He lost telephonic contact with and tried calling him back several times, and did not receive an answer from GREEN. He was not conversing with GREEN as GREEN was running away on foot from PRESLEY. During his conversation with GREEN, GREEN told him that he had a gun in his possession.

According to [REDACTED], GREEN had the above mentioned firearm for about 1

week. GREEN had "pistol whipped" an unknown individual the day before he was killed. GREEN had the gun on his person as he was running away from PRESLEY.

██████████ stated that GREEN had never discussed anything pertaining to PRESLEY with him. GREEN generally did not like law enforcement.

██████████ stated that he has more information regarding the above mentioned firearm, including the location of it. ██████████ will provide that information if he can be released from jail. He currently has a 20,000 dollar bond, and cannot afford that bond. Agent IVEY informed ██████████ that he would relay that information to the District Attorney's Office.

Agent IVEY asked ██████████ if he new the code to GREEN'S phone. ██████████ made a motion with his hands of a backwards "7". This was referring to the finger swipe motion to access the phone.

This interview was concluded on the same date at approximately 9:00 a.m.

While at this location, AGENT IVEY interviewed ERIC HINES for the purpose of obtaining information relevant to the Officer Involved Use of Force investigation, in which Kingsland Police OFFICER ZECHARIAH PRESLEY shot and killed TONY GREEN. Present during this interview was HINES' Attorney, JOHN OSSICK, and Assistant District Attorneys ROCKY BRIDGES and ROBERT GERMAN.

HINES essentially related the following information:

He was at the Flash Foods Convenience Store in the Five Points area of Kingsland with TONY GREEN just prior to GREEN'S encounter with PRESLEY. HINES stated that he is familiar with who OFFICER PRESLEY is. While he and GREEN were located at the Flash Foods, PRESLEY was staring at them. He stated that PRESLEY never entered the Flash Foods Store. When GREEN exited the store and saw PRESLEY, he came to the vehicle and was visibly shaking and scared. At this time GREEN kept repeating, "I gotta go." According to HINES, PRESLEY arrived at the Flash Foods after he and GREEN did,

GREEN was driving the vehicle that HINES was present in. He does not know how long GREEN had been driving this vehicle. As GREEN backed out of the Flash Foods parking lot, PRESLEY also backed out of the Flash Foods parking lot and followed them onto GA Hwy 40 West. He stated that when GREEN pulled onto Hwy

40, his tires broke traction; therefore, making a screeching sound. He stated that as GREEN was traveling down Hwy 40, he was not driving excessively fast. He was driving approximately 50 mph. GREEN turned right onto North East Street. GREEN continued to repeat "I gotta go." GREEN kept looking back behind him. HINES stated that is what caused GREEN to crash at the intersection of North East and Lilian Streets. During the time that GREEN was driving, he was not talking on the phone with anyone. HINES stated there were five pieces of crack cocaine in the vehicle. He stated that the crack cocaine was left in the vehicle after he and GREEN both fled on foot. According to HINES, there were no firearms present in the vehicle. He further stated that he has never witnessed GREEN being in possession of a firearm.

After the vehicle came to a stop, HINES ran through the woods and then circled back around to his residence. He stated that he did not take anything with him from the vehicle. As he was running, he never heard any firearm discharge sounds, nor did he hear or see anything else. HINES did not interact with anyone while enroute to his residence. He further stated that he was not on the phone when this incident took place. HINES stated that GREEN fled because he was on probation. He is unaware of the status of GREEN'S driver's license. When asked if GREEN has a history of fleeing and eluding from law enforcement, he stated that he has not done that in a long time.

Based upon information received in Summary 670979, AGENT IVEY asked HINES if GREEN had recently beat anyone with a firearm. HINES stated that he had no knowledge of this occurring, and that GREEN did not own any firearms to his knowledge. HINES also stated that he is unfamiliar with a subject named, SANTELL MCCUTCHEN.

Based upon information received in Summary 664600, AGENT IVEY asked HINES if he had any knowledge of GREEN being a Confidential Informant for PRESLEY, or PRESLEY soliciting GREEN to be a Confidential Informant.
