She was afraid that the management team had found out about it since the detainee was being placed in restrictive housing. The officer explained to me that she knew that she had to report this information. It was the "right thing to do". Additional information was given that the detainee may have a cellphone.

Sgt. Botts is 2nd shift and will return to work on 1-20-2021. I am requesting an investigation.

Synopsis

On 01-20-2021 SA STEPHENS was located at Walker State Prison to conduct an investigation into a possible relationship between SGT BOTTS and IM/DET REYNOLDS. An interview was conducted with SGT BOTTS, SGT BOTTS admitted to being friends with IM REYNOLDS and that they kissed on one occasion. She continued to deny that anything else happened but admitted that it probably would have eventually. SGT BOTTS denied any sexual contact between the two and denied bringing anything in to IM REYNOLDS. SGT BOTTS vehicle was searched and nothing of relevance was found, SGT BOTTS phone was seized as a precaution. IM REYNOLDS was not interviewed as per the WARDEN he was acting irate and had flooded his cell demanding to call and check on his mother who he claimed was sick. An interview will be scheduled with CO KENNEDY for 01-21-2021 most likely off site of Walker SP. SGT BOTTS resigned after the interview and was allowed to leave.
