This form is to be completed with the greatest attention to detail. The handling of this form will be in accordance with General Order O-10, Section D, Paragraph 3.

On 04/18/20 I, Sergeant Futch, as well as several APD officers attempted to pick up a wanted Felon for the FBI. I followed Sgt Hancock to MLK & W. 5th ST where the informant had advised Sgt Hancock the suspect was located. While there a male later identified as Gary Thomas (10/18/71) began to resist. Officers Sgt Hancock and Sgt Hancock while they were attempting to detain him. I tried to assist these officers in getting off on the man but he was actively resisting. Thomas was kicking and swinging his arms around while sitting on a bench so I grabbed his legs and pulled him from the bench in order to gain control of Thomas. Thomas continued to kick me in the chest as I ~~tried~~ <sup>tried</sup> to hold him in an attempt to prevent him from causing further injury. After Thomas continued fighting officers trying to catch him I moved to his torso where I was able to pull him right off then his left arm from under Thomas. He was placed on the ground without further incident. EMT checked Thomas at the jail for his hand number complaint & they advised he was OK. I treated my own injuries.
