Information found on the Offender Phone System is indicative that Inmate Michael Holloman Jr. 100881253 may be involved in an inappropriate relationship with an unknown female employee, referred to as "sergeant", while incarcerated at Walker State Prison Northwest Residential. Inmate Holloman states, "Anyways, but other words, I was just out in the God damn fucking barber shop with, with the sergeant by herself. This bitch God damn, God damn, rub her thighs all over me and shit, ew boy. My dick was so God damn hard I wouldn't even walk [inaudible] look, 'You gonna have to give me a second. I can't, I can't even fucking walk back on the sidewalk.' 'Cause somebody, two people just went to the hole for fighting. Alright, so I was like, 'I can't even walk down the sidewalk.' She was like, 'Oh yeah?' I said, 'Hell nah, what you mean? Dick hard as fuck.' She goes, 'Uh-huh.' She's like, 'You wanna take the finger nail clippers back with you?' I said, 'Fuck no.' She's like, 'I thought you came to cut your nails.' I was like, 'I cut my nails. Fuck everyone else. You know why I came in here.' She said, 'Oh you too much Holloman.'" This information was found during a call placed on 12/09/2020.

Escalated Call

12/09/2020 @ 20:08:00 This is believed to be Inmate Michael Holloman Jr. 100881253 using Inmate Robert Poteet [REDACTED] PIN to contact an unknown male civilian at telephone number [REDACTED]. During this call, Inmate Holloman refers to himself as "Holloman." During the beginning of this call, Inmate Holloman and the male discuss that the male has not received the money to his "Cash App" account.

At CP 01:53 Inmate Holloman says, "Making plays from the inside bro, trying to, ya know what I'm saying?"

At CP 01:59 Inmate Holloman says, "Anyways, but other words, I was just out in the God damn fucking barber shop with, with the sergeant by herself. This bitch God damn, God damn, rub her thighs all over me and shit, ew boy. My dick was so God damn hard I wouldn't even walk [inaudible] look, 'You gonna have to give me a second. I can't, I can't even fucking walk back on the sidewalk.' 'Cause somebody, two people just went to the hole for fighting. Alright, so I was like, 'I can't even walk down the sidewalk.' She was like, 'Oh yeah?' I said, 'Hell nah, what you mean? Dick hard as fuck.' She goes, 'Uh-huh.' She's like, 'You wanna take the finger nail clippers back with you?' I said, 'Fuck no.' She's like, 'I thought you came to cut your nails.' I was like, 'I cut my nails. Fuck everyone else. You know why I came in here.' She said, 'Oh you too much Holloman.' She [stutters] chub, she ain't chubby. She's like, she got like a big ass, ya know what I'm saying like, it's weird. Like, she got a big ass and big ass titties. But she ain't really fat, ya know what I'm saying, got her nose pierced and shit. She cool as fuck. Like, she works night time so like, I be working, helping like, orderly and shit, ya know what I'm saying, I really just be kicking shit. Me, my homeboy, he's G.D., his name Isaac, G.D. to death. Motherfucker got cut throat on his, across the top of his neck. He ain't nothing but twenty-one, ya know what I'm saying, he like a ninety-eight baby, or some, ninety-nine baby. He just as wild as you are, ya know what I'm saying, me and him get along great. G.D. to death though, cool as fuck. And so me and him, we just be kicking shit with her, ya know what I'm saying, and really they [stutters] they talking on fucking the phone and the whole nine yards, ya know what I'm saying like, three-way messages and all that. So, I was like, fucking uh, I was talking to her. I was like, 'Shit, ya know, Isaac gonna be mad as fuck I'm in here by myself.' She like, 'You just gonna go back and tell him that you were, me and you were talking about him.' I said, 'Alright, say no more [laughs].' Straight up." The male says, "Yeah." Inmate Holloman says, "She just gonna hit me with her thighs boy, whoo."

Note:

A THREADS report was ran on telephone number [REDACTED] which reveals that Inmate Michael Holloman Jr. [REDACTED] has dialed this number 2 times. The THREADS report reveals that Inmate Holloman is currently incarcerated at Ware State Prison. The Secure Call Platform reveals that the last telephone call placed by Inmate Holloman's PIN was on 12/07/2020 @ 18:14:34 and was placed from Walker State Prison Northwest Residential. The GADOC inmate search reveals that Inmate Holloman is currently housed at Northwest Rsat Center. Given this information it is believed, but not confirmed, that Inmate Holloman is currently incarcerated at Walker State Prison Northwest Residential.

I PRO gives a score of 5% that the inmate using Inmate Poteet's PIN is Inmate Robert Poteet [REDACTED]. After comparing voices from Inmate Poteet's enrollment recording they do not appear to be a match. Inmate Holloman's enrollment recording was also compared to the voice in the above notated call and does appear to be a match. It is believed but not confirmed based upon voice comparison from Inmate Holloman's enrollment recording that the inmate in the above notated call is Inmate Michael Holloman Jr. 1000881253.
