I TOOK PHOTOS OF WHERE I BELIEVED THE MELON USED TO BE AND INFORMED BRIAN AN INVESTIGATOR WOULD CONTACT HIM ABOUT HIS CASE.

ON 04/16/2019 I CALLED AND SPOKE WITH BRIAN MCNERNEY. HE STATED THERE WAS ANOTHER DUMPING SITUATION WITHIN 12 HOURS OF MAKING THE REPORT. HE STATED THE FOOD SCRAPS ARE BEING DUMPED INTO A CULVERT AND IS ATTRACTING RATS. I ADVISED HIM I WOULD TRY AND TALK TO HIS NEIGHBOR AND WOULD CALL HIM BACK ONCE I HAD DONE SO.

ON 04/17/2019 I WENT TO 442 SETTLERS RUN AND SPOKE WITH A RESIDENT. SHE STATED MRS. ROWE WAS NOT HOME. I GAVE HER MY CARD AND ASKED THAT ROWE CALL ME. I ASKED HER ABOUT DUMPING ITEMS LIKE FOOD NEAR THE PROPERTY LINE WITH HOUSE 418. THE FEMALE STATED SHE DIDN'T KNOW WHAT I WAS TALKING ABOUT. AS I WAS LEAVING I DID SEE A COUPLE OF PIECES THAT APPEAR TO BE EGG SHELLS NEAR THE MAILBOX OF 442 IN THE CUL DE SAC.

DEB ROWE CALLED AND I SPOKE WITH HER. SHE STATED SHE HAS THROWN FOOD SCRAPS IN THE 1/2 ACRE LOT SHE OWNS THAT IS BETWEEN THE TWO RESIDENCES. DEB STATED THE FIRST PROBLEM SHE RECALLED LIKE THIS WAS WHEN HER MOTHER DIED. SHE THREW OUT THE OLD FLOWERS FROM THE FUNERAL INTO THE WOODS SHE OWNS BETWEEN THE TWO RESIDENCES. SHE STATED SHE HAS HAD NUMEROUS ISSUES WITH HER NEIGHBOR AND HIS ODD BEHAVIOR. THERE ARE CRIMINAL TRESPASS WARNINGS OUT FOR BOTH OF THEM ON EACH OTHERS PROPERTY. DEB STATED IF SHE WAS DOING SOMETHING WRONG, I SHOULD TELL HER TO STOP. I TOLD HER AS LONG AS SHE WAS THROWING FOOD SCRAPS OUT ON HER OWN PROPERTY, THEN THERE WAS NO LAW BEING BROKEN THAT I KNOW OF. ON THE SECOND DAY OF MAY 2019 I DEPUTY MUELLER WAS DISPATCHED TO 442 SETTLERS RUN, DAHLONEGA GA. IN REFERENCE TO A MALE SUPPOSEDLY TRESPASSING.

WHEN I ARRIVED ON SCENE I WAS MET BY THE COMPLAINANT, DEBORAH ROWE, WHO STATED THAT HER NEIGHBOR, BRIAN MCNERNEY, HAD CROSSED OVER INTO HER PROPERTY BRIEFLY FOR AN UNKNOWN REASON. MRS. ROWE THEN SHOWED ME PICTURES THAT SHE HAD TAKEN EARLIER ON THIS DATE OF MR. MCNERNEY CLEARLY AND VISIBLY ON HER PROPERTY. I MADE CONTACT WITH MR. MCNERNEY AT HIS GARAGE AND PLACED HIM UNDER ARREST FOR CRIMINAL TRESPASS. I THEN SPOKE WITH HIM AND HIS WIFE ABOUT THE EVENTS THAT WOULD FOLLOW HIS ARREST. I PLACED MR. MCNERNEY IN THE REAR OF MY PATROL VEHICLE AFTER FIRST SEARCHING HIM FOR WEAPONS, I FOUND NONE. MR. MCNERNEY WAS THEN TRANSPORTED TO THE LUMPKIN COUNTY DETENTION CENTER AND TRANSFERRED OVER TO DETENTION STAFF WITHOUT INCIDENT. THE REAR OF MY PATROL VEHICLE WAS CHECKED BEFORE AND AFTER MR. MCNERNEY WAS INSIDE, NO CONTRABAND WAS FOUND. WARRANTS FOR CRIMINAL TRESPASS WILL BE SOUGHT.
