## Narrative

On June 8, 2020 at 1446 hours while on uniform patrol in a marked unit, I, Ofc. T Blackwell (PRN 64030) was dispatched to Eisenhower Dr. and Noble Oaks Dr. in reference to an automobile accident with injuries.

See Gears report 200608050 for information pertinent to accident investigation. During the course of my accident investigation it was brought to my attention that one of the drivers, Ms. Elizabeth Marshall, had crushed a canned alcoholic beverage and hid it under a car nearby. The only indications she had given me that she was possible DUI were slurred speech and glassy eyes. Ms. Marshall had complaint of pain or possible injury so I waited for EMS to arrive before questioning her further. I made fellow officer Cpl. Sharif Lockett (PRN 61577) aware of this so I could continue my investigation. Cpl. Lockett spoke to two witnesses who had knowledge of the alcoholic beverage and located the mentioned container.

At approximately 1507 hours, I interviewed Ms. Marshall in regards to the alcoholic beverage with the help of Cpl. Lockett. I informed Ms. Marshall some witnesses had seen her toss a crushed alcoholic beverage container under

a nearby car and then asked, "Were you drinking and driving?"

Ms. Marshall replied, "No."

I then asked, "Do you know anything about a crushed can?"

At this point Cpl. Lockett interjected and informed Ms. Marshall he had spoke to two witnesses who saw her throw the can under a nearby car and there were cameras to confirm. Cpl. Lockett then stated, "This is the one by the way. So how much of this did you drink?"

Ms. Marshall stated she had "probably half the can." I read Ms. Marshall Implied Consent over 21 at approximately 1512 hours and received a verbal yes.

I arrived at Memorial Medical Center located at 4700 Waters Ave, at 1603 hours and stood by with EMS while they performed a GBI Blood Draw. I witnessed EMS properly place the blood vials back into the cushion sleeve. In transit the sample was damaged before it could be logged in as evidence. The vials of blood had broken at the bottom outside of the cushion sleeve. I disposed of the kit as a biohazard material at the Property Room. My department-issued BWC was active for citizen encounters.
