Narrative

I spoke with Sharon via telephone in reference to a suspicious person at her residence yesterday. She told me the following: She is out of town at a wedding and her house is being watched by Brittney. Sharon was upset because a person was wandering around her house and it scared Brittney. Sharon told me she wanted to file a formal complaint since the officers on scene did nothing with the male subject. I asked her to give me the number where I could speak with Brittney and I would call her back. Sharon gave me the number.

I called Brittney and spoke with her via telephone. She told me the following: Yesterday around 1517 hours, a white male came to the residence and knocked on the door and asked to use the phone. She told the male the phone was out of service and closed the door. The male subject left and walked down the street. She thought the male had a mental handicap because of the following: 1 when she told him the phone was out, he just stood "dumbfounded" 2 when he walked down the street, he "wandered" like he was "lost or confused". The male subject came back and knocked on the front door for a second time. She refused to answer the door. She called Sharon and was told to call the police. While she was on the phone with Sharon and the police; the male walked around to the rear of the house and looked in the window and tried to open the back door. When the male could not open the door, he walked towards the out buildings and disappeared into the woods. She said the police arrived, but they could not find the male.

Brittney described the male as follows: a white male, approximately 50 years old, 5'10" tall wearing a blue jacket and dark (navy) blue jogging pants. She believed he smokes since she smelled cigarette smoke on his person.

Brittney believed the male subject returned tonight. She took the dogs outside around 2000 hours and heard some rustling in the shrubs. At first, she thought it was a squirrel until she heard the dogs next door barking. She listened and heard leaves crunching and realized someone was

walking towards her. She gathered up the animals and went inside. Before she was inside, she saw a male she believed matched the description from yesterday. She knows the male she saw tonight had the same built and height, but that was all she could determine.

I told Brittiney I would set up a Zone Patrol for the residence and document the incident in a report. She told me to call Sharon and tell her. I gave Brittiney the case number and explained how to obtain a copy of the report.

I called Sharon and spoke with her. I told Sharon the following: Brittiney told me what happened, I documented the incident, and I set up a Zone Patrol for the next five days. Sharon was still upset about the incident and told me she was going to speak with the officers who went to her residence when she returns. I told Sharon that Brittiney has the case number.

Narrative

On 01/12/2006 I received a phone call from Ms. Sharon Beil. Ms. Beil had some concerns on how a suspicious person call was handled at her residence while she was out of town. She stated she had spoken to Deputy Wells and Deputy Love regarding this situation. She was not happy in the way Deputy Wells handled the call. When she spoke with Deputy Love she told D/S Love she wanted to file a formal complaint. He however never forwarded this info to a supervisor.

In speaking with Ms. Biel, she advised me her concerns were that we did not spend enough time at the residence looking for this suspicious person. She would like another supervisor to come out to her residence at our convenience. I told her that I had just got off duty and asked her if she would have a problem until I could personally come to her residence tomorrow morning. She stated that would be great for her. Ms. Biel stated she would call first thing tomorrow to arrange a time for me to come out to her residence.

The next morning Ms. Biel called dispatch to have me en-route. I was dispatched to 117 Saddlehorn and made contact with Ms. Biel. I then explained the procedure to Ms. Biel on how we in the Sheriff's Office handle specific calls and explaining some tips to her in making her residence more secured. After providing her with this information, I asked her if she wanted to file a formal complainant still. She stated that she did not want make a complaint and she
