General Conditions #13. Submit to drug, alcohol, and/or mental health testing / evaluation / rehabilitation and participate in and successfully complete any program as directed by probation.

Special Conditions #1b. You shall attend and complete Clinical Evaluation AND any follow up recommended treatment. PER REV; JUDGE ORDERED ^ TO PAY ARREARS OF \$273 WITHING 60 DAYS. ^ MUST HAVE CLINICAL EVAL DONE WITHIN 14 DAYS AND START CELEBRATE RECOVERY BY 11-19-18.

Special Conditions #11. You shall pay at the rate of \$113 /month FOR 18/MTHS by MONEY ORDER OR CASHIERS CHECK. (Includes Probation Fee and EVAF).

PER REV; JUDGE ORDERED ^ TO PAY ARREARS OF \$273 WITHING 60 DAYS. ^ MUST HAVE CLINICAL EVAL DONE WITHIN 14 DAYS AND START CELEBRATE RECOVERY BY 11-19-18.

Probationer is charged with violation of said conditions, in willful disregard of a Court Order, specifically as follows:


In that the defendant violated general condition # 4 in that he FAILED TO REPORT ON 12/17/18, 1/4/19, 1/7/19, 3-1-19, 3-8-19, AND 3-11-19 AS DIRECTED BY PROBATION.

In that the defendant violated special condition # 13 in that he FAILED TO ATTEND CELEBRATE RECOVERY AS DIRECTED BY PROBATION. DEFENDANT HAS ONLY ATTENDED 6 OF 24 SESSIONS SINCE HIS REVOCATION ON 11-14-2018.

In that the defendant violated special condition # 1b in that HE FAILED TO BEGIN TREATMENT AS ORDERED BY CLINICAL EVALUATION. DEFENDANT WAS INSTRUCTED TO BEGIN TREATMENT ON 3-4-19.

In that the defendant violated special condition # 11 in that HE FAILED TO PAY AS ORDERED BY THE COURT.
