**COUNT 1**

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **MILES BRYANT** with the offense of **MALICE MURDER (O.C.G.A. 16-5-1(a))**, for that the said accused, in the County and State aforesaid, between the 26th day of July, 2022, and the 27th day of July, 2022, the exact date of the offense being unknown to the Grand Jury, did unlawfully, with malice aforethought, cause the death of Susana Morales, a human being, in a manner unknown to the Grand Jury, contrary to the laws of said State, the good order, peace and dignity thereof.

**COUNT 2**

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **MILES BRYANT** with the offense of **FELONY MURDER (O.C.G.A. 16-5-1(c))**, for that the said accused, in the County and State aforesaid, between the 26th day of July, 2022, and the 27th day of July, 2022, the exact date of the offense being unknown to the Grand Jury, while in the commission of the offense of Kidnapping, a felony, did cause the death of Susana Morales, a human being, in a manner unknown to the Grand Jury, contrary to the laws of said State, the good order, peace and dignity thereof.

**COUNT 3**

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **MILES BRYANT** with the offense of **KIDNAPPING (O.C.G.A. 16-5-40)**, for that the said accused, in the County and State aforesaid, on the 26th day of July, 2022, did unlawfully abduct and steal away Susana Morales without lawful authority or warrant and held such person against her will, said act resulting in bodily injury to Susana Morales, contrary to the laws of said State, the good order, peace and dignity thereof.

**COUNT 4**

**THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA,** charge and accuse **MILES BRYANT** with the offense of **CRIMINAL ATTEMPT TO COMMIT RAPE (O.C.G.A. 16-4-1)(O.C.G.A. 16-6-1)**, for that the said accused, in the County and State aforesaid, between the 26th day of July, 2022, and the 27th day of July, 2022, the exact date of the offense being unknown to the Grand Jury, did knowingly and intentionally attempt to commit the crime of Rape, in violation of Code section 16-6-1 of the Official Code of Georgia, in that the said accused did kidnap Susana Morales, an act which constitutes a substantial step toward the commission of said crime, contrary to the laws of said State, the good order, peace and dignity thereof.

**COUNT 5**

**THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA,** charge and accuse **MILES BRYANT** with the offense of **FALSE REPORT OF A CRIME (O.C.G.A. 16-10-26)**, for that the said accused, in the County and State aforesaid, on the 27th day of July, 2022, did willfully and knowingly give a false report of the crime of Theft by Taking to William Merkley, a law enforcement officer with the Gwinnett County Police Department, contrary to the laws of said State, the good order, peace and dignity thereof.
