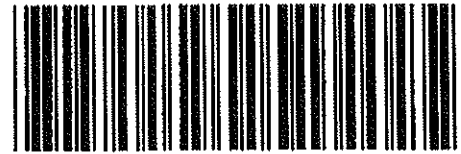

CASE SUMMARY

On or about 12/07/12, the officer was arrested and issued a municipal citation for offense of Public Intoxication.

On or about 12/06/12, local law enforcement officers were doing a patrol around several of the local bars. They observed that the officer of this investigation appeared to be having an argument outside with another person. The officer then walked away and walked toward a park. The officer was then observed behind a dumpster and stated that he/she was waiting on someone. The officer was left to wait for a ride. Shortly afterwards, the officer was again observed standing by the roadway yelling and waving his/her arms at an occupant inside a vehicle that was out in the road.

The officer was intoxicated and was placed under arrest at this time.

On or about 12/07/12, the officer paid a fine in the amount of \$216.00 and was not required to appear in court since the officer was over the age of twenty-one.
