On Wednesday, August 19, 2020 at approximately 3:35 p.m., Special Agent DEREK GLASCO was located at the Hall County Sheriff's Office Headquarters for the purpose of receiving a briefing of case facts from Captain DALE LONG and 1st Lieutenant BONNER BURTON of the Hall County Sheriff's Office. Captain LONG and 1st Lt. BURTON related essentially the following.

On Monday, August 17, 2020, an Inmate, TAKARRA WRIGHT, advised a Jailer that Officer DAVID RIVERA was having a intimate relationship with Inmate HEATHER ROBERTSON. WRIGHT had seen Jailer RIVERA and ROBERTSON kissing in the dry storage area near the kitchen. WRIGHT also advised that ROBERTSON had previously told her that Jailer RIVERA performed oral sex on her.

Sgt. THOMASON and Deputy PAUL PAINE spoke to ROBERTSON. ROBERTSON denied having any relationship with RIVERA.

Agent GLASCO advised he would conduct a criminal investigation into the alleged sexual assault.

On Wednesday, August 19, 2020, at approximately 5:28 p.m., Special Agent DEREK GLASCO was located at the Hall County Detention Center for the purpose of interviewing Inmate TAKARRA WRIGHT. Also present during the interview was Lt. KILEY SARGENT. WRIGHT was interviewed to determine what information she could provide regarding a sexual relationship between Hall County Detention Center Jailer DAVID RIVERA and Inmate HEATHER ROBERTSON. Prior to the interview Agent GLASCO advised WRIGHT of her Constitutional Rights by utilizing a GBI Waiver of Rights form. Agent GLASCO read the entire Waiver of Rights form to WRIGHT. WRIGHT agreed to speak to Agent GLASCO and signed the Waiver of Rights form. The original Waiver of Rights form will be maintained in the rear of this case file. A copy of this Waiver of Rights form will be attached to this case summary in digital format. It should be noted the interview was audio recorded. A copy of this digital recording has been attached to this case summary in digital format. During the interview, WRIGHT stated essentially the following.

WRIGHT knew that ROBERTSON and Jailer RIVERA had been dating for approximately the past two months. WRIGHT and ROBERTSON both worked in the kitchen area of the jail. This detail is known as "work force." WRIGHT was also in the same cell as ROBERTSON.

WRIGHT saw RIVERA and ROBERTSON kiss in the dry storage area in the kitchen. WRIGHT saw this one morning last week. ROBERTSON and Jailer RIVERA kissed on the mouth.

WRIGHT only saw Jailer RIVERA and ROBERTSON kiss the one time. WRIGHT however, had seen Jailer RIVERA comment on how good ROBERTSON looked. WRIGHT also observed ROBERTSON threaten other female inmates who found Jailer RIVERA attractive. WRIGHT advised that ROBERTSON and Jailer RIVERA told each other that they loved each other.

ROBERTSON previously told WRIGHT that Jailer RIVERA had performed oral sex on her. WRIGHT assumed this happened in the dry storage area. WRIGHT did not know when Jailer RIVERA performed oral sex on ROBERTSON. WRIGHT did not know of any other sexual acts between the two.

WRIGHT described Jailer RIVERA as a very flirty person.

WRIGHT had been in the Hall County Detention Center for approximately one month. WRIGHT knew ROBERTSON from outside of jail. ROBERTSON told WRIGHT that she and Jailer RIVERA had been dating for the past two months. ROBERTSON advised WRIGHT of this when WRIGHT was first assigned to work force.

ROBERTSON was scared that Jailer RIVERA would get in trouble for their relationship and lose his job as a Jailer.

WRIGHT did not know of any other inmates that knew of Jailer RIVERA and ROBERTSON'S relationship.

WRIGHT did not know of Jailer RIVERA providing ROBERTSON with any gifts or contraband. ROBERTSON did not want to get Jailer RIVERA in trouble.

ROBERTSON did recently request some new t-shirts from Jailer RIVERA and Jailer RIVERA advised he would look into getting her some more.

On Wednesday, August 19, 2020, at approximately 5:55 p.m., Special Agent DEREK GLASCO was located at the Hall County Detention Center for the purpose of interviewing TINA BUI. Agent GLASCO was investigating an alleged sexual assault between Jailer DAVID RIVERA and Inmate HEATHER ROBERTSON. Agent GLASCO had learned that BUI was a potential witness. BUI was interviewed to determine what information she could provide regarding the relationship between Jailer RIVERA and ROBERTSON. Also present during the interview was Hall County Sheriff's Office Lt. KILEY SARGENT. It should be noted prior to the interview Agent GLASCO advised BUI of her Constitutional Rights by utilizing a GBI Waiver of Rights form. Agent GLASCO read the entire Waiver of Rights form to BUI. BUI agreed to speak to Agent GLASCO and provided her signature. A copy of this Waiver of Rights form has been attached to this case summary in digital format. The original Waiver of Rights form will be maintained in the rear of this case file. It should also be noted that this interview was audio recorded. A copy of this digital recording has been attached to this case summary in digital format. During the interview, BUI stated essentially the following.

ROBERTSON and BUI worked together in the kitchen on "work force" detail. BUI did not know of a relationship between Jailer RIVERA and ROBERTSON.

Inmate SUMMER BRYANT and Inmate BRIDNEY JOHNSON indicated that they heard ROBERTSON and Jailer RIVERA had a relationship. BRYANT and JOHNSON said they heard Jailer RIVERA and ROBERTSON had "something going on in the storage room." However, no one witnessed this. BUI did not believe this

was true.

BUI never saw ROBERTSON or Jailer RIVERA acting flirty towards each other. BUI never saw them hug. BUI never heard them speaking inappropriately to one another.

The last time BUI saw Jailer RIVERA and ROBERTSON together would have been approximately one week prior to this interview in the kitchen. BUI had never seen ROBERTSON or Jailer RIVERA in the storage room together.

ROBERTSON did think that Jailer RIVERA was attractive. ROBERTSON would refer to him as her "husband." A lot of the female Inmates believe Jailer RIVERA was an attractive person.

No further information was obtained. The interview was concluded at approximately 6:08 p.m.

On Wednesday, August 19, 2020, at approximately 6:14 p.m., Special Agent DEREK GLASCO was located at the Hall County Detention Center for the purpose of interviewing Inmate HEATHER ROBERTSON. ROBERTSON was interviewed to determine what information she could provide regarding a sexual relationship between herself and Hall County Detention Center Jailer DAVID RIVERA. Also present during the interview was Hall County Sheriff's Office Lt. KILEY SARGENT. It should be noted, prior to the interview, Agent GLASCO advised ROBERTSON of her Constitutional Rights by utilizing a GBI Waiver of Rights form. Agent GLASCO read the entire Waiver of Rights form to ROBERTSON. ROBERTSON agreed to speak to Agent GLASCO and signed the Waiver of Rights form. A copy of this Waiver of Rights form has been attached to this case summary in digital format. The original Waiver of Rights form will be maintained in the rear of this case file. It should also be noted that this interview was audio recorded. A copy of this digital recording has been attached to this case summary in digital format. During the interview ROBERTSON stated essentially the following.

ROBERTSON denied having a relationship with Jailer RIVERA. Jailer RIVERA never told ROBERTSON that he loved her. Jailer RIVERA had never hugged ROBERTSON. ROBERTSON denied any sexual contact with Jailer RIVERA. ROBERTSON denied Jailer RIVERA performing oral sex on her.

ROBERTSON had been incarcerated for the past thirteen months. ROBERTSON first met Jailer RIVERA when she was assigned to kitchen duty. Jailer RIVERA worked in the place of Jailer EVANS when Jailer EVANS went on vacation. Jailer

RIVERA worked there for two weeks in the kitchen.

ROBERTSON did not know where these rumors originated regarding ROBERTSON and Jailer RIVERA having a relationship. ROBERTSON began hearing these rumors approximately two months prior to this interview when she was in cell B-5.

ROBERTSON believed another female inmate may have been jealous and began the rumors.

No further information was obtained. The interview was concluded at approximately 6:34 p.m.

On August 20, 2020, at approximately 10:02 a.m., Special Agent DEREK GLASCO was located at the Hall County Detention Center for the purpose of interviewing DAVID RIVERA. RIVERA was interviewed to determine what information he could provide regarding a sexual relationship he had with an Inmate, HEATHER ROBERTSON, when he was employed at the Hall County Detention Center as a Jailer. It should be noted the interview was audio recorded. A copy of this digital recording has been attached to this case summary in digital format. During the interview RIVERA stated essentially the following.

Prior to the interview Agent GLASCO advised RIVERA that, "This investigation is to determine whether any criminal laws have been violated regarding sexual contact with an inmate. It is not an administrative or disciplinary inquiry. You are not being compelled to give any statement or answer any question. Your cooperation in this investigation is voluntary." Agent GLASCO also advised RIVERA that he was not under arrest. RIVERA agreed to speak to Agent GLASCO.

RIVERA was previously employed at the Hall County Detention Center as a Jailer. RIVERA worked at the Detention Center from August of 2018 until August of 2020.

On approximately June 24, 2020, RIVERA was working as a Jailer in the kitchen area of the Detention Center. RIVERA was filling in for Jailer EVANS who was out on leave. As a Jailer in the kitchen, Jailer RIVERA'S duties would have been to supervise the inmates who prepared food in the kitchen.

Jailer RIVERA went into the dry storage area of the kitchen with ROBERTSON because a truck was delivering items to the kitchen. When Jailer RIVERA and ROBERTSON walked into dry storage ROBERTSON pulled her pants down to her thighs and told Jailer RIVERA that she wanted him. ROBERTSON exposed her vagina to Jailer RIVERA while they were both in the dry storage area of the kitchen. Jailer RIVERA inserted his fingers in ROBERTSON'S vagina. Jailer RIVERA then performed oral sex on ROBERTSON; Jailer RIVERA placed his mouth on ROBERTSON'S vagina. Jailer RIVERA knew there were no cameras in the dry storage area.

Jailer RIVERA advised he inserted his fingers in ROBERTSON'S vagina for approximately five seconds. Furthermore, he performed oral sex on her for approximately two seconds. Jailer RIVERA explained that the entire contact with ROBERTSON in the dry storage area took place over the course of fifteen minutes.

After performing oral sex on ROBERTSON for approximately two seconds, Jailer RIVERA stood up and ROBERTSON kissed him on the mouth. Jailer RIVERA advised ROBERTSON was standing up while he put his fingers in her vagina and performed oral sex on her.

Jailer RIVERA could not recall if the sexual contact with ROBERTSON occurred in the morning or the afternoon. Jailer RIVERA advised he was on "B shift" when the sexual contact with ROBERTSON occurred. "B shift" was from 7:00 a.m. to 7:00 p.m.

Jailer RIVERA knew the sexual contact he had with ROBERTSON was inappropriate and he had been taught in the POST Jailer Academy not to have

sexual contact with inmates. Jailer RIVERA also knew it was against Hall County Detention Center Policy. In the Jailer Academy, instructors warned Jailer RIVERA and other cadets that inmates would try to manipulate them to have sexual contact with them. Jailer RIVERA felt ROBERTSON manipulated him. Jailer RIVERA was not sexually attracted to ROBERTSON.

Jailer RIVERA explained that approximately a week and a half before he performed oral sex on ROBERTSON, Jailer RIVERA entered the dry storage room and ROBERTSON ran up to Jailer RIVERA and kissed him. ROBERTSON then walked away. ROBERTSON continued to do this whenever Jailer RIVERA went into dry storage. Jailer RIVERA did not like it when ROBERTSON would do this.

Jailer RIVERA denied being in a relationship with ROBERTSON. Jailer RIVERA denied having any communications with ROBERTSON outside of the Detention Center. Jailer RIVERA denied providing ROBERTSON or any other inmates with contraband. Jailer RIVERA denied having any sexual contact with any other inmates.

Jailer RIVERA stated he was going through a rough time when he began having sexual contact with ROBERTSON. He knew that it was wrong.

ROBERTSON told Jailer RIVERA that she loved him before. Jailer RIVERA denied loving ROBERTSON however, he did say he loved ROBERTSON in return. Jailer RIVERA did this to make ROBERTSON feel better about herself.

ROBERTSON would speak about seeing Jailer RIVERA after she got out of the Detention Center. Jailer RIVERA told ROBERTSON he would see her when she got

out of the Detention Center. Jailer RIVERA did not truthfully intend on seeing ROBERTSON when she was released.

Jailer RIVERA did not know ROBERTSON prior to meeting her in the Detention Center. Jailer RIVERA was unsure of ROBERTSON'S criminal charges.

Agent GLASCO asked Jailer RIVERA if ROBERTSON ever requested him to use his position as a Jailer for her benefit. ROBERTSON did not request anything such as cigarettes or other contraband. Jailer RIVERA did recall ROBERTSON requesting some more shirts from Jailer RIVERA. Jailer RIVERA told ROBERTSON he would get them for her however, Jailer RIVERA did not intend on getting ROBERTSON the shirts. Jailer RIVERA admitted he was worried ROBERTSON would tell someone about their relationship if he did not get her the t-shirts she requested.

Jailer RIVERA advised that ROBERTSON would tell him she loved him essentially every time he came to work since they began having sexual contact. Jailer RIVERA heard from other inmates that ROBERTSON was calling him her husband. Jailer RIVERA did not think of ROBERTSON as a girlfriend.

Approximately one to two weeks prior to this interview, ROBERTSON touched Jailer RIVERA'S penis outside of his pants. ROBERTSON grabbed his penis as she walked past him. Jailer RIVERA denied having an erection. This incident occurred in the dry storage.

Agent GLASCO asked Jailer RIVERA if he and ROBERTSON ever "made out." Jailer RIVERA advised he made out with ROBERTSON on two occasions. The first

time he "made out" with ROBERTSON was in dry storage prior to the time he performed oral sex on ROBERTSON. The second time Jailer RIVERA "made out" with ROBERTSON was a week after he performed oral sex on her.

Jailer RIVERA described making out with ROBERTSON as kissing her for thirty seconds to a minute. Agent GLASCO asked Jailer RIVERA if he would touch ROBERTSON'S vagina when they made out. Jailer RIVERA advised, "at time yes." Jailer RIVERA would place his hand on ROBERTSON'S vagina under her clothes. Jailer RIVERA estimated he had touched ROBERTSON'S vagina three or four times. Jailer RIVERA would "finger" ROBERTSON'S vagina for approximately fifteen seconds.

Agent GLASCO asked Jailer RIVERA how their relationship became known. Jailer RIVERA advised he told no one about the relationship. Jailer RIVERA assumed ROBERTSON was bragging about it to other people.

Jailer RIVERA told his girlfriend about his relationship with ROBERTSON the night prior to this interview. Jailer RIVERA'S girlfriend was also a Hall County Detention Center Jailer named ELANA GARCIA.

Agent GLASCO asked Jailer RIVERA if he would write a written statement regarding his sexual contact with ROBERTSON. Jailer RIVERA wrote essentially a timeline which outlined how his relationship with ROBERTSON started by exchanging hello and progressed to oral sex. A copy of this written statement has been attached to this case summary in digital format. The original statement will be maintained in the rear of this case file.

On Friday, August 21, 2020, at approximately 1:19 p.m., Special Agent DEREK GLASCO received an email from Hall County Sheriff's Lt. KILEY SARGENT. The email contained an audio file which was a telephone call between Inmate HEATHER ROBERTSON and BRITTNEY ROBERTSON.

Agent GLASCO reviewed the telephone call. At approximately five minutes, thirty-three seconds (5:33) HEATHER ROBERTSON advised BRITTNEY that she was being investigated by the GBI. HEATHER stated she was not in trouble. HEATHER would not provide BRITTNEY with any details as to why she was being investigated. HEATHER advised BRITTNEY that she would put BRIDNEY JOHNSON on the phone to describe a similar situation that JOHNSON was going through so that BRITTNEY could get the picture as to what was going on.

At approximately seven minutes and twenty-eight seconds (7:28) into the recording, JOHNSON began speaking to BRITTNEY. JOHNSON stated, "you know how they say jail house love ain't real? They trying to keep them separated like Romeo and Juliet cause you know it's not supposed to happen." JOHNSON then stated, "use your imagination." It should be noted it is difficult to discern much of what JOHNSON is stating. JOHNSON gets off the phone at approximately eight minutes and forty seconds (8:40) into the recording.

The recording ends at approximately sixteen minutes one second (16:01) into the interview.

On Thursday, August 27, 2020, at approximately 10:21 a.m., Special Agent DEREK GLASCO was located at the Hall County Detention Center for the purpose of interviewing Inmate SUMMER BRYANT. BRYANT was interviewed to determine what information she could provide regarding a sexual relationship between Inmate HEATHER ROBERTSON and Hall County Detention Center Jailer DAVID RIVERA. It should be noted prior to the interview Agent GLASCO advised BRYANT of her Constitutional Rights by utilizing a GBI Waiver of Rights form. Agent GLASCO read the entire Waiver of Rights form to BRYANT. BRYANT agreed to speak with Agent GLASCO and provided her signature on the Waiver of Rights form. A copy of the GBI Waiver of Rights form has been attached to this case summary in digital format. It should be noted this interview was audio recorded and has been attached to this case summary in digital format. During the interview, BRYANT stated essentially the following.

BRYANT had been incarcerated at the Hall County Detention Center since May of 2020. Ever since BRYANT had been in the Hall County Detention Center, ROBERTSON had bragged about having a relationship with RIVERA. ROBERTSON would tell other inmates that RIVERA was her boyfriend. ROBERTSON would say she and RIVERA were going to get married whenever ROBERTSON got out of jail.

ROBERTSON said she and RIVERA had kissed. ROBERTSON had also touched RIVERA'S penis. BRYANT assumed ROBERTSON touched RIVERA'S penis over his clothing because of RIVERA'S duty belt. RIVERA had also performed oral sex

on ROBERTSON. ROBERTSON and RIVERA wanted to have sex however, they did not want to get into trouble. BRYANT had never seen ROBERTSON or RIVERA have any type of physical contact with one another.

BRYANT described ROBERTSON as a flirty individual. ROBERTSON flirted with a lot of jailers.

BRYANT recalled an occasion when Jailer EVANS went on vacation and RIVERA covered his shift which was in the kitchen area of the jail. ROBERTSON was on the "work force." This meant ROBERTSON worked in the kitchen and prepared food for inmates. BRYANT was on "work release." This meant BRYANT prepared food for the Sheriff's Office Staff.

Both "work force" and "work release" inmates worked in the kitchen area. Attached to the kitchen was an area BRYANT described as "dry storage." BRYANT would see RIVERA and ROBERTSON go into dry storage by themselves. RIVERA and ROBERTSON would be in the dry storage area by themselves between ten and fifteen minutes at a time. This is when BRYANT began believing ROBERTSON'S claims that she had a relationship with RIVERA.

BRYANT saw RIVERA and ROBERTSON in the dry storage area numerous times since RIVERA began filling in on Jailer EVANS' shift. When RIVERA was covering for Jailer EVANS, RIVERA would follow ROBERTSON everywhere. RIVERA would often come to the kitchen area even when he was not assigned to that detail.

When RIVERA was in charge of kitchen detail, ROBERTSON would sometimes sit beside him at his post. BRYANT advised that was against the rules to have an

inmate sit next to a jailer.

BRYANT was unaware of RIVERA providing ROBERTSON, or any other inmates, any contraband. BRYANT was not aware of any other jail staff having sexual contact with inmates.

BRYANT recalled on Saturday, August 15, 2020 and Sunday, August 16, 2020 seeing ROBERTSON and RIVERA in the dry storage area laughing in the corner. This would have been between 8:00 a.m. and 3:00 p.m. BRYANT recalled the dates because she was supposed to go to Court on Monday, August 17, 2020.

ROBERTSON was very flirty towards RIVERA. BRYANT did not see RIVERA flirt back with ROBERTSON when the other inmates could see them. BRYANT was unaware of any other inmates who witnessed ROBERTSON and RIVERA have physical contact with each other.

No further information was obtained. The interview was concluded at approximately 10:42 a.m.

JOHNSON described ROBERTSON as a friend of hers. JOHNSON thought of RIVERA as a very professional jailer. A lot of female inmates thought that RIVERA
