1 ON SEPTEMBER 10, 2015 AT APPROXIMATELY 2359 HOURS, I RAN THE TAG OF A WHITE DODGE CARAVAN VAN, GA TAG #PMQ3319, THROUGH GCIC/NCIC.  
2 I THEN RAN THE REGISTERED OWNER OF THE VEHICLE THROUGH GCIC/NCIC; **Statue Regulation**  
3 **Statue** I NOTICED THE DRIVER WAS A MALE AND WAS MOST LIKELY THE REGISTERED OWNER. I INITIATED A TRAFFIC STOP ON THE VEHICLE, AND THE  
4 VEHICLE CAME TO A FINAL STOP AT THE FAST TRIP CONVENIENCE STORE LOCATED AT 2115 WINDER HWY. I MADE CONTACT WITH THE DRIVER AND  
5 ASKED FOR HIS NAME. THE DRIVER PROVIDED HIS NAME AS NILSON MORAES, WHICH WAS THE SAME NAME AS THE REGISTERED OWNER OF THE  
6 VEHICLE. I INFORMED THE DRIVER HIS LICENSE WAS SUSPENDED ON SEPTEMBER 7, 2015 FOR CHILD SUPPORT OBLIGATIONS. HE ACKNOWLEDGED HE  
7 RECEIVED A PAPER IN MAIL STATING HIS LICENSE WOULD BE SUSPENDED ON SEPTEMBER 7TH. I ASKED THE DRIVER IF HE COULD HAVE SOMEONE  
8 COME PICK UP HIS VEHICLE, AND HE CONTACTED HIS WIFE. HIS WIFE AND HIS WIFE'S DAUGHTER, DESIREE OLSEN, ARRIVED ON SCENE. PER THE  
9 DRIVER'S REQUEST, THE VEHICLE WAS RELEASED TO DESIREE OLSEN. THE DRIVER WAS INFORMED HE WAS UNDER ARREST FOR DRIVING A MOTOR  
10 VEHICLE WITH A SUSPENDED DRIVER'S LICENSE. HE WAS HANDCUFFED BEHIND HIS BACK, DOUBLE-LOCKED, CHECKED FOR FIT, AND SEARCHED  
11 INCIDENT TO ARREST. THE DRIVER WAS TRANSPORTED TO THE COUNTY JAIL AND RELEASED TO THE ON-DUTY DEPUTIES WITHOUT ANY INCIDENT. HE  
12 WAS CITED FOR DRIVING A MOTOR VEHICLE WITH A SUSPENDED DRIVER'S LICENSE (CITATION #586519).
