On Wednesday, February 26, 2020, at approximately 9:11 a.m., SA LOGAN HOLLAND and SA AMANDA HAMMOCK were located at the Byron Police Department for the purpose of interviewing BRIANNA WISE pursuant to this investigation. Also present during the interview was Byron Police Department SERGEANT MELANIE BICKFORD. WISE filed a police report with the Byron Police Department because her Kia Forte had the tires slashed and a rock thrown through the window of the vehicle either on February 22 or February 23, 2020. WISE has three children with a Peach County Deputy, ANDY HARPER, who is a suspect in this case. During the course of the interview, WISE essentially stated the following:

WISE went to her friend, ALLIE SANDERS' house, located at [REDACTED] Main Street, Apartment 7A, Byron, Georgia on February 22, 2020 at approximately 5:30 - 6:00 p.m. WISE and SANDERS went to Wild Wings Restaurant together. They returned home at approximately 2:00 a.m. and SANDERS was later called by her neighbor, who works for the Warner Robins Police Department, at approximately 6:50 a.m. SANDERS was informed that a vehicle was damaged outside of her apartment. After going outside, SANDERS and WISE discovered that WISE's 2015 Kia Forte, Georgia tag # [REDACTED] was damaged. The vehicle had a boulder thrown through the window of the vehicle and all four tires had been slashed. WISE was not aware of anybody who would have been upset with her other than the father of her three children, Peach County Deputy ANDY HARPER. WISE went on to explain that her and HARPER have had a volatile relationship over the past several years.

According to WISE, the previous Wednesday, February 19, 2020, she washed her

clothing at HARPER's father's home. She stayed the night at the residence with HARPER who became upset with her the following morning because he believed that WISE stole his iPhone, which was deactivated. WISE left and later came back to discover that her clothing and bag that she brought to the residence was no longer there. WISE contacted HARPER who had it inside his patrol car and stated he refused to give it to her until she gave him his phone back. According to WISE, she did not have HARPER's phone. HARPER later went to her apartment at [REDACTED] Boulevard, [REDACTED] Byron, Georgia and threw her clothing on the ground to bring it back to her. Additionally, WISE explained they have had previous incidents of domestic disputes. In 2015 or 2016, they rented a house off of Red Oak Road in Peach County, Georgia. WISE had a relationship outside of her relationship with HARPER. HARPER became upset and cut up the couch with a knife and tried to throw the couch at the door. According to WISE, HARPER stated that he should have put a bullet through her head and the head of the other individual she was seeing. Furthermore, WISE explained that in 2017, WISE and HARPER lived in an apartment complex off Highway 96 across from Houston County High School. They were split up at the time, and HARPER worked for the Pulaski County Sheriff's Office. HARPER would drink and drive his patrol vehicle. There was an incident in 2017, while WISE lived at this complex where they got into an argument and HARPER tried to sleep in his patrol car outside the apartment. WISE eventually let him inside the residence, The following morning, WISE found a plastic part of Black and Mild with a jagged part underneath her tire. According to WISE, when HARPER drank, he would smoke Black and Mild cigars.

In September 2019, WISE moved to Brighton Park Apartment complex at [REDACTED] Watson Boulevard, Byron, Georgia. After moving in, there was an incident where they had been drinking and HARPER pushed her. Furthermore, there was an

incident where she believed HARPER put a part of their daughters bed post underneath the tire of her vehicle with a screw pointed up.

According to WISE, the officer who notified SANDERS of the damage to the vehicle stated that he did not see anything at that time.

WISE later reported the incident to the Byron Police Department who requested the assistance of the GBI.

SA HOLLAND's interview with WISE concluded at approximately 10:06 a.m.

On Wednesday, February 26, 2020, at approximately 3:20 p.m., SA LOGAN HOLLAND and SA AMANDA HAMMOCK were located at the Peach County Sheriff's Office for the purpose of interviewing ANDY HARPER pursuant to this investigation. HARPER was a Peach County deputy and a suspect in this case. Prior to beginning the interview, SA HOLLAND read HARPER his Miranda Rights, which HARPER stated he understood and signed a GBI Waiver of Rights form. SA HOLLAND audio recorded the interview with HARPER, which was digitally attached to this summary. In addition, SA HOLLAND video recorded the interview with HARPER. The video recording will be maintained in the rear of the case file. During the course of the interview, HARPER essentially stated the following:

HARPER and BRIANNA WISE have been together for approximately fifteen years. They have three children together. According to HARPER, he came to work at approximately 5:30 p.m. - 8:30 p.m. on Saturday, February 22, 2020. Prior to that, he was at his uncle's funeral. SERGEANT RODRIGUEZ with the Peach County Sheriff's Office called HARPER into work. While working, HARPER confirmed that he did ride by BRIANNA WISE's apartment in Brighton Park and later rode by the apartment where he vehicle was located off of Main Street in Byron, Georgia. According to HARPER, he did get out of his vehicle for approximately fifteen seconds and ran the tag of a pick-up truck that was parked behind WISE's Kia Forte. HARPER recalled that the pick-up truck was a white Chevrolet truck that he thought he recognized from the Brighton Park apartment complex area. HARPER explained he ran the tag because his cell phone pinged in that area. HARPER believed that WISE had recently stolen his cell phone. After getting off, WISE later

used his dad's truck to go buy beer off the 247 Connector near Interstate 75. According to HARPER, he never drove his father's truck to where WISE's vehicle was located.

HARPER also worked Monday and Tuesday nights, which was February 24 and February 25, 2020. HARPER confirmed that he did drive by WISE's apartment in [REDACTED] complex the early morning hours of Tuesday and the early morning hours of Wednesday. According to HARPER, he did not see her car at her apartment.

HARPER went on to explain that he and WISE have not any recent issues and that WISE spent the night with him and his father the previous Wednesday. SA HOLLAND inquired if WISE and HARPER were involved in a dispute about his cell phone. HARPER confirmed he believed that WISE took his cell phone. WISE did laundry at HARPER's father's house and he later took the laundry to WISE. HARPER denied throwing the laundry on the ground.

SA HOLLAND inquired if HARPER would be willing to take a polygraph. HARPER agreed to take a polygraph and stated he was not sure if he would pass one because they believed they were inaccurate. HARPER confirmed that he would cope with WISE previously cheating on him through drinking. However, HARPER has stopping drinking as much and has been going to the gym.

HARPER later told SA HAMMOCK that he was assigned the Byron area to patrol the night that WISE's tires were slashed.

SA HOLLAND and SA HAMMOCK concluded the contact with HARPER at

approximately 4:01 p.m.

Additionally, SERGEANT MELANIE BICKFORD stepped in to speak with HARPER after the interview.

On Thursday, February 27, 2020, at approximately 2:35 p.m., SA LOGAN HOLLAND was located at Allen's Alignment off of Highway 49 in Peach County, Georgia. SA HOLLAND was at this location for the purpose of photographing the vehicle belonging to BRIANNA WISE, which was a 2015 Kia Forte.

Additionally, SA HOLLAND obtained an estimate of record which showed the total cost of repairs to WISE's 2015 Kia Forte was \$1,041.31. SA HOLLAND digitally attached a copy of this to this summary.

SA HOLLAND took multiple photographs of the Kia Forte and the slashed tires, which were already off of the vehicle. While photographing the vehicle, SA HOLLAND noticed several possible latent prints on the vehicle. SA HOLLAND used black fingerprint powder to dust the 2015 Kia Forte. SA HOLLAND obtained a total of eight latent prints. Several of the prints were located on the A pillar of the vehicle near where damage was done on the windshield. Additionally, more latent prints were recovered above the front driver's side of the vehicle and the driver's side mirror, along with the B pillar and above the passenger's side tire. These latent prints were assigned to GBI bar code BB03670 and were later transported to the GBI Crime Lab.

SA HOLLAND digitally attached a copy of the photographs to this summary.

SA HOLLAND concluded the processing of WISE's vehicle at approximately 4:15 p.m.



On Wednesday, March 11, 2020 at approximately 10:00 a.m., Georgia Bureau of Investigation (GBI) Special Agent (SA) AMANDA HAMMOCK and SA DAVID PEEBLES were located at the GBI Region 13 Field Office, 108 Woodlawn Drive, Perry, Houston Count, Georgia. While at this location, SA HAMMOCK and SA PEEBLES made contact with ANDY HARPER in reference to this investigation. HARPER was escorted by SA PEEBLES to the conference room for a polygraph examination. SA HAMMOCK did not observe the polygraph examination.

At approximately 11:14 a.m., SA PEEBLES stepped out of the polygraph examination and advised SA HAMMOCK that HARPER declined to take the polygraph. At that time, SA HAMMOCK and SA MADISON HOLLAND entered the conference room and attempted a second interview with HARPER. During the interview, HARPER essentially stated the following:

HARPER has taken a numerous amount of polygraphs and he does not trust the results of a polygraph examination. HAPRER doesn't like the pressure that polygraphs put on him.

HARPER believes the vehicle that BRIANNA WISE drives is in WISE's mother's name. WISE is HARPER's ex-girlfriend and the mother of his children. HARPER does not pay child support but does pay WISE's rent and gives money for groceries for her and their children. HARPER wouldn't want to damage the car that WISE uses because he would probably be the person to pay for the repairs. HARPER stated he did not damage the vehicle WISE drives

HARPER and WISE broke up approximately 10 months ago and HARPER isn't sure who WISE is friends with now. HARPER isn't sure who would have done this to WISE.

In 2017, HARPER found out that WISE was cheating on him with one of his friends. At this time, HARPER was working with Pulaski County Sheriff's Office. HARPER and WISE broke up for a while but then got back together. While in a relationship, HARPER and WISE had another child. HARPER has a history of cheating on WISE as well.

HARPER believes WISE was upset with him because HARPER didn't watch their kids Friday, February 21, 2020 and Saturday, February 22, 2020 . HARPER wasn't sure what WISE planned to do Friday and Saturday.

HARPER has been having to work extra shifts due to shortage of patrol deputies. HARPER has wanted to work the extra shifts for the extra money.

HARPER was called in to work patrol on Saturday, February 22, 2020. Saturday was HARPER's scheduled day off. HARPER was patrolling the north end of Peach County during his shift. While HARPER was patrolling, HARPER noticed his missing iPhone was pinging in the area of a nearby apartment complex. HARPER noticed WISE's vehicle in the parking lot of this same apartment complex. HARPER did not observe any damage to WISE's vehicle at this time. HARPER noticed a Warner Robins Police Department patrol vehicle parked next to WISE's vehicle. Across the lane from WISE's vehicle, HARPER noticed a familiar black truck backed into a parking space. HARPER ran the tag on the black truck and the registered address

was the same apartment complex that WISE resides in.

HARPER believes WISE has his iPhone but will not return it to him.

HARPER asked if he could leave. SA HAMMOCK told HARPER that he was free to leave and HARPER left the interview.

The interview concluded at 11:57 a.m.

On Tuesday, March 17, 2020 at approximately 8:50 a.m., Georgia Bureau of Investigation (GBI) Special Agent (SA) AMANDA HAMMOCK was located at the GBI Region 13 Field Office, 108 Woodlawn Drive, Perry, Houston County, Georgia. While at this location, SA HAMMOCK received a black in color Kyocera cell phone (██████████) from SA LOGAN HOLLAND for the purpose of downloading the data.

The Kyocera cell phone (Model: E4610 / Serial Number: ██████████ / IMEI: ██████████ 3932 113) is owned by the Peach County Sheriff's Office and was being used by ANDY HARPER during his employment with their office. HARPER has since resigned from employment with the Peach County Sheriff's Office.

SA HAMMOCK connected the Kyocera cell phone to the Cellebrite Universal Forensic Extraction device by using Cable A with black tip T-100 in an effort to allow the device to charge and gain battery life.

At approximately 3:00 p.m., SA HAMMOCK noticed the device was fully charged. SA HAMMOCK enabled developer options, set USB debugging to on, enabled MTP and set the screen lock to none. The data was extracted from the device, the sim card and the memory card. The extraction was partially successful. MMS, IM, User Dictionary, Email, Browsing Data and Files were not supported. The Cellebrite failed to extract the contacts from the device.

A Cellebrite Extraction Report was generated and is attached to this summary. A disc containing the data from the Cellebrite extraction is located at the rear of the

The extraction concluded at 4:00 p.m. The Kyocera cell phone was returned to SA HOLLAND.

CHILDRESS determined that HARPER ran one vehicle on February 22, 2020 between 1955 and 2005, Ga tag RRW9117 (2007 Chevrolet Silverado).
