On 07/09/21 Deputy Amanda Donald responded to 237 Deerfield Lane in regards to Nicolas Snow destroying his own property and throwing things at passing vehicles and onto his neighbors' properties. The demented or intoxicated subject was eventually taken into custody after a struggle and handcuffed by Deputy Donald and other deputies. When he refused to get up from the ground Deputy Donald stated "Get the fuck up!" twice and then struck the subject on the side of his face with her fist. The only injury sustained by the subject was limited to scrapes from where he was flailing on the ground. Other strategies for dealing with struggling, combative, or resistant subjects were discussed along with how an event like this can be perceived. Any future violations of a similar nature will result in further disciplinary action.
