

PUBLIC SAFETY TRAINING CENTER. On the evening of Wednesday, May 12, 2021, at approximately 5:00pm, HIRSCH went to dinner at EL TEJADO MEXICAN RESTAURANT in Forsyth County, Georgia. HIRSCH went to the Mexican restaurant with her classmates JASON COLE, STEPHEN PENDERGRASS, ERIC WHITE, BRANDON CROCKER, JUSTIN JONES, and QUAMERE ROOKS. HIRSCH rode to the restaurant with JONES, ROOKS, and PENDERGRASS, and JONES drove his GBI issued vehicle. All the Agents had alcoholic beverages with their dinner, except for JONES. HIRSCH ordered a jalapeno margarita and drank half of it because it was gross/very strong. HIRSCH also drank a Jack Daniels and Diet Coke at the restaurant. After the Agents left the Mexican restaurant, they all went to the FOX CITY BREWERY COMPANY to have more drinks. BRANDON CROCKER did not go to the Brewery with the other Agents. The Agents recognized several of their classmates leaving the brewery as the Agents were going inside the brewery. The Agents walked to the back of the restaurant and ordered a round of drinks. HIRSCH had another Jack Daniels and Diet Coke. While at the brewery HIRSCH had several more Jack Daniels and Diet Coke drinks. HIRSCH's coworker at WEST METRO REGIONAL DRUG ENFORCEMENT OFFICE, ADAM BLANE, bought HIRSCH another shot of Jack Daniels and a Coke before he left the restaurant. BLANE was in Forsyth attending training at the GEORGIA PUBLIC SAFETY TRAINING CENTER. HIRSCH did not know what time they left the brewery, because everything became hazy to her. HIRSCH knows that she rode back to the Police Academy with JASON COLE, but she did not recall arriving on campus. The next thing that HIRSCH remembers is CHARLIE JOHNSTON knocking on ROOKS' vehicle window. HIRSCH thinks that the loud noise of JOHNSTON knocking on the window brought her back for a couple of minutes,

although she did not remember what was said, and she did not remember when or why she got into the vehicle with ROOKS. HIRSCH considered ROOKS a good friend and they have a good friend relationship. While the Agents were at the brewery, they were talking about their significant others and HIRSCH called her boyfriend and chatted with him. HIRSCH did not recall walking back to her dormitory room, but she slightly remembers being upset and crying when she got back to her room. HIRSCH'S roommate KAREN WILBANKS asked HIRSCH what was wrong, and HIRSCH did not remember exactly what she said to WILBANKS. HIRSCH feels that being drunk made her emotional, as well as taking the prescription Accutane and Trazodone. HIRSCH is not certain why she was crying. HIRSCH stated that she asked WILBANKS the next morning what happened and WILBANKS explained to her that she got back to the room around 9:45pm and she was crying. HIRSCH stated that WILBANKS told her that she had made the comment the night before that she is tired of people taking advantage of her but did not give many details. HIRSCH did not think that ROOKS would intentionally harm or disrespect her. HIRSCH remembers WHITE and RICHARDSON being in their room at some point and RICHARDSON asked HIRSCH if she was okay and HIRSCH nodded her head. CARLA DUTTON arrived on campus around 2:00am, and DUTTON told HIRSCH to get dressed and they were going to go to the Training Office to talk to SAC BILL BODREY. HIRSCH did not recall many details of the night once they left the brewery. HIRSCH felt embarrassed and disappointment in herself because she brought a lot on herself to consume more than a couple cocktails. HIRSCH did not have any injuries or marks on her body, and she felt fine. On the following day, during class break, HIRSCH asked ROOKS what had happened the night before. ROOKS advised HIRSCH that she was upset

with her boyfriend, HUNTER, and that is why she was emotional and crying. ROOKS told HIRSCH that they had called HUNTER on two occasions when HIRSCH was in the vehicle with ROOKS. HIRSCH stated that ROOKS told her that he started to perform oral sex on her and that is when CHARLIE JOHNSTON knocked on the window. JOHNSTON did not know it was HIRSCH in the vehicle. HIRSCH did not believe that ROOKS' actions were unwarranted. HIRSCH feels that if ROOKS' actions were unwarranted, she would have been fighting and struggling to get away. HIRSCH did not know why she let those actions happen, but she trusts ROOKS and knows he will not harm her. HIRSCH feels that she overreacted due to her being drunk and not sleeping much. HIRSCH apologized for overreacting, and she apologized for causing strain on her Instructors and the Command Staff. HIRSCH did not feel that ROOKS did anything wrong. HIRSCH did not feel that ROOKS took advantage of her because she was drunk. HIRSCH remembered eating some of JUSTIN JONES' apple pie at the brewery, and she knows that ROOKS had some of the pie, but she did not remember feeding the apple pie to ROOKS. HIRSCH vaguely remembers talking about sex while she and the other Agents were at the brewery. HIRSCH blacks out easily and that is why she does not typically drink a whole lot. HIRSCH had a total of five Jack Daniels and Coke on that particular night and a half of a jalapeno margarita. HIRSCH feels that if ROOKS thought the oral sex between them was consensual, then it was consensual. HIRSCH is currently taking 2 prescribed medication, Trazodone and Accutane.

- THAD JOBE – THAD JOBE is a SPECIAL AGENT with the GBI, and he has worked for the GBI since November 2016. JOBE is currently assigned to the

APPALACHIAN DRUG TASK FORCE. On Wednesday, May 12, 2021, JOBE was located at the GEORGIA PUBLIC SAFETY TRAINING CENTER, Forsyth, Georgia training the new Agents in the BASIC AGENT CLASS in reference to death investigations involving opioid overdose. After class JOBE, along with AGENTS CHRIS FROGNER and HANNAH SHEARER and CASEY PATTERSON, went to FOX CITY BREWERY COMPANY for dinner. All Agents work together at the APPALACHIAN REGIONAL DRUG ENFORCEMENT OFFICE. Once at the brewery, JOBE and PFRONGER ordered beer with their dinner, and SHEARER and PATTERSON did not order any alcohol. As JOBE and other Agents were leaving the brewery, they noticed another group of BASIC AGENT CLASS Agents walking towards the restaurant. JOBE recognized HIRSCH and ROOKS because they had asked for copies of search warrant go-by's related to overdose investigations. The group wanted JOBE and other Agents to come back inside and have more drinks with them, but JOBE and the other Agents refused. At approximately 6:45, JOBE drove PFROGNER back to the GEORGIA PUBLIC SAFETY TRAINING CENTER and dropped him off, and JOBE drove to his residence. PATTERSON and SHEARER rode in SHEARER'S vehicle back to the GEORGIA PUBLIC SAFETY TRAINING CENTER. JOBE had two beers with his dinner at the FOX CITY BREWERY COMPANY. JOBE was driving his GBI issued vehicle when he drove to FOX CITY BREWERY and when he drove PFROGNER back to the GEORGIA PUBLIC SAFETY TRAINING CENTER. JOBE drove his GBI issued vehicle home after dropping PFROGNER off at the training center.

- CHARLIE JOHNSTON – CHARLIE JOHNSTON is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION. JOHNSTON has worked for the GBI

since September 2020 and he is assigned to the GBI REGION 9 Thomasville, Georgia Office. JOHNSTON is currently attending the 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On Wednesday, May 12, 2021, around 7:30pm, JOHNSTON and BRIAN WHITE started practicing picking locks in Room 108 at the Police Academy. ERIC WHITE came by JOHNSTON'S room and advised JOHNSTON that there were some students from the class that were drinking, and QUAMERE ROOKS had stated that he wanted to go home to see his wife. At approximately 9:00pm, JOHNSTON was in the parking lot near the tracks in the GEORGIA PUBLIC SAFETY TRAINING CENTER speaking with his wife on the cell phone and doing crossword puzzles. JOHNSTON had earlier drank a small amount of alcohol from a bottle while sitting in JASON COLES' government vehicle. This is a routine that JOHNSTON does with his wife nightly. JOHNSTON spoke with JUSTIN JONES and JASON COLE who were near JOHNSTON'S vehicle in reference to them going out to dinner. JOHNSTON was waiting for his wife to call him back. JOHNSTON noticed MEGAN HIRSCH and QUAMERE ROOKS sitting in a grey Tahoe. ROOKS was sitting in the front driver's seat, and HIRSCH was sitting in the front passenger seat. At approximately 9:10pm, CHARLIE sat in his GBI issued vehicle to talk with his wife when he noticed brake lights turn on for the vehicle that ROOKS and HIRSCH were sitting in. JOHNSTON then noticed the backup lights on the vehicle came on and the vehicle backed out of its parking spot, almost hitting several vehicles. The vehicle that ROOKS and HIRSCH were riding in proceeded forward, nearly striking several vehicles on the opposite side of the parking lot. After witnessing this, JOHNSTON advised his wife that he needed to go because he felt that someone may be making bad decisions. JOHNSTON remembered that ROOKS had stated earlier that he was going to his

residence, that he needed to see his wife. JOHNSTON thought that he was going to have to use his vehicle to perform a traffic stop on ROOKS if he left the parking lot. JOHNSTON thought that ROOKS was the only person in the vehicle when the vehicle went from the parking area near the track to the parking area on the eastside of the parking lot, near the perimeter road. JOHNSTON pulled his vehicle to the westside of the vehicle. JOHNSTON parked his vehicle and got out to check on the occupant of the vehicle. JOHNSTON knocked on the front driver's side window but did not see anyone inside. JOHNSTON opened the driver's side door and it was unlocked. JOHNSTON peeked into the vehicle and saw two people in the backseat. JOHNSTON noticed a white female lying on her back with her head pointing towards the passenger side of the vehicle. JOHNSTON also noted there was a black male on top of her facing the same direction. JOHNSTON could see the female legs in the air, and it looked like her hands were on the black males back. JOHNSTON felt that the two occupants were QUAMERE ROOKS and MEGAN HIRSCH. CHARLIE called out to the two people and stated that whatever the two were doing, they needed to stop, and they needed to go to bed. JOHNSTON recognized the voice of the black male as QUAMERE ROOKS, and ROOKS asked JOHNSTON why was he in the vehicle. JOHNSTON did not observe anything that led him to believe that the sexual encounter occurring was not consensual. The female did not say anything in JOHNSTON'S presence. JOHNSTON returned to his previous parking spot and continued talking to his wife until approximately 9:23pm. JOHNSTON explained to his wife what had just happened. JOHNSTON went to his room at approximately 9:34pm when he finished talking with his wife. JOHNSTON noticed that he had missed three calls from ROOKS: twice at 9:26 pm, and once at 9:52 pm. JOHNSTON heard a

knocked on his door shortly after the missed phone calls at 9:26 pm. JOHNSTON'S roommate, MATT PEARCE, opened the door and ROOKS entered the room. ROOKS walked over to JOHNSTON'S bed and asked JOHNSTON several times how he had found him. JOHNSTON told ROOKS to leave his room and JOHNSTON told ROOKS that they could talk about the situation in the morning. ROOKS did not leave the room and said he wanted to talk about it now. JOHNSTON saw JUSTIN JONES standing behind ROOKS and asked JONES to get ROOKS out of his room. JOHNSTON told his roommate MATT PEARCE not to answer his phone or the door anymore that evening, and they both went to sleep. At approximately 11:10pm, PEARCE received a call from CLASS PRESIDENT JAMES RICHARDSON, and RICHARDSON advised PEARCE that he needed to talk to JOHNSTON in reference to the situation that happened earlier. JOHNSTON and RICHARDSON talked about what happened. RICHARDSON advised JOHNSTON that he had called DUTTON and advised her of what was going on.

- JUSTIN JONES – JUSTIN JONES is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and JONES has worked for the GBI since September 2020. JONES is assigned to the SOUTHWESTERN REGIONAL DRUG ENFORCEMENT OFFICE. JONES is currently attending the 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On Wednesday, May 12, 2021, at approximately 10:00am during a class break, JONES, ROOKS, and HIRSCH walked to the cafeteria at the Police Academy. On the way back from the cafeteria, ROOKS told HIRSCH in the hallway that she had something on her butt and HIRSCH told ROOKS to get it off. ROOKS asked HIRSCH if she was sure she wanted him to get it off, and HIRSCH told him it was okay. ROOKS grabbed a

loose string off HIRSCH'S backside. Later that afternoon after class, JONES, ROOKS, HIRSCH, and PENDERGRASS went to EL TEJADO MEXICAN RESTAURANT at approximately 5:00pm. JONES drove his GBI issued vehicle and the other three Agents rode with him. After arriving at the Mexican restaurant, the Agents were joined by JASON COLE and ERIC WHITE. While at the restaurant, someone made the comment that ROOKS is always erect in front of the class when stretching for PT in the morning. HIRSCH stated that she didn't know if she should look or cover her eyes. Everyone in the group was drinking, except for JONES. HIRSCH suggested they go to the FOX CITY BREWERY COMPANY because other classmates were going to go there. HIRSCH decided to ride with COLE, and PENDERGRASS rode with WHITE. ROOKS rode with JONES to the brewery. Once the Agents arrived at the brewery, they recognized HANNAH SHEARER, THAD JOBE, CHRIS PFROGNER and CASEY PATTERSON leaving the brewery. Once the Agents got seated in the brewery, all the Agents began to drink alcoholic beverages, except for JONES. JONES ordered a water and apple pie with ice cream on top. While waiting on his apple pie, JONES overheard conversations at the table between PENDERGRASS and WHITE, and ROOKS and HIRSCH. JONES noticed that the conversation between ROOKS and HIRSCH became more sexual. After the waitress brought JONES his apple pie, HIRSCH asked if she could try some of it. The waiter gave an extra spoon for HIRSCH and she ate a few bites of apple pie, and then fed some to ROOKS. HIRSCH and ROOKS called HIRSCH'S boyfriend several times while at the restaurant. HIRSCH started a conversation in reference to her boyfriend not pleasing her and not being into the same sexual activities as her. HIRSCH stated that she doesn't want to look like a slut to her boyfriend by requesting certain things. HIRSCH asked the group



how she can get her boyfriend to be more open. JONES noticed that ROOKS and HIRSCH began talking amongst themselves and were whispering in each other's ears. JONES noticed HIRSCH bend over the table with her back arched, and she asked the group if that is the way she should do it. There was more sexual talk that went on in reference to HIRSCH'S frustrations, and ROOKS shared that he doesn't have those problems satisfying his wife. The Agents arrived back at the GEORGIA PUBLIC SAFETY TRAINING CENTER at approximately 8:00pm. When JONES and ROOKS parked in the parking lot of GPSTC, JONES and ROOKS started walking towards the dormitory rooms when HIRSCH and COLE pulled into the campus. ROOKS called HIRSCH and HIRSCH invited JONES and ROOKS to the truck where she and COLE had parked. As JONES and ROOKS approached COLE'S truck, HIRSCH flagged them down. COLE was sitting in the driver's seat of the truck, HIRSCH was in the front passenger seat, ROOKS in the rear driver's seat, and JONES in the rear passenger seat. COLE took out a bottle of alcohol and a coke. ROOKS and HIRSCH drank some of the alcohol and coke. JAMES RICHARDSON and LUCAS BEYER walked up to the truck and began talking to ROOKS. ROOKS got HIRSCH'S phone and called HIRSCH'S boyfriend. ROOKS and HIRSCH'S boyfriend discussed hanging out and ROOKS sent him his number. ROOKS stated that HIRSCH'S boyfriend seemed frustrated. JONES advised HIRSCH that it was time for her to go to her room, and JONES offered to walk her there. ROOKS walked over to the passenger seat and started talking to HIRSCH. HIRSCH began crying and saying that she has had a rough life and something to the effect of being depressed all the time. ROOKS asked HIRSCH to come and sit with him in his truck. JONES told ROOKS and HIRSCH to go to their rooms, and COLE told them the same things. JONES attempted again to try and get HIRSCH

and ROOKS to go their room, but they refused to go. JONES noticed HIRSCH walk over to ROOKS truck and get into the passenger seat. ROOKS got into the driver's seat of his GBI vehicle. JONES went to his room, and later that night, he noticed several people standing outside and ROOKS walking up the paths to the rooms. JONES noticed ROOKS walk into CHARLIE JOHNSTON'S room and asked to speak with him. JOHNSTON advised ROOKS that he was in bed, and they would talk in the morning. The CLASS PRESIDENT, JAMES RICHARDSON, called the Instructors of the Academy and ROOKS went into JONES' room. ROOKS told JONES that he and HIRSCH had sex and JOHNSTON busted in on them in the parking lot. ROOKS told JONES that the sex was consensual, and that HIRSCH started crying after JOHNSTON busted in on them, and now he is worried she might say that she did not want to in order to save her relationship. The following day, May 13, 2021, while in class, JONES asked HIRSCH if she was okay. HIRSCH stated that she doesn't remember what happened the night before. When ROOKS sat down, HIRSCH rubbed ROOKS arm, looked at him, and turned back around. JONES feels that the sex between ROOKS and HIRSCH was consensual due to the fact the way HIRSCH was talking about sex all night.

- ANNIE MOORMAN – ANNIE MOORMAN is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and she has worked for the GBI since September 2020. MOORMAN is assigned to the GBI REGION 7 Thompson, Georgia office. MOORMAN is currently in the 2021 BASIC AGENT CLASS. On Wednesday, May 12, 2021, MOORMAN met with SAC BILL BODREY for approximately 20 minutes after she left class. After the meeting with SAC BODREY, MOORMAN left the GEORGIA PUBLIC SAFETY TRAINING CENTER
