

Campus and went to Dunkin Donuts. MOORMAN returned to the GEORGIA PUBLIC SAFETY TRAINING CENTER at approximately 5:30pm and remained in her vehicle and conducted a private phone call to her husband for approximately 20-30 minutes. After the phone call with MOORMAN'S husband, she returned to her dormitory room 103 and remained there the rest of the night.

- JAMES MORGAN – JAMES MORGAN is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and he is assigned to the GBI REGION 12 Eastman, Georgia office. MORGAN is currently attending the GBI 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On the evening of May 12, 2021, after class, MORGAN went to his dormitory room and took a nap. MORGAN woke up and went to Classroom 108 to work on summaries. At approximately 11:00, MORGAN returned to his dormitory room for the evening and went to sleep. MORGAN did observe QUAMERE ROOKS standing in the doorway of JUSTIN JONES' dormitory room. Both ROOKS and JONES appeared to be calm, and MORGAN acknowledged ROOKS before going to sleep.
- CASEY PATTERSON – CASEY PATTERSON is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and she is assigned to the GBI REGION 10 Conyers, Georgia office. PATTERSON has worked for the GBI since January 2020. PATTERSON is currently attending the GBI 2021 BASIC AGENT CLASS. On the evening of Wednesday, May 12, 2021, after dismissal from class, PATTERSON went to her room and changed clothes. PATTERSON went with HANNAH SHEARER to the FOX CITY BREWERY on the Square in Forsythe,

Georgia. PATTERSON and SHEARER met with THAD JOBE and CHRIS PFROGNER and had dinner for about an hour and a half. PATTERSON did not drink any alcohol while she was there at the brewery. SHEARER did not drink any alcohol either. As the Agents were leaving the brewery to return to the Training Center, they passed several classmates in the parking lot who were on their way to go inside the brewery. PATTERSON recognized MEGAN HIRSCH, JASON COLE, STEPHEN PENDERGRASS, ERIC WHITE, and QUAMERE ROOKS as Agents going into the brewery. The Agents returned to the Training Center around 6:30pm, and PATTERSON stayed in her room for the remainder of the night working on assignments. PATTERSON was in her bed asleep by 9:00pm. PATTERSON woke up several times throughout the night to yelling and doors slamming outside. PATTERSON was unable to discern what was going on and she stayed in her bed the entire night.

- MATTHEW PEARCE – MATTHEW PEARCE is a SPECIAL AGENT with the GEORGIA DEPARTMENT OF CORRECTIONS. PEARCE has worked for the GEORGIA DEPARTMENT OF CORRECTIONS for approximately 13 months. PEARCE is currently attending the GBI 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On the evening of May 12, 2021, PEARCE went to his room after class and watched Netflix until approximately 7:00pm. At approximately 7:00pm, PEARCE received a text message from his friend who works for the COLUMBUS POLICE DEPARTMENT requesting to go to dinner. PEARCE and his friend went to the FOX CITY BREWERY COMPANY for dinner. PEARCE observed JASON COLE and COLE advised PEARCE that some of the class was present in the restaurant. PEARCE'S

friend from the COLUMBUS POLICE DEPARTMENT was of the opposite gender, and he was aware of potential gossip and speculation amongst his classmates if they saw him with her. PEARCE decided to relocate dinner plans to JONAH'S PIZZA SHOP. PEARCE did not consume any alcoholic beverages while at the Pizza Shop. At approximately 8:00 pm, PEARCE observed COLE, HIRSCH, WHITE and ROOKS returning to their vehicles from FOX CITY BREWERY COMPANY. There were other people with the Agents, but PEARCE does not recall who they were. When PEARCE returned to his room, he noticed ERIC WHITE, CHARLIE JOHNSTON and BRIAN WHITE located in the barracks. JOHNSTON was showing BRIAN WHITE and ERIC WHITE how to pick a lock. At approximately 8:30, the Agents left PEARCE'S room, and PEARCE put on his CPAP machine and watched Netflix on his phone. JOHNSTON returned to the room, and JOHNSTON and PEARCE had a brief conversation, and JOHNSTON went to bed. At approximately 9:55pm, PEARCE heard a knock on the door of his barracks. PEARCE answered the door and observed QUAMERE ROOKS and JUSTIN JONES in the doorway. ROOKS advised PEARCE that he needed to talk with JOHNSTON. PEARCE noticed that ROOKS had slurred speech, was unsteady on his feet, and an odor of alcoholic beverages coming from his person. PEARCE allowed ROOKS into the barracks and then went to the restroom. After PEARCE returned from the restroom, he noticed JONES trying to get ROOKS out of the room. PEARCE heard ROOKS make the statement, "I don't want to have to beat someone's ass, don't let that be you, CHARLIE." ROOKS then left the barracks. PEARCE asked JOHNSTON what was going on, and JOHNSTON replied, "don't worry about it." At approximately 10:05, PEARCE received a call from ROOKS on his cell phone, and ROOKS requested that PEARCE send JOHNSTON outside the

room. JOHNSTON told PEARCE to tell ROOKS that he was not coming outside and that's when ROOKS asked PEARCE to open the door to his barracks. JOHNSTON advised PEARCE it was not a good idea to answer the door. At approximately 10:15, PEARCE observed knocking on his door and windows, and PEARCE heard JAMES CRAFT state "it's not worth it, you have a good job, and you don't want to throw it away." PEARCE went to sleep and at approximately 11:15, PEARCE received a telephone call from ERIC WHITE. WHITE advised PEARCE to have JOHNSTON meet with CLASS PRESIDENT RICHARDSON in his vehicle in the parking lot. Again, PEARCE asked ERIC WHITE what was going on and if everyone was going to be okay, and WHITE advised PEARCE that he did not know. PEARCE told JAMES RICHARDSON that if ROOKS needed someone to speak to, he didn't mind because PEARCE has had a problem in the past with alcoholism. RICHARDSON advised PEARCE not to worry about anything. PEARCE drove his government vehicle to the brewery and to the pizza house, but he did not consume any alcoholic beverages.

- MICHAEL PEARSON – MICHAEL PEARSON is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION. PEARSON worked for the GBI from 1995 to 2005. PEARSON returned to the GBI in September 2020. PEARSON is currently attending portions of the 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. PEARSON is assigned to the GBI REGION 8, Cleveland, Georgia office. On the evening of May 12, 2021, PEARSON ate dinner at the GEORGIA PUBLIC SAFETY TRAINING CENTER cafeteria and returned to his dormitory room to complete homework assignments. After about an hour, PEARSON left the GEORGIA PUBLIC SAFETY TRAINING CENTER

campus and went and filled up his gas tank at a convenience store near the campus. PEARSON did not have any interaction with other students of the 2021 BASIC AGENT CLASS that evening, and PEARSON went to sleep between 10:00 and 11:00pm.

- STEPHEN PENDERGASS – PENDERGRASS is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and he's worked for the GBI since September 2020. PENDERGRASS is assigned to the WEST METRO DRUG TASK FORCE. PENDERGRASS is currently attending the GBI 2021 BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On the evening of Wednesday, May 12, 2021, PENDERGRASS went to EL TEJADO MEXICAN RESTAURANT with classmates QUAMERE ROOKS, JUSTIN JONES, and MEGAN HIRSCH. JUSTIN JONES drove his GBI assigned vehicle to the restaurant. Once at the restaurant, the Agents were joined by ERIC WHITE, BRANDON CROCKER, and JASON COLE. At the restaurant, PENDERGRASS had two beers with his dinner, and he observed ROOKS and HIRSCH have approximately two to three drinks. PENDERGRASS believed that HIRSCH had a margarita and a shot of alcohol. PENDERGRASS believed ROOKS had one to two shots of alcohol and a beer. Everybody had an alcoholic drink except JONES. At approximately 6:12pm, the Agents decided to go to FOX CITY BREWERY COMPANY, and PENDERGRASS rode with ERIC WHITE. Once at the brewery, the Agents were joined by HIRSCH, JONES, ROOKS, and COLE. At the brewery, PENDERGRASS consumed two to three beers, and he observed HIRSCH and ROOKS continue to drink heavily, including shots of alcohol. At approximately 8:09pm, PENDERGRASS left the brewery with ERIC WHITE. When

PENDERGRASS and WHITE left the brewery, the rest of the Agents were still inside the brewery. PENDERGRASS arrived at the GEORGIA PUBLIC SAFETY TRAINING CENTER at 8:19pm, and he stayed in his room until he was awakened by his alarm at 5:00am. While at the brewery, the conversations became sexual, and HIRSCH stated, how can she tell her significant other what she wanted in the bedroom. PENDERGRASS remembered HIRSCH making a comment and making a motion in reference to oral sex. PENDERGRASS felt that ROOKS and HIRSCH were intoxicated.

- CHRIS PFROGNER – CHRIS PFROGNER is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and he has worked for the GBI since February 2020. PFROGNER is assigned to the WEST METRO REGIONAL DRUG ENFORCEMENT OFFICE. PFROGNER is currently attending the 2021 GBI BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On the evening of May 12, 2021, after PFROGNER was released from class, he returned to his room to change clothes. At approximately 5:30pm, PFROGNER rode with THAD JOBE to dinner at FOX CITY BREWERY COMPANY in Forsyth, Georgia. PFROGNER consumed one beer with his dinner. PFROGNER and JOBE were joined by HANNAH SHEARER and CASEY PATTERSON at the restaurant. At approximately 7:30pm., PFROGNER, PATTERSON, SHEARER and JOBE left the restaurant. As the Agents were leaving the restaurant, they noticed several more Agents that were coming to the restaurant. JOBE drove PFROGNER back to the GEORGIA PUBLIC SAFETY TRAINING CENTER. PFROGNER worked on homework for the following day, then PFROGNER went to sleep around 9:30pm.

- JAMES RICHARDSON – JAMES RICHARDSON is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION. He has worked for the GBI since September 2020. RICHARDSON is assigned to the GBI REGION 2, Columbus, Georgia office. RICHARDSON is currently attending the BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER, and RICHARDSON is the CLASS PRESIDENT. On the evening of May 12, 2021, at approximately 8:45pm, RICHARDSON was in his dormitory room at the GEORGIA PUBLIC SAFETY TRAINING CENTER studying. LUCAS BEYER knocked on RICHARDSON'S door and advised RICHARDSON that several classmates had went off campus for dinner at a local Mexican restaurant and may be heavily intoxicated. While BEYER was relaying this information to RICHARDSON, BEYER received a call on his cell phone from QUAMERE ROOKS. BEYER put the cell phone on speaker, and RICHARDSON felt that ROOKS sounded intoxicated. RICHARDSON heard ROOKS state to BEYER that they were back on campus in the parking lot, so RICHARDSON and BEYER took it upon themselves to go and check on the group. When RICHARDSON and BEYER arrived in the parking lot, RICHARDSON observed GDC AGENT JASON COLE standing outside of his assigned vehicle smoking a cigarette. RICHARDSON then noticed MEGAN HIRSCH sitting in the front passenger seat of COLE'S vehicle. HIRSCH seemed intoxicated. HIRSCH had a bottle of brown liquor in her hand, and a coke bottle in the other hand. RICHARDSON stated his disapproval of seeing the bottle. RICHARDSON did not see anyone within consume any of the alcohol at that time. RICHARDSON noticed JUSTIN JONES was seated in the rear passenger seat of COLE'S vehicle, and ROOKS was seated in the rear driver's seat with the window partially down. RICHARDSON returned back to his barracks, and he encountered GDC AGENT

KAREN WILBANKS, who is a roommate of HIRSCH. RICHARDSON informed WILBANKS that HIRSCH was intoxicated and to make sure that she gets up in the morning for the class assigned PT session. RICHARDSON returned back to his room at approximately 9:01pm. JUSTIN JONES told RICHARDSON that ROOKS and HIRSCH was last seen getting into ROOKS' assigned GBI vehicle in the parking lot. RICHARDSON was informed that HIRSCH was in her assigned room crying. RICHARDSON stood outside of HIRSCH's room, and RICHARDSON noticed ROOKS walk from the parking lot with HIRSCH's handheld wallet in his hands. ROOKS appeared to be frustrated and agitated at the time. RICHARDSON asked ROOKS to go to his room, and ROOKS walked in the direction of his room. WHITE advised RICHARDSON that HIRSCH wanted to talk to him. RICHARDSON entered HIRSCH'S AND WILBANKS' room. RICHARDSON asked HIRSCH what happened, and she stated to RICHARDSON "something bad". HIRSCH then told RICHARDSON that she was seated in ROOKS' vehicle, and ROOKS exposed his bare penis to her. HIRSCH advised RICHARDSON that after ROOKS showed her his exposed penis, CHARLIE JOHNSTON opened her passenger side door and pulled her out of the vehicle, and she returned to her room. HIRSCH stated that nothing else happened other than ROOKS showing her his penis, and she did not require any medical treatment. After RICHARDSON left HIRSCH'S room, he overheard ROOKS yelling obscenities outside of the barracks at the door of CHARLIE JOHNSTON. RICHARDSON asked ROOKS for his assigned GBI vehicle car keys, and ROOKS gave the keys to RICHARDSON. RICHARDSON left and contacted SPECIAL AGENT 3 CARLA DUTTON to inform her of what had transpired. RICHARDSON returned to his assigned room and remained with ROOKS with the assistance of JONES and BEYER until DUTTON arrived on the



campus. Prior to DUTTON arriving on the campus, RICHARDSON observed ROOKS kicking JOHNSTON'S dormitory room door and calling JOHNSTON a nigger.

- QUAMERE ROOKS - QUAMERE ROOKS is a SPECIAL AGENT with the GEORGIA BUREAU OF INVESTIGATION, and he has worked for the GBI since September of 2020. ROOKS is assigned to the GBI REGION 7 Thompson, Georgia Office. ROOKS is currently attending the GBI BASIC AGENT CLASS at the GEORGIA PUBLIC SAFETY TRAINING CENTER. On the evening of Wednesday, May 12, 2021, ROOKS went to dinner at a Mexican restaurant in Forsyth, Georgia with several of his classmates. ROOKS ate dinner at the restaurant with JUSTIN JONES, JASON COLE, MEGAN HIRSCH, STEPHEN PENDERGRASS, BRANDON CROCKER, and ERIC WHITE. ROOKS, HIRSCH and PENDERGRASS rode with JUSTIN JONES in his GBI issued vehicle. BRANDON CROCKER, ERIC WHITE, and JASON COLE joined the Agents at the restaurant. All the Agents at the Mexican restaurant had alcoholic beverages, except for JUSTIN JONES. After leaving the Mexican restaurant, the Agents decided to go to JONAH'S to have more drinks. After leaving the Mexican restaurant HIRSCH got into the vehicle with JASON COLE, and JUSTIN JONES drove ROOKS and PENDERGRASS to the restaurant. Once at the restaurant, the Agents had more drinks. While at the restaurant, ROOKS talked to HIRSCH's boyfriend on the telephone. After leaving the restaurant, the Agents went back to the Police Academy. ROOKS rode back to the Academy with JONES, and PENDERGRASS and HIRSCH rode back with COLE. Once back at the Academy, the Agents continued drinking in the parking lot, but ROOKS do not remember that part. After

getting back to the Police Academy parking lot, ROOKS was talking about going to see his wife, so LUCAS BEYER came out and told ROOKS that he did not need to be driving to go see his wife. HIRSCH started getting emotional and ROOKS stated to HIRSCH that they can get in his vehicle and talk. HIRSCH willingly got into ROOKS' GBI issued vehicle, and she started crying about her life not going the way she wants it to go and issues with her boyfriend. At that point, ROOKS and HIRSCH called HIRSCH'S boyfriend and talked to him on two different occasions while sitting in the vehicle. After ROOKS and HIRSCH finished talking with HIRSCH's boyfriend, ROOKS and HIRSCH started talking about their sex lives. ROOKS confided in HIRSCH about his and his wife's sex life. HIRSCH told ROOKS that her boyfriend is not as sexual as she was. ROOKS told HIRSCH that he likes sex. ROOKS and HIRSCH looked at each other and ROOKS suggested that they should have sex, and HIRSCH agreed. HIRSCH takes her pants off and ROOKS started performing oral sex on HIRSCH. ROOKS decided that they needed to move from the location that they were parked, and he drove his vehicle to another area in the parking lot close to the obstacle course. ROOKS told HIRSCH that they should get in the back seat and HIRSCH gets in the back seat of ROOKS' vehicle. ROOKS got into the back seat with HIRSCH and continued to perform oral sex on her. HIRSCH did not express to ROOKS at any time that she was not comfortable and that she did not want to do that. ROOKS and HIRSCH agreed to do that. ROOKS was in the process of taking his pants off to have intercourse with HIRSCH when he heard a knock on the window. CHARLIE JOHNSTON opened the door and stuck his head in and said, "Hey man, ya'll need to go, ya'll need to go." ROOKS did not know if JOHNSTON saw HIRSCH in the vehicle or not. ROOKS told JOHNSTON to get away from the car. At that point
