

FM: Hmm. Okay, according to several statements that you were, you were crying at the bar, I believe, or somewhere at that, at that brewery.

MH: So –

FM: After you was talking to HUNTER.

MH: -- and later in my statement, after I talked to ROOKS –

FM: Mm hmm.

MH: – ROOKS told me you were really upset. That is how I got into ROOKS' vehicle. He said that I was in his vehicle and that he was trying to comfort me, make me feel better and that we had talked to HUNTER a couple times, or tried calling HUNTER a couple times on the phone, which we did. I looked on my phone and I asked my boyfriend, HUNTER, which he confirmed that.

FM: Okay, so you said that, you knew that what's his name knocked on the window –

MH: CHARLIE JOHNSTON.

FM: Yeah, CHARLIE JOHNSTON knocked on the window and you knew it was him.

MH: Then, can I backtrack real quick?

FM: Yeah.

MH: When I'm talking to KAREN, my roommate, KAREN said, or KAREN said that I said that CHARLIE, CHARLIE stopped her. He saved me. So, that's also why I believe something happened.

FM: CHARLIE said that to you?

MH: No, I said that to KAREN.

FM: Okay.

MH: KAREN's my roommate.

FM: Okay. So, are you saying that you think –

MH: Well, now I know something happened because Q told me.

FM: Okay.

MH: At this point I'm kind of, I'm not quite sure. I feel like something happened, and even in my statement to BILL and CARLA, I said I feel like something happened because I wouldn't be this upset. But I'm not positive what happened.

FM: Okay.

MH: And when I was talking to CARLA yesterday, she told me that I made the statement that I saw Q's penis, which I do not recall.

FM: Okay. So, you don't recall seeing his penis?

MH: No sir.

FM: Okay, but you told someone that you did that night?

MH: CARLA and BILL.

FM: Okay.

MH: Well, CARLA reminded me I said that, and that's when we were talking about the seriousness of -- I'm, I'm nervous going forward because I – If you were to put me on the stand, I couldn't be like 100 percent, yes, I know this has happened, because this is not – I don't know this happened. But what I've been told, obviously something has happened.

FM: Okay.

MH: And I'm upset because Q and I are friends, and he knows that I was drunk. If, if it was unwarranted, it's still I'm drunk, still not necessarily right. And when I, when I

talked to him, he's like I didn't know you were, you were drunk. He's like I didn't know you were that blacked out. You were talking, and like I understand that.

FM: Oh gosh. I –

MH: I know. I understand it's like – I feel like it's very difficult because I don't recall.

FM: Yeah.

MH: I only know certain things because of what people had told me. I'm not trying to sit here and get anyone in trouble. I'm just trying to be honest with what I remember.

FM: Yeah. Well, why would you tell them that night that you saw his penis? You told CARLA and BILL you saw his penis and –

MH: I must, it must have happened. I mean also you have to remember it was 2:00 am.

FM: Mm hmm.

MH: Still probably under the influence, hadn't really slept at all. I understand why they took my statement, but I also feel like they probably could've let me a sleep a little bit longer.

FM: This is some serious allegations.

MH: Okay, I understand that.

FM: Yeah.

MH: And that's what I had talked to CARLA about, and I said I'm uncomfortable and I'm scared because I'm not trying to ruin anyone's career, my career. I don't necessarily 100 percent without a, without a doubt know this happened. But it

also makes, like, if what he said happened, well, how do I know something else didn't happen?

FM: What did Q tell you he did to you?

MH: That he had oral sex with me, and that's when CHARLIE knocked on the window.

FM: So, he said that you took your pants off. Do you remember that?

MH: He told me that.

FM: Do you remember that?

MH: I do not remember that.

FM: Okay. Okay, so if you, so what do you think about it now, after he told you what happened? What do you think?

MH: I think yesterday I was kind of like, what the hell is going on, and I still kind of feel like that.

FM: Okay.

MH: I'm upset because Q and I are such good friends. He would know if I was sober, and I'm sure if he was sober, that that wouldn't have happened. The, the only thing I can say is we both were drunk. It was first of all, not professional. Shouldn't have happened. We talked yesterday. It wasn't like it was awkward. It was both of us were like what the hell is going on. He said that –

FM: Do you think he did anything wrong?

MH: I don't think so, and I don't – and CARLA asked me, she's like, do you feel like physically hurt? And I said, no.

FM: So, with you being drunk, do you think he took advantage of you?

MH: I don't think he took advantage of me, like advantage of me. I'm just upset that that stuff happened because I was drunk and probably because he was drunk.

FM: Okay.

MH: I understand him saying, I was trying to comfort you and make you feel better because Q was very lovey dovey like that.

FM: Do you remember, while ya'll were at Jonah's, the conversation turned to sex?

MH: I didn't even know that we went to Jonah's, the pizza place?

FM: Oh no, the brewery, the brewery, brewery.

MH: Foxes.

FM: Yeah, some people call it Jonah's, some people call it the brewery place. I'm reading all these different statements, but when, and the second place ya'll went to.

MH: The brewery.

FM: Okay, the brewery.

MH: I was never at – I don't think any of us were ever at Jonah's.

FM: Okay.

MH: Unless they went afterwards.

FM: Somebody put Jonah's in their statement there. But, do you remember there, I think it was JUSTIN had maybe bought or ordered some pie with ice cream on it and you ate some of it and gave Q some?

MH: I remember –

FM: You remember?

MH: – I remember eating some of it.

FM: Okay. You don't remember feeding any to Q?

MH: I know Q had some. I don't –

FM: Okay. Do you remember talking about sex with the guys there, about your relationship with your boyfriend, –

MH: I vaguely –

FM: – HUNTER?

MH: – vaguely do, yes.

FM: Okay. Okay, I just – do you – is this normal for you to get this intoxicated –

MH: No, it's not.

FM: – to not to remember?

MH: It's not, and that's – it was definitely more, I drank more than I usually do, because that was four cocktails and a shot in a matter of three hours.

FM: Mm hmm.

MH: Four hours that like we were out. I do, I do blackout easily. That's why I don't typically drink a whole lot.

FM: Okay. MEGAN, you know this is not the type of behavior we expect our agents –

MH: I understand that.

FM: – to do. I mean, you know, we are a professional agency and we can't have Agents out here getting that drunk or intoxicated in public that they don't remember what they've done.

MH: I understand that, sir.

FM: And this is very, you know, a big lapse in judgment on all of y'all's part. First of all, you probably shouldn't have government cars at bars, and these people should

not be driving government cars and drinking. But now, you know, you can't remember anything that happened, and this is a serious allegation because careers are on the line and this is borderline, you know, criminal.

MH: I understand that.

FM: You know, and –

MH: And that, like I told you, and why I told CARLA, this scares me, this makes me nervous because I can't sit, sit here and say without a doubt this is what happened, because I'm not sure.

FM: Mm hmm. Okay. I'm probably, after I interview everybody I might have to come back and, you know, ask, and interview you again. But, you know, whenever that, there's 12 statements here that I've got to cipher through. I'm just trying to do this as quick as possible, and, you know, get to the bottom of this. But we got to sort all this out. In the meantime, do not discuss this with anyone.

MH: Okay.

FM: Okay? I told CARLA to tell the class, and I'm sure everybody in class, you know, knows a little something about this, or knows everything about it. Nobody down there can talk about it. If somebody from class tries to call you, it's okay for them to call you, but do not talk about this investigation, okay?

MH: Okay.

FM: Is here anything you want to say SHONDRENA?

SHH: Yes, I have a question.

FM: Yes ma'am, go ahead.

SHH: When you stated about blacking out, how long have you known that you have blackouts when you're drinking? Like –

MH: I mean, it's happened like sporadically, since I started drinking, but it's only when it's like super, when I drink a lot. I typically do not drink this much. Usually when we all go out, I'm the one who drives.

SHH: What prompted you to continue to drink in this scenario versus knowing what your limitations –

MH: Yes ma'am.

SHH: – are for the perspective of blacking out and saying okay, I'm not going to drink anymore because you said you had three on your receipt. Was that at the Mexican restaurant?

MH: No, that was at the brewery, and I had one –

SHH: And that was at the brewery, but you said you also had one at the Mexican restaurant.

MH: Yes ma'am.

SHH: That would've been four.

MH: Four.

SHH: And then ADAM bought you one, so that was five drinks. Is the three including the margarita or not including the margarita?

MH: Not including the margarita.

SHH: Okay, so the margarita would make –

MH: The mar –

SHH: – 5 ½ or so, even if like tasting and getting the alcohol in your system.



MH: Yes ma'am.

SHH: Did you ever think I need to stop drinking so much or –

MH: I think it was just we were, we're just having a good time.

SHH: Okay.

MH: I felt – I mean, I've never, I've never not felt safe around these people. I've never

–

SHH: Okay, what were you upset with HUNTER about because it seems the –

MH: I don't quite remember. Um, –

SHH: -- Because that conversation started at the restaurant with the group, so you're being upset after the incident is one thing, but you were also upset –

MH: Right.

SHH: – before the incident as well.

MH: And that, that is what I didn't know until Q told me.

SHH: What did your – well, when you talked, you talked to him several, at least two times (*inaudible*).

MH: HUNTER, yes ma'am.

SHH: Yeah. Did you ask him what you all talked about?

MH: I talked to him this morning. I asked him. He said that he, he said something that I said. I know we were – asking Q like how to make our sex, but not Q and I's, HUNTER and I's, and he was just kind of giving me some pointers, blah, blah, blah. And, I believe that's what HUNTER, HUNTER got pissed about.

SHH: So, HUNTER was upset about the conversation you all had.

MH: Mm hmm.

SHH: But then you all, you and Q, subsequently called him back.

MH: Yes.

SHH: And –

MH: Because now I'm upset because HUNTER's upset.

SHH: But they had a conversation, even though HUNTER was upset.

MH: Q and HUNTER had a conversation?

SHH: A subsequent second conversation.

MH: I believe we called HUNTER in Q's car.

SHH: But you knew – I guess that goes to he was upset from the first conversation, but you all proceeded to call him again. –

MH: Well, I –

SHH: – Did you talk?

MH: – I didn't know he, I didn't know he was upset. I don't recall calling HUNTER after our first phone call.

SHH: Okay, but he did confirm there was a second, but –

MH: Yes.

SHH: – you didn't know he was upset when you all called the second time?

MH: I didn't know he was upset until yesterday morning when I talked to him on the phone when I woke up, and that's when he said I was crying and not making any sense.

SHH: Which time, the second time when you called from the vehicle? When did HUNTER say you were crying and not making any sense?

MH: When Q and I called him.
