On Wednesday, May 12, 2021 at approximately 5:15 p.m. I (Brandon Crocker) went to the Quik Med medical facility in Forsyth, GA. After being treated for back pain, I met with Quamere Rooks, Justin Jones, Eric White, Stephen Pendergrass, Jason Cole and Megan Hirsch at the El Tejado Mexican Restaurant in Forsyth, GA for dinner. All the above named were already at the restaurant and had already ordered drinks. I cannot specifically recall the drinks that everyone already had. I do remember that Hirsch had a Margarita, Rooks had a Margarita and an empty shot glass, Pendergrass and White both had a beer and Cole had a drink that appeared to be coke and something. I ordered a beer with my food and the rest of the group ordered food at the same time. During our wait for food, I recall Rooks ordering a couple more shots for he and Cole, and Hirsch and Cole ordered Diet Coke and Bourbon, I believe. Our food was delivered to the table and Rooks ordered two more shots for he and Cole. We completed our meals and I asked for the checks. I was the first to get up and pay at the register. The others followed. The group talked about going to the Fox Brewery to continue in the festivities and I decided to go back to the Academy and get in bed to rest my back. I was back at the Academy by approximately 6:45 p.m. I believe that Eric White, Jason Cole, Justin Jones, and myself were the only ones that drove to the restaurant. From the time that I returned to the Academy around 6:45 p.m., I did not leave my room until the next morning for breakfast. I am unaware of the activities that occurred after I left the restaurant.

I had a beer with my dinner and the only person I remember not drinking was Justin Jones.
