## **INTERVIEW WITH LUCAS BEYER**

Okay, today's date is Friday, May 21, 2021. The time now is 9:39am. This is DIRECTOR FRED MAYS in GBI OFFICE OF PROFESSIONAL STANDARDS. I'm speaking with SPECIAL AGENT LUCAS BEYER, and I contacted him at the GEORGIA PUBLIC SAFETY TRAINING CENTER at telephone number 478-993-4601.

FM: AGENT BEYER, how long have your worked for the GBI?

LB: I was hired in September of 2020.

FM: Okay, and were you sent to the GBI REGION 10 OFFICE prior to going to the Academy?

LB: Yes sir. Um, following my hire date I went through, uh, Basic Mandate here at GPSTC and upon completion of Mandate, uh, which was December, I believe I graduated on (inaudible), uh, December 11, I believe we graduated. Um, so I went to the REGION 10 FIELD OFFICE and worked there until, um, until Basic Agent Academy started.

FM: Okay, so you're in the BAC now. Is that correct?

LB: That's correct, yes sir.

FM: Okay. You provided a statement back on May 13, dated May 13, of an incident that happened on May 12 at the Academy involving SPECIAL AGENT QUAMERE ROOKS and SPECIAL AGENT MEGAN HIRSCH. I have a copy of that statement and I'm gonna make it part of the official investigative file. Is there anything you want to change, add or delete to that statement?

LB: Um, no sir, not to my knowledge.

FM: Okay. Alright, briefly tell me, I have your detailed statement here. Briefly tell me, you know, what happened that night.

LB: So, we got out of, um, as collectively we, um, the BAC class, we were dismissed from class. Uh, that afternoon, um, I believe that there were some pre-existing plans with several of the, uh, agents to go out to dinner that evening off campus. Um, I was invited to go with them. They said they were going to a, um, Mexican restaurant. I'm not sure which one. Um, I declined the invitation, um, and I went and had dinner at the, uh, the GPSTC cafeteria with some other classmates that also remained on campus. Um, after dinner concluded, um, I did briefly leave campus. Um, I believe I left right around 6:15 in the evening. Um, I went to a local gas station, um, picked up a few, uh, few sodas and snacks, and I also went to go, uh, break some change, um, so that I could use the laundry facilities here on campus. So, I got some dollar bills transferred into quarters. Um, I returned to campus, uh, very shortly thereafter. I made no other stops other than the gas station. Um, came back to campus, started my laundry and started on some homework that we had. Um, somewhere between 8:00 and 8:15pm my roommate, ERIC WHITE, uh, he had gone out to, to dinner with, uh, with those classmates that I previously mentioned. Um, he returned to the room, um, and one of the first things that he told me when he walked back into the room was. uh, that there had been a couple of classmates that, uh, that had had several drinks, um, while he was out with them. Um, two that he mentioned in particular were, uh, QUAMERE ROOKS and MEGAN HIRSCH. Um, he told me that. I can't remember his exact words, but I believe that the word that he used was trashed, um, just to describe the, how intoxicated that they were. Um, he went on to
